Mr. WOODALL, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the concurrent resolution (H. Con. Res. 96) establishing the budget for the United States Government for fiscal year 2015 and setting forth appropriate budgetary levels for fiscal years 2016 through 2024, and providing for proceedings during the period from April 11, 2014, through April 25, 2014.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee

1 of the Whole House on the state of the Union for consider-
2 ation of the concurrent resolution (H. Con. Res. 96) estab-
3 lishing the budget for the United States Government for
4 fiscal year 2015 and setting forth appropriate budgetary
5 levels for fiscal years 2016 through 2024. The first read-
6 ing of the concurrent resolution shall be dispensed with.
7 All points of order against consideration of the concurrent
8 resolution are waived. General debate shall not exceed four
9 hours, with three hours of general debate confined to the
10 congressional budget equally divided and controlled by the
11 chair and ranking minority member of the Committee on
12 the Budget and one hour of general debate on the subject
13 of economic goals and policies equally divided and con-
14 trolled by Representative Brady of Texas and Representa-
15 tive Carolyn Maloney of New York or their respective des-
16 ignees. After general debate the concurrent resolution
17 shall be considered for amendment under the five-minute
18 rule. The concurrent resolution shall be considered as
19 read. No amendment shall be in order except those printed
20 in the report of the Committee on Rules accompanying
21 this resolution. Each amendment may be offered only in
22 the order printed in the report, may be offered only by
23 a Member designated in the report, shall be considered
24 as read, and shall be debatable for the time specified in
25 the report equally divided and controlled by the proponent

1 and an opponent. All points of order against such amend-
2 ments are waived except that the adoption of an amend-
3 ment in the nature of a substitute shall constitute the con-
4 clusion of consideration of the concurrent resolution for
5 amendment. After the conclusion of consideration of the
6 concurrent resolution for amendment and a final period
7 of general debate, which shall not exceed 10 minutes
8 equally divided and controlled by the chair and ranking
9 minority member of the Committee on the Budget, the
10 Committee shall rise and report the concurrent resolution
11 to the House with such amendment as may have been
12 adopted. The previous question shall be considered as or-
13 dered on the concurrent resolution and amendments there-
14 to to adoption without intervening motion except amend-
15 ments offered by the chair of the Committee on the Budg-
16 et pursuant to section 305(a)(5) of the Congressional
17 Budget Act of 1974 to achieve mathematical consistency.
18 The concurrent resolution shall not be subject to a demand
19 for division of the question of its adoption.

20 SEC. 2. On any legislative day during the period from
21 April 11, 2014, through April 25, 2014—

22 (a) the Journal of the proceedings of the previous day
23 shall be considered as approved; and

24 (b) the Chair may at any time declare the House ad-
25 journed to meet at a date and time, within the limits of

1 clause 4, section 5, article I of the Constitution, to be an-
2 nounced by the Chair in declaring the adjournment.

3 SEC. 3. The Speaker may appoint Members to per-
4 form the duties of the Chair for the duration of the period
5 addressed by section 2 of this resolution as though under
6 clause 8(a) of rule I.

7 SEC. 4. Each day during the period addressed by sec-
8 tion 2 of this resolution shall not constitute a calendar
9 day for purposes of section 7 of the War Powers Resolu-
10 tion (50 U.S.C. 1546).

11 SEC. 5. The Committee on Appropriations may, at
12 any time before 5 p.m. on Thursday, April 17, 2014, file
13 privileged reports to accompany measures making appro-
14 priations for the fiscal year ending September 30, 2015.
