Mr. NUGENT, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for further consideration of the bill (H.R. 4435) to authorize appropriations for fiscal year 2015 for military activities of the Department of Defense and for military construction, to prescribe military personnel strengths for such fiscal year, and for other purposes; and providing for consideration of the bill (H.R. 3361) to reform the authorities of the Federal Government

to require the production of certain business records, conduct electronic surveillance, use pen registers and trap and trace devices, and use other forms of information gathering for foreign intelligence, counterterrorism, and criminal purposes, and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
 2 lution the Speaker may, pursuant to clause 2(b) of rule
 3 XVIII, declare the House resolved into the Committee of
 4 the Whole House on the state of the Union for further
 5 consideration of the bill (H.R. 4435) to authorize appro-
 6 priations for fiscal year 2015 for military activities of the
 7 Department of Defense and for military construction, to
 8 prescribe military personnel strengths for such fiscal year,
 9 and for other purposes.

10 SEC. 2. (a) No further amendment to the bill, as
 11 amended, shall be in order except those printed in part
 12 A of the report of the Committee on Rules accompanying
 13 this resolution and amendments en bloc described in sec-
 14 tion 3 of this resolution.

15 (b) Each further amendment printed in part A of the
 16 report of the Committee on Rules shall be considered only
 17 in the order printed in the report, may be offered only
 18 by a Member designated in the report, shall be considered
 19 as read, shall be debatable for the time specified in the
 20 report equally divided and controlled by the proponent and
 21 an opponent, shall not be subject to amendment, and shall

1 not be subject to a demand for division of the question
2 in the House or in the Committee of the Whole.

3 (c) All points of order against the further amend-
4 ments printed in part A of the report of the Committee
5 on Rules or amendments en bloc described in section 3
6 of this resolution are waived.

7 SEC. 3. It shall be in order at any time for the chair
8 of the Committee on Armed Services or his designee to
9 offer amendments en bloc consisting of amendments print-
10 ed in part A of the report of the Committee on Rules ac-
11 companying this resolution not earlier disposed of. Amend-
12 ments en bloc offered pursuant to this section shall be con-
13 sidered as read, shall be debatable for 20 minutes equally
14 divided and controlled by the chair and ranking minority
15 member of the Committee on Armed Services or their des-
16 ignees, shall not be subject to amendment, and shall not
17 be subject to a demand for division of the question in the
18 House or in the Committee of the Whole.

19 SEC. 4. At the conclusion of consideration of the bill
20 for amendment the Committee shall rise and report the
21 bill to the House with such further amendments as may
22 have been adopted. The previous question shall be consid-
23 ered as ordered on the bill and amendments thereto to
24 final passage without intervening motion except one mo-
25 tion to recommit with or without instructions.

1 SEC. 5. Upon adoption of this resolution it shall be
2 in order to consider in the House the bill (H.R. 3361)
3 to reform the authorities of the Federal Government to
4 require the production of certain business records, conduct
5 electronic surveillance, use pen registers and trap and
6 trace devices, and use other forms of information gathering for foreign intelligence, counterterrorism, and criminal purposes, and for other purposes. All points of order
7 against consideration of the bill are waived. In lieu of the
8 amendments in the nature of a substitute recommended
9 by the Committee on the Judiciary and the Permanent
10 Select Committee on Intelligence now printed in the bill,
11 the amendment in the nature of a substitute printed in
12 part B of the report of the Committee on Rules accompanying this resolution shall be considered as adopted.
13 The bill, as amended, shall be considered as read. All
14 points of order against provisions in the bill, as amended,
15 are waived. The previous question shall be considered as
16 ordered on the bill, as amended, and on any amendment
17 thereto to final passage without intervening motion except:
18 (1) one hour of debate, with 40 minutes equally divided
19 and controlled by the chair and ranking minority member
20 of the Committee on the Judiciary and 20 minutes equally
21 divided and controlled by the chair and ranking minority
22 member of the Permanent Select Committee on Intel-

1 ligence; and (2) one motion to recommit with or without
2 instructions.

3 SEC. 6. The Committee on Appropriations may, at
4 any time before 5 p.m. on Tuesday, May 27, 2014, file
5 privileged reports to accompany measures making appro-
6 priations for the fiscal year ending September 30, 2015.
