Providing for consideration of the bill (H.R. 4870) making appropriations for the Department of Defense for the fiscal year ending September 30, 2015, and for other purposes, and providing for consideration of the Senate amendments to the bill (H.R. 3230) making continuing appropriations during a Government shutdown to provide pay and allowances to members of the reserve components of the Armed Forces who perform inactive-duty training during such period.

Mr. NUGENT, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4870) making appropriations for the Department of Defense for the fiscal year ending September 30, 2015, and for other purposes, and providing for consideration of the Senate amendments to the bill (H.R. 3230) making continuing appropriations during a Government shutdown to provide pay and allowances to members of the reserve components of the Armed Forces who perform inactive-duty training during such period.

1 *Resolved*, That (a) at any time after adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 4870) making appropriations for
6 the Department of Defense for the fiscal year ending Sep-
7 tember 30, 2015, and for other purposes. The first reading
8 of the bill shall be dispensed with. All points of order
9 against consideration of the bill are waived. General de-
10 bate shall be confined to the bill and shall not exceed one
11 hour equally divided and controlled by the chair and rank-
12 ing minority member of the Committee on Appropriations.
13 After general debate the bill shall be considered for
14 amendment under the five-minute rule. Points of order
15 against provisions in the bill for failure to comply with
16 clause 2 of rule XXI are waived.

17 (b) During consideration of the bill for amendment—

18 (1) each amendment, other than amendments
19 provided for in paragraph (2), shall be debatable for
20 10 minutes equally divided and controlled by the
21 proponent and an opponent and shall not be subject
22 to amendment except as provided in paragraph (2);

23 (2) no pro forma amendment shall be in order
24 except that the chair and ranking minority member
25 of the Committee on Appropriations or their respec-

1 tive designees may offer up to 10 pro forma amend-
2 ments each at any point for the purpose of debate;
3 and

4 (3) the chair of the Committee of the Whole
5 may accord priority in recognition on the basis of
6 whether the Member offering an amendment has
7 caused it to be printed in the portion of the Con-
8 gressional Record designated for that purpose in
9 clause 8 of rule XVIII. Amendments so printed shall
10 be considered as read.

11 (c) When the committee rises and reports the bill
12 back to the House with a recommendation that the bill
13 do pass, the previous question shall be considered as or-
14 dered on the bill and amendments thereto to final passage
15 without intervening motion except one motion to recommit
16 with or without instructions.

17 SEC. 2. Upon adoption of this resolution it shall be
18 in order to take from the Speaker's table the bill (H.R.
19 3230) making continuing appropriations during a Govern-
20 ment shutdown to provide pay and allowances to members
21 of the reserve components of the Armed Forces who per-
22 form inactive-duty training during such period, with the
23 Senate amendments thereto, and to consider in the House,
24 without intervention of any point of order or question of
25 consideration, a single motion offered by the chair of the

1 Committee on Veterans' Affairs or his designee that the
2 House: (1) concur in the Senate amendment to the title;
3 and (2) concur in the Senate amendment to the text with
4 the amendment printed in the report of the Committee
5 on Rules accompanying this resolution. The Senate
6 amendments and the motion shall be considered as read.
7 The motion shall be debatable for one hour equally divided
8 and controlled by the chair and ranking minority member
9 of the Committee on Veterans' Affairs. The previous ques-
10 tion shall be considered as ordered on the motion to adop-
11 tion without intervening motion or demand for division of
12 the question. If the motion is adopted, then it shall be
13 in order for the chair of the Committee on Veterans' Af-
14 fairs or his designee to move that the House insist on its
15 amendment to the Senate amendment to H.R. 3230 and
16 request a conference with the Senate thereon.
