Mr. WOODALL, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 273) to eliminate the 2013 statutory pay adjustment for Federal employees, and for other purposes.

1 *Resolved*, That upon the adoption of this resolution
2 it shall be in order to consider in the House the bill (H.R.
3 273) to eliminate the 2013 statutory pay adjustment for
4 Federal employees. All points of order against consider-
5 ation of the bill are waived. The bill shall be considered
6 as read. All points of order against provisions in the bill
7 are waived. The previous question shall be considered as

1 ordered on the bill and on any amendment thereto to final
2 passage without intervening motion except: (1) one hour
3 of debate equally divided and controlled by the chair and
4 ranking minority member of the Committee on Oversight
5 and Government Reform; and (2) one motion to recommit.

6 SEC. 2. During any recess or adjournment of not
7 more than three days, if in the opinion of the Speaker
8 the public interest so warrants, then the Speaker or his
9 designee, after consultation with the Minority Leader, may
10 reconvene the House at a time other than that previously
11 appointed, within the limits of clause 4, section 5, article
12 I of the Constitution, and notify Members accordingly.

13 SEC. 3. It shall be in order at any time through the
14 legislative day of February 15, 2013, for the Speaker to
15 entertain motions that the House suspend the rules, as
16 though under clause 1 of rule XV, relating to a measure
17 condemning the government of North Korea and its Feb-
18 ruary 12, 2013 test of a nuclear device.

19 SEC. 4. On any legislative day during the period from
20 February 16, 2013, through February 22, 2013—

21 (a) the Journal of the proceedings of the previous day
22 shall be considered as approved; and

23 (b) the Chair may at any time declare the House ad-
24 journed to meet at a date and time, within the limits of

1 clause 4, section 5, article I of the Constitution, to be an-
2 nounced by the Chair in declaring the adjournment.

3 SEC. 5. The Speaker may appoint Members to per-
4 form the duties of the Chair for the duration of the period
5 addressed by section 4 of this resolution as though under
6 clause 8(a) of rule I.
