Ms. KLOBUCHAR (for herself and Mrs. FISCHER) introduced the following bill; which was read twice and referred to the Committee on Commerce, Science, and Transportation

A BILL

To encourage spectrum licensees to make unused spectrum available for use by rural and smaller carriers in order to expand wireless coverage.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Rural Spectrum Acces-
5 sibility Act of 2013”.

6 **SEC. 2. EXTENSION OF LICENSES.**

7 Section 307 of the Communications Act of 1934 (47
8 U.S.C. 307) is amended by adding at the end the fol-
9 lowing:

1 “(g) EXTENSION OF LICENSES.—

2 “(1) DEFINITIONS.—

3 “(A) IN GENERAL.—For purposes of this
4 subsection—

5 “(i) the term ‘rural area’ means any
6 area other than—

7 “(I) an area described in clause
8 (i) or (ii) of section 343(a)(13)(A) of
9 the Consolidated Farm and Rural De-
10 velopment Act (7 U.S.C.
11 1991(a)(13)(A)); and

12 “(II) a city, town, or incor-
13 porated area that has a population of
14 greater than 20,000 inhabitants; and

15 “(ii) the term ‘small carrier’ means a
16 carrier with not more than 1,500 employ-
17 ees.

18 “(B) CALCULATION OF NUMBER OF EM-
19 PLOYEES.—For purposes of subparagraph
20 (A)(ii), the number of employees of a carrier
21 shall be determined in accordance with section
22 121.106 of title 13, Code of Federal Regula-
23 tions, or any successor thereto.

24 “(2) ESTABLISHMENT OF PROGRAM.—Not later
25 than 90 days after the date of enactment of Rural

1 Spectrum Accessibility Act of 2013, the Commission
2 shall establish a program under which a carrier that
3 receives a license under this section may partition or
4 disaggregate the license in order to make unused
5 spectrum available to small carriers or carriers serv-
6 ing a rural area.

7 “(3) EXTENSION OF LICENSE TERM.—Any car-
8 rier that receives a license under this section and
9 participates in the program established under para-
10 graph (2) shall receive a 3-year extension of the li-
11 cense granted under this section.”.
