## AN ACT

To amend the provisions of title 46, United States Code, related to the Board of Visitors to the United States Merchant Marine Academy, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “U.S. Merchant Marine  
3 Academy Board of Visitors Enhancement Act”.

4 **SEC. 2. UNITED STATES MERCHANT MARINE ACADEMY**  
5 **BOARD OF VISITORS.**

6 Section 51312 of title 46, United States Code, is  
7 amended to read as follows:

8 **“§ 51312. Board of Visitors**

9 “(a) IN GENERAL.—A Board of Visitors to the  
10 United States Merchant Marine Academy (referred to in  
11 this section as the ‘Board’ and the ‘Academy’, respec-  
12 tively) shall be established to provide independent advice  
13 and recommendations on matters relating to the United  
14 States Merchant Marine Academy.

15 “(b) APPOINTMENT AND MEMBERSHIP.—

16 “(1) IN GENERAL.—Not later than 60 days  
17 after the date of the enactment of the U.S. Mer-  
18 chant Marine Academy Board of Visitors Enhance-  
19 ment Act, the Board shall be composed of—

20 “(A) 2 Senators appointed by the chair-  
21 man, in consultation with the ranking member,  
22 of the Committee on Commerce, Science, and  
23 Transportation of the Senate;

24 “(B) 3 members of the House of Rep-  
25 resentatives appointed by the chairman, in con-  
26 sultation with the ranking member, of the Com-

1           mittee on Armed Services of the House of Rep-  
2           resentatives;

3           “(C) 1 Senator appointed by the Vice  
4           President, who shall be a member of the Com-  
5           mittee on Appropriations of the Senate;

6           “(D) 2 members of the House of Rep-  
7           resentatives appointed by the Speaker of the  
8           House of Representatives, in consultation with  
9           the Minority Leader, at least 1 of whom shall  
10          be a member of the Committee on Appropria-  
11          tions of the House of Representatives;

12          “(E) the Commander of the Military Sea-  
13          lift Command;

14          “(F) the Assistant Commandant for Pre-  
15          vention Policy of the United States Coast  
16          Guard;

17          “(G) 4 individuals appointed by the Presi-  
18          dent; and

19          “(H) as ex officio members—

20                 “(i) the chairman of the Committee  
21                 on Commerce, Science, and Transportation  
22                 of the Senate;

23                 “(ii) the chairman of the Committee  
24                 on Armed Services of the House of Rep-  
25                 resentatives;

1                   “(iii) the chairman of the Advisory  
2                   Board to the Academy established under  
3                   section 51313; and

4                   “(iv) the member of the House of  
5                   Representatives in whose congressional dis-  
6                   trict the Academy is located, as a non-vot-  
7                   ing member, unless such member of the  
8                   House of Representatives is appointed as a  
9                   voting member of the Board under sub-  
10                  paragraph (B) or (D).

11               “(2) PRESIDENTIAL APPOINTEES.—Of the indi-  
12               viduals appointed by the President under paragraph  
13               (1)(H)—

14               “(A) at least 2 shall be graduates of the  
15               Academy;

16               “(B) at least 1 shall be a senior corporate  
17               officer from a United States maritime shipping  
18               company that participates in the Maritime Se-  
19               curity Program, or in any Maritime Adminis-  
20               tration program providing incentives for compa-  
21               nies to register their vessels in the United  
22               States, and this appointment shall rotate bien-  
23               nially among such companies; and

24               “(C) 1 or more may be a Senate-confirmed  
25               Presidential appointee, a member of the Senior

1 Executive Service, or an officer of flag-rank  
2 who from the United States Coast Guard, the  
3 National Oceanic and Atmospheric Administra-  
4 tion, or any of the military services that com-  
5 mission graduates of the Academy, exclusive of  
6 the Board members described in subparagraph  
7 (E), (F), or (G) of paragraph (1).

8 “(3) TERM OF SERVICE.—Each member of the  
9 Board shall serve for a term of 2 years commencing  
10 at the beginning of each Congress, except that any  
11 member whose term on the Board has expired shall  
12 continue to serve until a successor is designated.

13 “(4) VACANCIES.—If a member of the Board is  
14 no longer able to serve on the Board or resigns, the  
15 Designated Federal Officer selected under subsection  
16 (g)(2) shall immediately notify the official who ap-  
17 pointed such member. Not later than 60 days after  
18 that notification, such official shall designate a re-  
19 placement to serve the remainder of such member’s  
20 term.

21 “(5) CURRENT MEMBERS.—Each member of  
22 the Board serving as a member of the Board on the  
23 date of the enactment of the U.S. Merchant Marine  
24 Academy Board of Visitors Enhancement Act shall

1 continue to serve on the Board for the remainder of  
 2 such member's term.

3 “(6) DESIGNATION AND RESPONSIBILITY OF  
 4 SUBSTITUTE BOARD MEMBERS.—

5 “(A) AUTHORITY TO DESIGNATE.—A  
 6 member of the Board described in subpara-  
 7 graph (E), (F), or (G) of paragraph (1) or sub-  
 8 paragraph (B) or (C) of paragraph (2) may, if  
 9 unable to attend or participate in an activity  
 10 described in subsection (d), (e), or (f), des-  
 11 ignate another individual to serve as a sub-  
 12 stitute member of the Board, on a temporary  
 13 basis, to attend or participate in such activity.

14 “(B) REQUIREMENTS.—A substitute mem-  
 15 ber of the Board designated under subpara-  
 16 graph (A) shall be—

17 “(i) an individual who has been ap-  
 18 pointed by the President and confirmed by  
 19 the Senate;

20 “(ii) a member of the Senior Execu-  
 21 tive Service; or

22 “(iii) an officer of flag-rank who is  
 23 employed by—

24 “(I) the United States Coast  
 25 Guard; or

1 “(II) the Military Sealift Com-  
2 mand.

3 “(C) PARTICIPATION.—A substitute mem-  
4 ber of the Board designated under subpara-  
5 graph (A)—

6 “(i) shall be permitted to fully partici-  
7 pate in the proceedings and activities of  
8 the Board;

9 “(ii) shall report back to the member  
10 on the Board’s activities not later than 15  
11 days following the substitute member’s  
12 participation in such activities; and

13 “(iii) shall be permitted to participate  
14 in the preparation of reports described in  
15 paragraph (j) related to any proceedings or  
16 activities of the Board in which such sub-  
17 stitute member participates.

18 “(c) CHAIRPERSON.—

19 “(1) IN GENERAL.—On a biennial basis, the  
20 Board shall select from among its members, a mem-  
21 ber of the House of Representatives or a Senator to  
22 serve as the Chairperson.

23 “(2) ROTATION.—A member of the House of  
24 Representatives and a member of the Senate shall

1 alternately serve as the Chair of the Board on a bi-  
2 ennial basis.

3 “(3) TERM.—An individual may not serve as  
4 Chairperson for more than 1 consecutive term.

5 “(d) MEETINGS.—

6 “(1) IN GENERAL.—The Board shall meet sev-  
7 eral times each year as provided for in the Charter  
8 described in paragraph (2)(B), including at least 1  
9 meeting held at the Academy.

10 “(2) SELECTION AND CONSIDERATION.—Not  
11 later than 60 days after the date of the enactment  
12 of the U.S. Merchant Marine Academy Board of  
13 Visitors Enhancement Act, the Designated Federal  
14 Officer selected under subsection (g)(2) shall orga-  
15 nize a meeting of the Board for the purposes of—

16 “(A) selecting a Chairperson; and

17 “(B) considering an official Charter for the  
18 Board, which shall provide for the meeting of  
19 the Board several times each year.

20 “(e) VISITING THE ACADEMY.—

21 “(1) ANNUAL VISIT.—The Board shall visit the  
22 Academy annually on a date selected by the Board,  
23 in consultation with the Secretary of Transportation  
24 and the Superintendent of the Academy.



1           “(2) OTHER VISITS.—In cooperation with the  
2       Superintendent, the Board or its members may  
3       make other visits to the Academy in connection with  
4       the duties of the Board.

5           “(3) ACCESS.—While visiting the Academy  
6       under this subsection, members of the Board shall  
7       have reasonable access to the grounds, facilities,  
8       midshipmen, faculty, staff, and other personnel of  
9       the Academy for the purpose of carrying out the du-  
10      ties of the Board.

11          “(f) RESPONSIBILITY.—The Board shall inquire into  
12      the state of morale and discipline, the curriculum, instruc-  
13      tion, physical equipment, fiscal affairs, academic methods,  
14      and other matters relating to the Academy that the Board  
15      decides to consider.

16          “(g) DEPARTMENT OF TRANSPORTATION SUP-  
17      PORT.—The Secretary of Transportation shall—

18           “(1) provide support as deemed necessary by  
19      the Board for the performance of the Board’s func-  
20      tions;

21           “(2) not later than 30 days after the date of  
22      the enactment of the U.S. Merchant Marine Acad-  
23      emy Board of Visitors Enhancement Act, select a  
24      Designated Federal Officer to support the perform-  
25      ance of the Board’s functions; and

1           “(3) in cooperation with the Maritime Adminis-  
2           trator and the Superintendent of the Academy, ad-  
3           vise the Board of any institutional issues, consistent  
4           with applicable laws concerning the disclosure of in-  
5           formation.

6           “(h) STAFF.—Staff members may be designated to  
7           serve without reimbursement as staff for the Board by—

8                 “(1) the Chairperson of the Board;

9                 “(2) the chairman of the Committee on Com-  
10           merce, Science, and Transportation of the Senate;  
11           and

12                 “(3) the chairman of the Committee on Armed  
13           Services of the House of Representatives.

14           “(i) TRAVEL EXPENSES.—While serving away from  
15           home or regular place of business, a member of the Board  
16           or a staff member designated under subsection (h) shall  
17           be allowed travel expenses, including per diem in lieu of  
18           subsistence, as authorized under section 5703 of title 5,  
19           United States Code.

20           “(j) REPORTS.—

21                 “(1) ANNUAL REPORT.—Not later than 60 days  
22           after each annual visit required under subsection  
23           (e)(1), the Board shall submit to the President a  
24           written report of its actions, views, and rec-  
25           ommendations pertaining to the Academy.

1           “(2) OTHER REPORTS.—If the members of the  
2       Board visit the Academy under subsection (e)(2),  
3       the Board may—

4           “(A) prepare a report on such visit; and

5           “(B) if approved by a majority of the  
6       members of the Board, submit such report to  
7       the President not later than 60 days after the  
8       date of the approval.

9           “(3) ADVISORS.—The Board may call in advis-  
10      ers—

11           “(A) for consultation regarding the execu-  
12      tion of the Board’s responsibility under sub-  
13      section (f); or

14           “(B) to assist in the preparation of a re-  
15      port described in paragraph (1) or (2).

16           “(4) SUBMISSION.—A report submitted to the  
17      President under paragraph (1) or (2) shall be con-  
18      currently submitted to—

19           “(A) the Secretary of Transportation;

20           “(B) the Committee on Commerce,  
21      Science, and Transportation of the Senate; and

1                   “(C) the Committee on Armed Services of  
2                   the House of Representatives.”.
