## A BILL

To reauthorize the United States Anti-Doping Agency, and  
for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “United States Anti-  
5 Doping Agency Reauthorization Act”.

6 **SEC. 2. PROHIBIT PERFORMANCE-ENHANCING METHODS.**

7 Section 701 of title VII of the Office of National  
8 Drug Control Policy Reauthorization Act of 2006 (21  
9 U.S.C. 2001) is amended—

1 (1) in subsection (a), by striking paragraph (4);

2 and

3 (2) in subsection (b)—

4 (A) in paragraph (1), by inserting “and be  
5 recognized worldwide as the independent na-  
6 tional anti-doping organization for the United  
7 States” after “Committee”;

8 (B) in paragraph (2), by striking “, or per-  
9 formance-enhancing genetic modifications ac-  
10 complished through gene-doping” and inserting  
11 “or prohibited performance-enhancing methods  
12 adopted by the Agency”;

13 (C) in paragraph (3), by striking “, or per-  
14 formance-enhancing genetic modifications ac-  
15 complished through gene-doping” and inserting  
16 “or prohibited performance-enhancing methods  
17 adopted by the Agency”;

18 (D) in paragraph (4), by striking “and the  
19 prevention of use of performance-enhancing  
20 drugs, or performance-enhancing genetic modi-  
21 fications accomplished through gene-doping by  
22 United States amateur athletes; and” and in-  
23 serting “, and the prevention of use by United  
24 States amateur athletes of performance-enhanc-

1           ing drugs or prohibited performance-enhancing  
 2           methods adopted by the Agency.”; and  
 3           (E) by striking paragraph (5).

4 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

5       Section 703 of title VII of the Office of National  
 6 Drug Control Policy Reauthorization Act of 2006 (21  
 7 U.S.C. 2003) is amended to read as follows:

8 **“SEC. 703. AUTHORIZATION OF APPROPRIATIONS.**

9       “There are authorized to be appropriated to the  
 10 United States Anti-Doping Agency—

- 11           “(1) for fiscal year 2014, \$11,300,000;  
 12           “(2) for fiscal year 2015, \$11,700,000;  
 13           “(3) for fiscal year 2016, \$12,300,000;  
 14           “(4) for fiscal year 2017, \$12,900,000;  
 15           “(5) for fiscal year 2018, \$13,500,000;  
 16           “(6) for fiscal year 2019, \$14,100,000; and  
 17           “(7) for fiscal year 2020, \$14,800,000.”.
