A BILL

To expand the program of priority review to encourage treatments for tropical diseases.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Adding Ebola to the
3 FDA Priority Review Voucher Program Act”.

4 **SEC. 2. PRIORITY REVIEW TO ENCOURAGE TREATMENTS**
5 **FOR TROPICAL DISEASES.**

6 Section 524 of the Federal Food, Drug, and Cosmetic
7 Act (21 U.S.C. 360n) is amended—

8 (1) in subsection (a)(3)—

9 (A) by redesignating subparagraph (Q) as
10 subparagraph (R);

11 (B) by inserting after subparagraph (P)
12 the following:

13 “(Q) Filoviruses.”; and

14 (C) in subparagraph (R), as so redesignig-
15 nated, by striking “regulation by” and inserting
16 “order of”; and

17 (2) in subsection (b)—

18 (A) in paragraph (2), by adding “There is
19 no limit on the number of times a priority re-
20 view voucher may be transferred before such
21 voucher is used.” after the period at the end;
22 and

23 (B) in paragraph (4), by striking “365
24 days” and inserting “90 days”.
