AN ACT

To make a technical amendment to the T'uf Shur Bien
Preservation Trust Area Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Sandia Pueblo Settle-
3 ment Technical Amendment Act”.

4 **SEC. 2. SANDIA PUEBLO SETTLEMENT TECHNICAL AMEND-
5 MENT.**

6 Section 413(b) of the T’uf Shur Bien Preservation
7 Trust Area Act (16 U.S.C. 539m–11(b)) is amended—

8 (1) in the first sentence of paragraph (4), by
9 striking “conveyance” and inserting “title to be con-
10 veyed”; and

11 (2) by adding at the end the following:

12 “(6) FAILURE TO EXCHANGE.—

13 “(A) IN GENERAL.—If the land exchange
14 authorized under paragraph (1) is not com-
15 pleted by the date that is 30 days after the date
16 of enactment of this paragraph, the Secretary,
17 on request of the Pueblo and the Secretary of
18 the Interior, shall transfer the National Forest
19 land generally depicted as ‘Land to be Held in
20 Trust’ on the map entitled ‘Sandia Pueblo Set-
21 tlement Technical Amendment Act’ and dated
22 October 18, 2013, to the Secretary of the Inte-
23 rior to be held in trust by the United States for
24 the Pueblo—

25 “(i) subject to the restriction enforced
26 by the Secretary of the Interior that the

1 land remain undeveloped, with the natural
2 characteristics of the land to be preserved
3 in perpetuity; and

4 “(ii) consistent with subsection (c).

5 “(B) OTHER TRANSFERS.—After the
6 transfer under subparagraph (A) is complete,
7 the Secretary of the Interior, with the consent
8 of the Pueblo, shall—

9 “(i) transfer to the Secretary, con-
10 sistent with section 411(c)—

11 “(I) the La Luz tract generally
12 depicted on the map entitled ‘Sandia
13 Pueblo Settlement Technical Amend-
14 ment Act’ and dated October 18,
15 2013; and

16 “(II) the conservation easement
17 for the Piedra Lisa tract generally de-
18 picted on the map entitled ‘Sandia
19 Pueblo Settlement Technical Amend-
20 ment Act’ and dated October 18,
21 2013; and

22 “(ii) grant to the Secretary a right-of-
23 way for the Piedra Lisa Trail within the
24 Piedra Lisa tract generally depicted on the
25 map entitled ‘Sandia Pueblo Settlement

1 Technical Amendment Act' and dated Oc-
2 tober 18, 2013.”.
