A BILL

To authorize a Wall of Remembrance as part of the Korean War Veterans Memorial and to allow certain private contributions to fund that Wall of Remembrance.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Korean War Veterans*
5 *Memorial Wall of Remembrance Act of 2016”.*

6 **SEC. 2. WALL OF REMEMBRANCE.**

7 *Section 1 of the Act titled “An Act to authorize the*
8 *erection of a memorial on Federal Land in the District of*
9 *Columbia and its environs to honor members of the Armed*
10 *Forces of the United States who served in the Korean War”,*
11 *approved October 25, 1986 (Public Law 99–572), is amend-*
12 *ed by adding at the end the following:*

13 *“Such memorial shall include a Wall of Remembrance,*
14 *which shall be constructed without the use of Federal funds.*
15 *The American Battle Monuments Commission shall request*
16 *and consider design recommendations from the Korean War*
17 *Veterans Memorial Foundation, Inc. for the establishment*
18 *of the Wall of Remembrance. The Wall of Remembrance*
19 *shall include—*

20 *“(1) a list by name of members of the Armed*
21 *Forces of the United States who died in theatre in the*
22 *Korean War;*

23 *“(2) the number of members of the Armed Forces*
24 *of the United States who, in regards to the Korean*
25 *War—*

1 “(A) were wounded in action;

2 “(B) are listed as missing in action; or

3 “(C) were prisoners of war; and

4 “(3) the number of members of the Korean Aug-
5 mentation to the United States Army, the Republic of
6 Korea Armed Forces, and the other nations of the
7 United Nations Command who, in regards to the Ko-
8 rean War—

9 “(A) were killed in action;

10 “(B) were wounded in action;

11 “(C) are listed as missing in action; or

12 “(D) were prisoners of war.”.
