A BILL

To direct the Secretary of the Interior to enter into an agreement to provide for management of the free-roaming wild horses in and around the Currituck National Wildlife Refuge.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Corolla Wild Horses
5 Protection Act”.

6 **SEC. 2. WILD HORSES IN AND AROUND THE CURRITUCK**

7 **NATIONAL WILDLIFE REFUGE.**

8 (a) AGREEMENT REQUIRED.—

9 (1) IN GENERAL.—The Secretary of the Inter-
10 rior shall enter into an agreement with the Corolla
11 Wild Horse Fund (a nonprofit corporation estab-
12 lished under the laws of the State of North Caro-
13 lina), the County of Currituck, North Carolina, and
14 the State of North Carolina within 180 days after
15 the date of enactment of this Act to provide for
16 management of free-roaming wild horses in and
17 around the Currituck National Wildlife Refuge.

18 (2) TERMS.—The agreement shall—

19 (A) allow a herd of not less than 110 and
20 not more than 130 free-roaming wild horses in
21 and around such refuge, with a target popu-
22 lation of between 120 and 130 free-roaming
23 wild horses;

24 (B) provide for cost-effective management
25 of the horses while ensuring that natural re-

1 sources within the refuge are not adversely im-
2 pacted;

3 (C) provide for introduction of a small
4 number of free-roaming wild horses from the
5 herd at Cape Lookout National Seashore as is
6 necessary to maintain the genetic viability of
7 the herd in and around the Currituck National
8 Wildlife Refuge; and

9 (D) specify that the Corolla Wild Horse
10 Fund shall pay the costs associated with—

11 (i) coordinating a periodic census and
12 inspecting the health of the horses;

13 (ii) maintaining records of the horses
14 living in the wild and in confinement;

15 (iii) coordinating the removal and
16 placement of horses and monitoring of any
17 horses removed from the Currituck County
18 Outer Banks; and

19 (iv) administering a viable population
20 control plan for the horses including auc-
21 tions, adoptions, contraceptive fertility
22 methods, and other viable options.

23 (b) REQUIREMENTS FOR INTRODUCTION OF HORSES
24 FROM CAPE LOOKOUT NATIONAL SEASHORE.—During
25 the effective period of the memorandum of understanding

1 between the National Park Service and the Foundation
2 for Shackleford Horses, Inc. (a non-profit corporation or-
3 ganized under the laws of and doing business in the State
4 of North Carolina) signed in 2007, no horse may be re-
5 moved from Cape Lookout National Seashore for intro-
6 duction at Currituck National Wildlife Refuge except—

7 (1) with the approval of the Foundation; and
8 (2) consistent with the terms of such memo-
9 randum (or any successor agreement) and the Man-
10 agement Plan for the Shackleford Banks Horse
11 Herd signed in January 2006 (or any successor
12 management plan).

13 (c) NO LIABILITY CREATED.—Nothing in this sec-
14 tion shall be construed as creating liability for the United
15 States for any damages caused by the free-roaming wild
16 horses to any person or property located inside or outside
17 the boundaries of the refuge.
