To amend the Agricultural Marketing Act of 1946 to repeal
country of origin labeling requirements with respect to

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Country of Origin La-*
 5 *beling Amendments Act of 2015”.*

6 **SEC. 2. REPEAL OF COUNTRY OF ORIGIN LABELING RE-**
 7 **QUIREMENTS FOR BEEF, PORK, AND CHICK-**
 8 **EN.**

9 (a) *DEFINITIONS.*—Section 281 of the Agricultural
 10 Marketing Act of 1946 (7 U.S.C. 1638) is amended—

11 (1) *by striking paragraphs (1) and (7);*

12 (2) *by redesignating paragraphs (2), (3), (4),*
 13 *(5), (6), (8), and (9) as paragraphs (1), (2), (3), (4),*
 14 *(5), (6), and (7), respectively; and*

15 (3) *in paragraph (1)(A) (as so redesignated)—*

16 (A) *by striking clause (i) and inserting the*
 17 *following new clause:*

18 “(i) *muscle cuts of lamb and venison;*”;

19 (B) *by striking clause (ii) and inserting the*
 20 *following new clause:*

21 “(ii) *ground lamb and ground veni-*
 22 *son;*”;

23 (C) *by striking clause (viii); and*

24 (D) *by redesignating clauses (ix), (x), and*
 25 *(xi) as clauses (viii), (ix), and (x), respectively.*

1 (b) *NOTICE OF COUNTRY OF ORIGIN.*—Section 282 of
 2 *the Agricultural Marketing Act of 1946 (7 U.S.C. 1638a)*
 3 *is amended—*

4 (1) *in subsection (a)(2)—*

5 (A) *in the heading, by striking “BEEF,*
 6 *LAMB, PORK, CHICKEN,” and inserting “LAMB,”;*

7 (B) *by striking “beef, lamb, pork, chicken,”*
 8 *and inserting “lamb,” each place it appears in*
 9 *subparagraphs (A), (B), (C), and (D); and*

10 (C) *in subparagraph (E)—*

11 (i) *in the heading, by striking*
 12 *“GROUND BEEF, PORK, LAMB, CHICKEN,”*
 13 *and inserting “GROUND LAMB,”; and*

14 (ii) *by striking “ground beef, ground*
 15 *pork, ground lamb, ground chicken,” each*
 16 *place it appears and inserting “ground*
 17 *lamb,”; and*

18 (2) *in subsection (f)(2)—*

19 (A) *by striking subparagraphs (B) and (C);*
 20 *and*

21 (B) *by redesignating subparagraphs (D)*
 22 *and (E) as subparagraphs (B) and (C), respec-*
 23 *tively.*
