A BILL

To adopt the bison as the national mammal of the United
States.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “National Bison Legacy*
5 *Act”.*

6 **SEC. 2. FINDINGS.**

7 *Congress finds that—*

8 *(1) bison are considered a historical symbol of*
9 *the United States;*

10 *(2) bison were integrally linked with the eco-*
11 *nomie and spiritual lives of many Indian tribes*
12 *through trade and sacred ceremonies;*

13 *(3) there are more than 60 Indian tribes partici-*
14 *pating in the Intertribal Buffalo Council;*

15 *(4) numerous members of Indian tribes are in-*
16 *volved in bison restoration on tribal land;*

17 *(5) members of Indian tribes have a combined*
18 *herd on more than 1,000,000 acres of tribal land;*

19 *(6) the Intertribal Buffalo Council is a tribal or-*
20 *ganization incorporated pursuant to section 17 of the*
21 *Act of June 18, 1934 (commonly known as the “In-*
22 *Indian Reorganization Act”)* (25 U.S.C. 477);

23 *(7) bison can play an important role in improv-*
24 *ing the types of grasses found in landscapes to the*
25 *benefit of grasslands;*

1 (8) *a small group of ranchers helped save bison*
2 *from extinction in the late 1800s by gathering the*
3 *remnants of the decimated herds;*

4 (9) *bison hold significant economic value for pri-*
5 *vate producers and rural communities;*

6 (10) *according to the 2012 Census of Agriculture*
7 *of the Department of Agriculture, as of 2012, 162,110*
8 *head of bison were under the stewardship of private*
9 *producers, creating jobs and providing a sustainable*
10 *and healthy meat source contributing to the food secu-*
11 *rity of the United States;*

12 (11) *on December 8, 1905, William Hornaday,*
13 *Theodore Roosevelt, and others formed the American*
14 *Bison Society in response to the near extinction of*
15 *bison in the United States;*

16 (12) *on October 11, 1907, the American Bison*
17 *Society sent 15 captive-bred bison from the New York*
18 *Zoological Park, now known as the “Bronx Zoo”, to*
19 *the first wildlife refuge in the United States, which*
20 *was known as the “Wichita Mountains Wildlife Ref-*
21 *uge”, resulting in the first successful reintroduction of*
22 *a mammal species on the brink of extinction back*
23 *into the natural habitat of the species;*

24 (13) *in 2005, the American Bison Society was*
25 *reestablished, bringing together bison ranchers, man-*

1 *agers from Indian tribes, Federal and State agencies,*
2 *conservation organizations, and natural and social*
3 *scientists from the United States, Canada, and Mex-*
4 *ico to create a vision for the North American bison*
5 *in the 21st century;*

6 *(14) there are bison herds in National Wildlife*
7 *Refuges and National Parks;*

8 *(15) there are bison in State-managed herds*
9 *across 11 States;*

10 *(16) there is a growing effort to celebrate and of-*
11 *ficially recognize the historical, cultural, and eco-*
12 *nomie significance of the North American bison to the*
13 *heritage of the United States;*

14 *(17) a bison is portrayed on 2 State flags;*

15 *(18) the bison has been adopted by 3 States as*
16 *the official mammal or animal of those States;*

17 *(19) a bison has been depicted on the official seal*
18 *of the Department of the Interior since 1912;*

19 *(20) the buffalo nickel played an important role*
20 *in modernizing the currency of the United States;*

21 *(21) several sports teams have the bison as a*
22 *mascot, which highlights the iconic significance of*
23 *bison in the United States;*

24 *(22) in the 2nd session of the 113th Congress, 22*
25 *Senators led a successful effort to enact a resolution*

1 to designate November 1, 2014, as the third annual
2 National Bison Day; and

3 (23) members of Indian tribes, bison producers,
4 conservationists, sportsmen, educators, and other pub-
5 lic and private partners have participated in the an-
6 nual National Bison Day celebration at several events
7 across the United States and are committed to con-
8 tinuing this tradition annually on the first Saturday
9 of November.

10 **SEC. 3. ESTABLISHMENT AND ADOPTION OF THE NORTH**
11 **AMERICAN BISON AS THE NATIONAL MAM-**
12 **MAL.**

13 (a) *IN GENERAL.*—The mammal commonly known as
14 the “North American bison” is adopted as the national
15 mammal of the United States.

16 (b) *RULE OF CONSTRUCTION.*—Nothing in this Act or
17 the adoption of the North American bison as the national
18 mammal of the United States shall be construed or used
19 as a reason to alter, change, modify, or otherwise affect any
20 plan, policy, management decision, regulation, or other ac-
21 tion by the Federal Government.
