# **A BILL**

To expand the boundary of Fort Frederica National Monument in the State of Georgia, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Fort Frederica National*  
5 *Monument Boundary Expansion Act”.*

6 **SEC. 2. FORT FREDERICA NATIONAL MONUMENT, GEORGIA.**

7        (a) *MAXIMUM ACREAGE.*—*The first section of the Act*  
8 *of May 26, 1936 (16 U.S.C. 433g), is amended by striking*  
9 *“two hundred and fifty acres” and inserting “305 acres”.*

10        (b) *BOUNDARY EXPANSION.*—

11            (1) *IN GENERAL.*—*The boundary of the Fort*  
12 *Frederica National Monument in the State of Georgia*  
13 *is modified to include the land generally depicted as*  
14 *“Proposed Acquisition Areas” on the map entitled*  
15 *“Fort Frederica National Monument Proposed*  
16 *Boundary Expansion”, numbered 369/132,469, and*  
17 *dated April 2016.*

18            (2) *AVAILABILITY OF MAP.*—*The map described*  
19 *in paragraph (1) shall be on file and available for*  
20 *public inspection in the appropriate offices of the Na-*  
21 *tional Park Service.*

22            (3) *ACQUISITION OF LAND.*—*The Secretary of the*  
23 *Interior may acquire the land and interests in land*  
24 *described in paragraph (1) by donation or purchase*

1       *with donated or appropriated funds from willing sell-*  
2       *ers only.*

3               (4) *WRITTEN CONSENT OF OWNER.—No non-Fed-*  
4       *eral property may be included in the Fort Frederica*  
5       *National Monument without the written consent of*  
6       *the owner.*

7               (5) *NO USE OF CONDEMNATION OR EMINENT DO-*  
8       *MAIN.—The Secretary of the Interior may not acquire*  
9       *by condemnation or eminent domain any land or in-*  
10       *terests in land under this Act or for the purposes of*  
11       *this Act.*

12              (6) *NO BUFFER ZONE CREATED.—Nothing in*  
13       *this Act, the establishment of the Fort Frederica Na-*  
14       *tional Monument, or the management plan for the*  
15       *Fort Frederica National Monument shall be construed*  
16       *to create buffer zones outside of the Monument. That*  
17       *activities or uses can be seen, heard, or detected from*  
18       *areas within the Fort Frederica National Monument*  
19       *shall not preclude, limit, control, regulate, or deter-*  
20       *mine the conduct or management of activities or uses*  
21       *outside of the Monument.*
