# **A BILL**

To amend the Homeland Security Act of 2002 to establish the Securing the Cities program to enhance the ability of the United States to detect and prevent terrorist attacks and other high consequence events utilizing nuclear or other radiological materials that pose a high risk to homeland security in high-risk urban areas, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Securing the Cities Act*  
5 *of 2015”.*

6 **SEC. 2. SECURING THE CITIES PROGRAM.**

7        *(a) IN GENERAL.—Title XIX of the Homeland Secu-*  
8 *rity Act of 2002 (6 U.S.C. 591 et seq.) is amended by add-*  
9 *ing at the end the following new section:*

10 **“SEC. 1908. SECURING THE CITIES PROGRAM.**

11        *“(a) ESTABLISHMENT.—The Director for Domestic*  
12 *Nuclear Detection shall establish the ‘Securing the Cities’*  
13 *(‘STC’) program to enhance the ability of the United States*  
14 *to detect and prevent terrorist attacks and other high con-*  
15 *sequence events utilizing nuclear or other radiological mate-*  
16 *rials that pose a high risk to homeland security in high-*  
17 *risk urban areas. Through such program the Director*  
18 *shall—*

19            *“(1) assist State, local, tribal, and territorial*  
20 *governments in designing and implementing, or en-*  
21 *hancing existing, architectures for coordinated and*  
22 *integrated detection and interdiction of nuclear or*  
23 *other radiological materials that are out of regulatory*  
24 *control;*

1           “(2) support the development of a region-wide  
2           operating capability to detect and report on nuclear  
3           and other radioactive materials out of operational  
4           control;

5           “(3) provide resources to enhance detection, anal-  
6           ysis, communication, and coordination to better inte-  
7           grate State, local, tribal, and territorial assets into  
8           Federal operations;

9           “(4) facilitate alarm adjudication and provide  
10          subject matter expertise and technical assistance on  
11          concepts of operations, training, exercises, and alarm  
12          response protocols;

13          “(5) communicate with, and promote sharing of  
14          information about the presence or detection of nuclear  
15          or other radiological materials among appropriate  
16          Federal, State, local, tribal, and territorial govern-  
17          ments, in a manner that ensures transparency with  
18          the jurisdictions served by such program; and

19          “(6) provide any other assistance the Director  
20          determines appropriate.

21          “(b) DESIGNATION OF JURISDICTIONS.—In carrying  
22          out the program under subsection (a), the Director shall des-  
23          ignate jurisdictions from among high-risk urban areas  
24          under section 2003, and other cities and regions, as appro-  
25          priate.

1           “(c) *CONGRESSIONAL NOTIFICATION.*—*The Director*  
2 *shall notify the Committee on Homeland Security and the*  
3 *Committee on Appropriations of the House of Representa-*  
4 *tives and the Committee on Homeland Security and Gov-*  
5 *ernmental Affairs and the Committee on Appropriations of*  
6 *the Senate not later than three days before the designation*  
7 *of new jurisdictions under subsection (b) or other changes*  
8 *to participating jurisdictions.*

9           “(d) *GAO REPORT.*—*Not later than one year after the*  
10 *date of the enactment of this section, the Comptroller Gen-*  
11 *eral of the United States shall submit to the congressional*  
12 *committees specified in subsection (c) an assessment, in-*  
13 *cluding an evaluation of the effectiveness, of the STC pro-*  
14 *gram under this section.*

15           “(e) *PROHIBITION ON ADDITIONAL FUNDING.*—*No*  
16 *funds are authorized to be appropriated to carry out this*  
17 *section. This section shall be carried out using amounts oth-*  
18 *erwise appropriated or made available for such purpose.”.*

19           “(b) *CLERICAL AMENDMENT.*—*The table of contents in*  
20 *section 1(b) of the Homeland Security Act of 2002 is*  
21 *amended by inserting after the item relating to section 1907*  
22 *the following new item:*

          “Sec. 1908. *Securing the Cities program.*”.

23 **SEC. 3. MODEL EXERCISES.**

24           *Not later than 120 days after the date of the enactment*  
25 *of this Act, the Director for Domestic Nuclear Detection of*

1 *the Department of Homeland Security shall report to the*  
2 *Committee on Homeland Security and the Committee on*  
3 *Appropriations of the House of Representatives and the*  
4 *Committee on Homeland Security and Governmental Af-*  
5 *airs and the Committee on Appropriations of the Senate*  
6 *on the feasibility of the Director developing model exercises*  
7 *to test the preparedness of jurisdictions participating in the*  
8 *Securing the Cities program under section 1908 of the*  
9 *Homeland Security Act of 2002 (as added by section 2 of*  
10 *this Act) in meeting the challenges that may be posed by*  
11 *a range of nuclear and radiological threats.*
