A BILL

To amend the Endangered Species Act of 1973 to extend the import- and export-related provision of that Act to species proposed for listing as threatened or endangered under that Act.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Conserving Ecosystems
3 by Ceasing the Importation of Large Animal Trophies
4 Act” or the “CECIL Act”.

5 **SEC. 2. AMENDMENT TO ENDANGERED SPECIES ACT OF**
6 **1973.**

7 Section 9(a)(1) of the Endangered Species Act of
8 1973 (16 U.S.C. 1538(a)(1)) is amended by striking sub-
9 paragraph (A) and inserting the following:

10 “(A) for any such species listed, or proposed to
11 be listed, under section 4, import the species into, or
12 export the species from, the United States;”.

13 **SEC. 3. GOVERNMENT ACCOUNTABILITY OFFICE STUDY.**

14 (a) IN GENERAL.—Not later than 6 months after the
15 date of the enactment of this Act, the Comptroller General
16 of the United States shall conduct and submit to Congress
17 a report on the results of a study of the effectiveness of
18 trophy hunting in supporting international wildlife con-
19 servation efforts.

20 (b) APPLICATION OF REVENUES TO TANGIBLE AC-
21 TIONS.—The study shall include a detailed analysis of how
22 permit fees and other payments from hunters to govern-
23 ment entities and hunting guides in host countries are ap-
24 plied to tangible actions supporting the conservation of the
25 target species and other wildlife in such countries.

26 (c) REPORT.—The report shall—

1 (1) identify data gaps and recommend informa-
2 tion that hunters and host countries must submit to
3 verify the impacts of trophy hunting on wildlife con-
4 servation efforts; and

5 (2) recommend actions that the Department of
6 the Interior and the Congress should take to ensure
7 that trophy hunting contributes to conservation.
