## A BILL

To amend title 38, United States Code, to provide additional educational assistance under the Post-9/11 GI Bill for veterans pursuing a degree in science, technology, engineering, or math.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be referred to as the “Veterans’ STEM  
5 Education Program”.

1 **SEC. 2. ADDITIONAL EDUCATIONAL ASSISTANCE UNDER**  
2 **POST-9/11 GI BILL FOR VETERANS PURSUING**  
3 **DEGREE IN SCIENCE, TECHNOLOGY, ENGI-**  
4 **NEERING, OR MATH.**

5 (a) ADDITIONAL ASSISTANCE.—

6 (1) IN GENERAL.—Chapter 33 of title 38,  
7 United States Code, is amended by inserting after  
8 section 3316 the following new section:

9 **“§ 3316A. Veterans’ STEM Education Program**

10 “(a) IN GENERAL.—(1) The Secretary may pay to  
11 an individual entitled to educational assistance under this  
12 chapter such additional amount as the Secretary considers  
13 appropriate if—

14 “(A) the individual is using such assistance to  
15 pursue a program of education described in sub-  
16 section (b); and

17 “(B) the amount of such assistance otherwise  
18 provided under this chapter does not cover the full  
19 cost of the established charges for such program of  
20 education, as determined after the application of any  
21 waiver of, or reduction in, tuition and fees and any  
22 scholarship, or other Federal, State, institutional, or  
23 employer-based aid or assistance (other than loans  
24 and any funds provided under section 401(b) of the  
25 Higher Education Act of 1965 (20 U.S.C. 1070a))  
26 that is provided directly to the institution offering

1 such program of education and specifically des-  
2 ignated for the sole purpose of defraying tuition and  
3 fees.

4 “(2) Amounts payable to an individual under this sec-  
5 tion are in addition to any other amounts payable to such  
6 individual under this chapter.

7 “(b) COVERED PROGRAMS OF EDUCATION.—A pro-  
8 gram of education described in this subsection is a pro-  
9 gram of education with a focus (as determined in accord-  
10 ance with regulations prescribed by the Secretary for pur-  
11 poses of this section) on science, technology, engineering,  
12 or math.”.

13 (2) CLERICAL AMENDMENT.—The table of sec-  
14 tions at the beginning of such chapter is amended  
15 by inserting after the item relating to section 3316  
16 the following new item:

“3316A. Veterans’ STEM Education Program.”.

17 (b) REPORTS TO CONGRESS.—Section 3325(c) of  
18 title 38, United States Code, is amended—

19 (1) in paragraph (2), by striking “; and” and  
20 inserting a semicolon;

21 (2) by redesignating paragraph (3) as para-  
22 graph (4); and

23 (3) by inserting after paragraph (2) the fol-  
24 lowing new paragraph:

1           “(3) a detailed description of the activities car-  
2           ried out under section 3316A of this title during the  
3           academic year covered by the report and an evalua-  
4           tion of such activities; and”.
