A BILL

To amend chapter 8 of title 5, United States Code, to provide for en bloc consideration in resolutions of disapproval for “midnight rules”, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Midnight Rules Relief
 5 Act of 2016”.

6 **SEC. 2. EN BLOC CONSIDERATION OF RESOLUTIONS OF**
 7 **DISAPPROVAL PERTAINING TO “MIDNIGHT**
 8 **RULES”.**

9 (a) IN GENERAL.—Section 801(d) of title 5, United
 10 States Code, is amended by adding at the end the fol-
 11 lowing:

12 “(4) In applying section 802 to rules described under
 13 paragraph (1), a joint resolution of disapproval may con-
 14 tain one or more such rules if the report under subsection
 15 (a)(1)(A) for each such rule was submitted during the
 16 final year of a President’s term.”.

17 (b) TEXT OF RESOLVING CLAUSE.—Section 802(a)
 18 of title 5, United States Code, is amended—

19 (1) by inserting after “resolving clause of which
 20 is” the following: “(except as otherwise provided in
 21 this subsection)”; and

22 (2) by adding at the end the following: “In the
 23 case of a joint resolution under section 801(d)(4),
 24 the matter after the resolving clause of such resolu-
 25 tion shall be as follows: ‘That Congress disapproves

1 the following rules: the rule submitted by the ____
2 relating to ____; and the rule submitted by the ____
3 relating to _____. Such rules shall have no force or
4 effect.’ (The blank spaces being appropriately filled
5 in and additional clauses describing additional rules
6 to be included as necessary)’’.
