A BILL

To designate facilities of the United States Postal Service, to establish new ZIP Codes, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. POST OFFICE DESIGNATIONS.**

4 (a) SPECIAL WARFARE OPERATOR MASTER CHIEF
5 PETTY OFFICER (SEAL) LOUIS “LOU” J. LANGLAIS
6 POST OFFICE BUILDING.—

7 (1) DESIGNATION.—The facility of the United
8 States Postal Service located at 1221 State Street,
9 Suite 12, Santa Barbara, California, shall be known
10 and designated as the “Special Warfare Operator

1 Master Chief Petty Officer (SEAL) Louis ‘Lou’ J.
2 Langlais Post Office Building”.

3 (2) REFERENCES.—Any reference in a law,
4 map, regulation, document, paper, or other record of
5 the United States to the facility referred to in para-
6 graph (1) shall be deemed to be a reference to the
7 “Special Warfare Operator Master Chief Petty Offi-
8 cer (SEAL) Louis ‘Lou’ J. Langlais Post Office
9 Building”.

10 (b) RICHARD ALLEN CABLE POST OFFICE.—

11 (1) DESIGNATION.—The facility of the United
12 States Postal Service located at 23323 Shelby Road
13 in Shelby, Indiana, shall be known and designated
14 as the “Richard Allen Cable Post Office”.

15 (2) REFERENCES.—Any reference in a law,
16 map, regulation, document, paper, or other record of
17 the United States to the facility referred to in para-
18 graph (1) shall be deemed to be a reference to the
19 “Richard Allen Cable Post Office”.

20 (c) LEONARD MONTALTO POST OFFICE BUILDING.—

21 (1) DESIGNATION.—The facility of the United
22 States Postal Service located at 3031 Veterans Road
23 West in Staten Island, New York, shall be known
24 and designated as the “Leonard Montalto Post Of-
25 fice Building”.

1 (2) REFERENCES.—Any reference in a law,
2 map, regulation, document, paper, or other record of
3 the United States to the facility referred to in para-
4 graph (1) shall be deemed to be a reference to the
5 “Leonard Montalto Post Office Building”.

6 (d) ARMY FIRST LIEUTENANT DONALD C. CARWILE
7 POST OFFICE BUILDING.—

8 (1) DESIGNATION.—The facility of the United
9 States Postal Service located at 401 McElroy Drive
10 in Oxford, Mississippi, shall be known and des-
11 ignated as the “Army First Lieutenant Donald C.
12 Carwile Post Office Building”.

13 (2) REFERENCES.—Any reference in a law,
14 map, regulation, document, paper, or other record of
15 the United States to the facility referred to in para-
16 graph (1) shall be deemed to be a reference to the
17 “Army First Lieutenant Donald C. Carwile Post Of-
18 fice Building”.

19 (e) E. MARIE YOUNGBLOOD POST OFFICE.—

20 (1) DESIGNATION.—The facility of the United
21 States Postal Service located at 14231 TX-150 in
22 Coldspring, Texas, shall be known and designated as
23 the “E. Marie Youngblood Post Office”.

24 (2) REFERENCES.—Any reference in a law,
25 map, regulation, document, paper, or other record of

1 the United States to the facility referred to in para-
2 graph (1) shall be deemed to be a reference to the
3 “E. Marie Youngblood Post Office”.

4 (f) ZAPATA VETERANS POST OFFICE.—

5 (1) DESIGNATION.—The facility of the United
6 States Postal Service located at 810 N. U.S. High-
7 way 83 in Zapata, Texas, shall be known and des-
8 ignated as the “Zapata Veterans Post Office”.

9 (2) REFERENCES.—Any reference in a law,
10 map, regulation, document, paper, or other record of
11 the United States to the facility referred to in para-
12 graph (1) shall be deemed to be a reference to the
13 “Zapata Veterans Post Office”.

14 (g) MARINE LANCE CORPORAL SQUIRE “SKIP”
15 WELLS POST OFFICE BUILDING.—

16 (1) DESIGNATION.—The facility of the United
17 States Postal Service located at 2886 Sandy Plains
18 Road in Marietta, Georgia, shall be known and des-
19 ignated as the “Marine Lance Corporal Squire
20 ‘Skip’ Wells Post Office Building”.

21 (2) REFERENCES.—Any reference in a law,
22 map, regulation, document, paper, or other record of
23 the United States to the facility referred to in para-
24 graph (1) shall be deemed to be a reference to the

1 “Marine Lance Corporal Squire ‘Skip’ Wells Post
2 Office Building”.

3 (h) OFFICER JOSEPH P. CALI POST OFFICE BUILD-
4 ING.—

5 (1) DESIGNATION.—The facility of the United
6 States Postal Service located at 6300 N. Northwest
7 Highway in Chicago, Illinois, shall be known and
8 designated as the “Officer Joseph P. Cali Post Of-
9 fice Building”.

10 (2) REFERENCES.—Any reference in a law,
11 map, regulation, document, paper, or other record of
12 the United States to the facility referred to in para-
13 graph (1) shall be deemed to be a reference to the
14 “Officer Joseph P. Cali Post Office Building”.

15 (i) SEGUNDO T. SABLAN AND CNMI FALLEN MILI-
16 TARY HEROES POST OFFICE BUILDING.—

17 (1) DESIGNATION.—The facility of the United
18 States Postal Service located at 1 Chalan Kanoa
19 VLG in Saipan, Northern Mariana Islands, shall be
20 known and designated as the “Segundo T. Sablan
21 and CNMI Fallen Military Heroes Post Office
22 Building”.

23 (2) REFERENCES.—Any reference in a law,
24 map, regulation, document, paper, or other record of
25 the United States to the facility referred to in para-

1 graph (1) shall be deemed to be a reference to the
2 “Segundo T. Sablan and CNMI Fallen Military He-
3 roes Post Office Building”.

4 (j) ABNER J. MIKVA POST OFFICE BUILDING.—

5 (1) DESIGNATION.—The facility of the United
6 States Postal Service located at 1101 Davis Street
7 in Evanston, Illinois, shall be known and designated
8 as the “Abner J. Mikva Post Office Building”.

9 (2) REFERENCES.—Any reference in a law,
10 map, regulation, document, paper, or other record of
11 the United States to the facility referred to in para-
12 graph (1) shall be deemed to be a reference to the
13 “Abner J. Mikva Post Office Building”.

14 **SEC. 2. ESTABLISHING NEW ZIP CODES.**

15 Not later than September 30, 2017, the United
16 States Postal Service shall designate a single, unique ZIP
17 code for, as nearly as practicable, each of the following
18 communities:

19 (1) Miami Lakes, Florida.

20 (2) Storey County, Nevada.

21 (3) Flanders, Northampton, and Riverside in
22 the Town of Southampton, New York.

23 (4) Ocoee, Florida.

24 (5) Glendale, New York.
