A BILL

To designate certain National Forest System lands and certain public lands under the jurisdiction of the Secretary of the Interior in the States of Idaho, Montana, Oregon, Washington, and Wyoming as wilderness, wild and scenic rivers, wildland recovery areas, and biological connecting corridors, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SEC. 2. FINDINGS.**

2 The Congress makes the following findings:

3 (1) Many areas of undeveloped National Forest
 4 System lands, National Park System lands, and
 5 public lands administered by the Bureau of Land
 6 Management in the States of Idaho, Montana, Or-
 7 egon, Washington, and Wyoming possess out-
 8 standing natural characteristics which give them
 9 high values as wilderness, parks, and wild and scenic
 10 rivers and will, if properly preserved, be an enduring
 11 resource of wilderness, wild land areas, and biodiver-
 12 sity for the benefit of the American people.

13 (2) The Northern Rockies Bioregion contains
 14 the most diverse array of wild lands remaining south
 15 of Canada, providing sanctuary for a host of species
 16 listed as threatened or endangered under section
 17 4(c) of the Endangered Species Act of 1973 (16
 18 U.S.C. 1533(c)). These national interest public lands
 19 are among the most popular wild lands in the
 20 United States, embracing greater ecosystems and
 21 national treasures such as the Greater Yellowstone,

1 Greater Glacier/Northern Continental Divide, Great-
2 er Hells Canyon/Wallowa, Greater Salmon/Selway,
3 and Greater Cabinet/Yaak/Selkirk ecosystems.

4 (3) The natural ecosystems in the Northern
5 Rockies Bioregion are largely dependent on National
6 Forest System lands, National Park System lands,
7 and public lands administered by the Bureau of
8 Land Management, and the ecological productivity
9 and diversity of resources these Federal public lands
10 provide. Conservation of roadless areas on these
11 public lands, which produces clean water, protects
12 native fisheries and native flora and fauna, and pro-
13 vides scenic and recreational qualities, also preserves
14 options for sustainable economics through activities
15 such as hunting, fishing, and wilderness-based recre-
16 ation.

17 (4) The headwaters of several major river sys-
18 tems, including the Columbia, Snake, Green, Mis-
19 souri and Saskatchewan Rivers, originate in the
20 Northern Rockies Bioregion, and these rivers send
21 their waters to three different oceans. These waters
22 are of tremendous economic importance to farming
23 and ranching operations, municipal water supplies,
24 and water-based recreation, including fishing and
25 boating. Protection of this world class water re-

1 source will enhance these uses, reduce costs for
2 water treatment and irrigation, and increase native
3 fish populations.

4 (5) The wildlife treasures of the Northern
5 Rockies are of international significance and contain
6 remarkably intact large mammalian fauna and rare
7 and unique plant life. Wildlife habitat fragmentation
8 due to roadbuilding, timber harvest, mining, oil and
9 gas exploration, lack of interagency cooperation, and
10 other activities has severe effects on the wildlife pop-
11 ulations (including those listed as threatened or en-
12 dangered under section 4(c) of the Endangered Spe-
13 cies Act of 1973 (16 U.S.C. 1533(c))) and their
14 habitat, the water quality, the ancient forests, and
15 the greater ecosystems of the Northern Rockies Bio-
16 region. The overemphasis on resource extraction
17 from National Forest System lands and public lands
18 administered by the Bureau of Land Management
19 has compromised ecosystem integrity and detracted
20 from economic diversification opportunities. Eco-
21 nomic instability and high unemployment in rural,
22 resource-dependent communities is a common result
23 of overexploitation of these lands.

24 (6) Continued fragmentation and development
25 of the remaining roadless and essentially roadless

1 ecosystems and biological connectors of the Northern
2 Rockies would cause a loss to the Nation of an en-
3 tire wild land region and of the only remaining areas
4 south of Canada still pristine enough to support
5 populations of caribou, gray wolves, grizzly bears,
6 anadromous fish, and numerous other rare and en-
7 dangered plant and animal life all in one intact bio-
8 region.

9 (7) Since the 1936 roadless area inventory com-
10 pleted by Bob Marshall, millions of acres of roadless
11 wild lands have been developed in the Northern
12 Rockies. Extensive fragmentation of wild lands and
13 wildlife habitat has resulted in the listing of several
14 species as threatened or endangered and reduced the
15 numbers and range of many others, including anad-
16 romous fish.

17 (8) The natural ecosystems of the Northern
18 Rockies Bioregion also serve as educational and re-
19 search centers for on-site studies in biology, geology,
20 astronomy and other sciences. The pristine nature of
21 the National Forest System lands, National Park
22 System lands, and public lands administered by the
23 Bureau of Land Management in the Northern Rock-
24 ies Bioregion helps local communities attract new

1 residents and businesses based on local quality of
2 life.

3 (9) A review of the current situation in the
4 Northern Rockies has revealed the urgent need for
5 an ecological reserve system for the Northern Rock-
6 ies Bioregion, which includes core ecosystem reserve
7 areas and biological connecting corridors necessary
8 to ensure wildlife movements and genetic inter-
9 change between the core reserve areas. Wildlife free-
10 dom of movement has always been essential to the
11 survival of wildlife species, and an increasing num-
12 ber of scientific studies have identified movement
13 corridors as a necessity for wildlife conservation in
14 a changing climate. Several foreign governments, in-
15 cluding the governments of Australia and Scotland,
16 have announced plans for corridors that would make
17 wildlife movement possible as climate pressures in-
18 crease. The concept of connective corridors for wild-
19 life movement has been endorsed by governors of
20 States in the western United States, and is now
21 widely recognized by conservation and scientific or-
22 ganizations. For example, freedom of movement for
23 wildlife is basic to the emerging new science of
24 “Movement Ecology” described in a December 2008
25 Proceedings of the National Academy of Sciences.

1 This freedom of wildlife movement was a funda-
2 mental reason for the Act's development and intro-
3 duction, and has become an increasingly high profile
4 issue in the climate and biological sciences.

5 (10) The economic value to the Nation of most
6 of these undeveloped areas, left in their natural
7 state, greatly exceeds any potential return to the
8 Treasury of the United States from timber harvest
9 and development. If current Federal land manage-
10 ment in the Northern Rockies continues to result in
11 the development of roadless areas, the American
12 public will be using its tax dollars to fund perma-
13 nent reductions in wilderness, water quality, fish and
14 wildlife habitat, and species and biological diversity.

15 (11) Instead, this Act provides opportunities for
16 employment in outdoor trades by establishing reha-
17 bilitation zones on specific tracts of damaged Fed-
18 eral land where active restoration work will occur.
19 This Act will provide contracts for local businesses
20 and renew the intrinsic economic, social and cultural
21 benefits that result from productive land. Federal
22 land rehabilitation projects represent a direct benefit
23 to the local economy and reduce the loss to Amer-
24 ican taxpayers caused by below-cost timber sales and
25 other subsidized resource extraction.

1 (12) The congressional review of roadless areas
2 within the National Forest System, National Park
3 System, and public lands administered by the Bu-
4 reau of Land Management in the States of Idaho,
5 Montana, Oregon, Washington, and Wyoming has
6 identified areas which, on the basis of their land
7 form, ecosystem, associated fish and wildlife, eco-
8 nomic value, and location will help to fulfill the role
9 of the United States Forest Service, National Park
10 Service, and Bureau of Land Management to ensure
11 a quality National Wilderness Preservation System.
12 The review has identified other areas which may
13 have outstanding values as wild and scenic rivers.
14 The review has also identified areas which may not
15 possess outstanding wilderness attributes and should
16 not now be designated as components of the Na-
17 tional Wilderness Preservation System, but which
18 should be studied to determine their role in main-
19 taining biological diversity in the Northern Rockies.

20 (13) Many areas of National Forest System
21 lands and public lands administered by the Bureau
22 of Land Management have been damaged and their
23 productivity reduced by unwise development prac-
24 tices, which have also impaired ecosystem function
25 and biological diversity. The Island Park area adja-

1 cent to Yellowstone National Park contains large
2 clear-cut areas right up to the park boundary. Ef-
3 forts should be made to return these areas to their
4 former ecological health and native diversity. These
5 efforts should seek to ensure that vital ecosystem
6 components are restored, especially in areas where
7 wildlife travel corridors and native fish and wildlife
8 populations have been damaged or eliminated. Res-
9 toration efforts should seek to ensure and maintain
10 genetic interchange, biological diversity, and restora-
11 tion of native species diversity throughout the
12 Northern Rockies Bioregion.

13 (14) Backcountry areas of the National Park
14 System have been damaged by inappropriate man-
15 agement, despite policies that require that rec-
16 ommended wilderness be administered as wilderness.
17 An emphasis on structures and motorized equip-
18 ment, and in some instances developed
19 “backcountry” campsites, have all detracted from
20 and degraded the wilderness character of these
21 backcountry areas.

22 (15) Federal agencies entrusted with managing
23 the natural resources of the Northern Rockies Bio-
24 region operate under contradictory congressional
25 mandates, and thus are in dissension over manage-

1 ment policies which involve common resources and
2 greater ecosystems. Existing agency structures and
3 regulatory mechanisms have proven unsatisfactory
4 for responsible management of nationally important
5 ecosystems on public lands. Existing laws and regu-
6 lations have not been sufficient to establish and
7 maintain agency accountability for public resources.

8 (16) This Act does not affect private existing
9 rights.

10 **SEC. 3. PURPOSES.**

11 (a) IN GENERAL.—The purposes of this Act are—

12 (1) to designate certain National Forest System
13 lands, certain National Park System lands, and cer-
14 tain public lands administered by the Bureau of
15 Land Management in the States of Idaho, Montana,
16 Oregon, Washington, and Wyoming as components
17 of the National Wilderness Preservation System;

18 (2) to designate certain National Forest System
19 lands, public lands administered by the Bureau of
20 Land Management, and watercourses on these lands
21 in the States of Montana, Idaho, and Wyoming as
22 components of the National Wild and Scenic Rivers
23 System;

1 (3) to prioritize areas for wildland recovery to
2 help restore biological diversity and native species;
3 and

4 (4) to establish a system of biological con-
5 necting corridors between the core ecosystems in the
6 Northern Rockies Bioregion.

7 (b) PURPOSE OF DESIGNATIONS.—The designations
8 made by this Act are made in order to—

9 (1) promote, perpetuate, and preserve the wil-
10 derness character of the area so designated;

11 (2) protect water quality, watersheds, and wild-
12 life habitat, including that of species listed as threat-
13 ened or endangered under section 4(c) of the Endan-
14 gered Species Act of 1973 (16 U.S.C. 1533(c));

15 (3) protect the ecological integrity and con-
16 tiguity of major wild land ecosystems and their
17 interconnecting corridors identified by the United
18 States Fish and Wildlife Service, and other sources;

19 (4) protect and maintain biological and native
20 species diversity and dispersal throughout the
21 Northern Rockies Bioregion;

22 (5) promote and ensure interagency cooperation
23 in the implementation of integrated, holistic eco-
24 system management and protection of the eco-

1 systems and corridors covered by this Act based
2 upon principles from conservation biology;

3 (6) preserve scenic, historic, and cultural re-
4 sources;

5 (7) promote scientific research, primitive recre-
6 ation, solitude, physical and mental challenge, and
7 inspiration for the benefit of all of the American
8 people;

9 (8) avoid the misinvestment of scarce capital in
10 lands of marginal timber value; and

11 (9) promote ecologically and economically sus-
12 tainable management in the Northern Rockies Bio-
13 region.

14 **SEC. 4. DEFINITIONS.**

15 For purposes of this Act:

16 (1) DEVELOPMENT.—The term “development”
17 means activities that eliminate the roadless and wil-
18 derness characteristics of the land and includes ski
19 resort facilities and such activities as roadbuilding,
20 timber harvest, mining, and oil and gas drilling.

21 (2) GREATER ECOSYSTEM.—The term “greater
22 ecosystem”, when used in conjunction with the spe-
23 cific ecosystems protected under this Act, means the
24 ecological land units of sufficient scale to support
25 and maintain populations of large vertebrate species

1 and the other native plant and animal species of the
2 units. These units are comprised of lands which are
3 similar in regards to topography, climate, and plant
4 and animal species. The ecosystems in the Northern
5 Rockies are also defined in terms of the habitat of
6 wildlife indicator species listed as threatened or en-
7 dangered under section 4(c) of the Endangered Spe-
8 cies Act of 1973 (16 U.S.C. 1533(c)), including griz-
9 zly bear, gray wolf, bald eagle, and caribou, and
10 have been depicted on maps published by Federal
11 agencies.

12 (3) NORTHERN ROCKIES BIOREGION.—The
13 term “Northern Rockies Bioregion” means the por-
14 tion of the Northern Rocky Mountains in the States
15 of Montana, Idaho, Wyoming, Oregon, and Wash-
16 ington, so referred to on maps referred to in this
17 Act.

18 (4) CORRIDORS.—The term “corridors” means
19 areas that provide connectivity of habitat or poten-
20 tial habitat and that facilitate the ability of terres-
21 trial, estuarine, and freshwater fish, or wildlife to
22 move within a landscape as needed for migration,
23 gene flow, or dispersal, or in response to the impacts
24 of climate change or other impacts.

1 (5) HABITAT.—The term “habitat” means the
2 physical, chemical, and biological properties that are
3 used by fish, wildlife, or plants for growth, reproduc-
4 tion, survival, food, water, and cover, on a tract of
5 land, in a body of water, or in an area or region.

6 (6) INDIAN TRIBE.—The term “Indian tribe”
7 has the meaning given the term in section 4 of the
8 Indian Self-Determination and Education Assistance
9 Act (25 U.S.C. 450b).

10 (7) NATURAL RESOURCES.—The term “natural
11 resources” means the terrestrial, freshwater, estua-
12 rine, and marine fish, wildlife, plants, land, water,
13 habitats, and ecosystems of the United States.

14 (8) PUBLIC LAND.—The term “public land”
15 has the meaning given the term in section 103(e) of
16 the Federal Land Policy and Management Act of
17 1976 (43 U.S.C. 1702(e)).

18 (9) RESILIENCE.—The terms “resilience” and
19 “resilient” means the ability to resist or recover
20 from disturbance and preserve diversity, produc-
21 tivity, and sustainability.

22 (10) SECRETARY CONCERNED.—The term
23 “Secretary concerned” means—

24 (A) the Secretary of Agriculture, with re-
25 spect to National Forest System lands; and

1 (B) the Secretary of the Interior, with re-
2 spect to National Park System lands and public
3 land.

4 **TITLE I—DESIGNATION OF**
5 **WILDERNESS**

6 **SEC. 101. DESIGNATION OF CERTAIN NATIONAL FOREST**
7 **SYSTEM LANDS, NATIONAL PARK SYSTEM**
8 **LANDS, AND BUREAU OF LAND MANAGEMENT**
9 **LANDS AS WILDERNESS.**

10 In furtherance of the purpose of the Wilderness Act
11 (16 U.S.C. 1131 et seq.), certain National Forest System
12 lands, National Park System lands, and public lands ad-
13 ministered by the Bureau of Land Management, as de-
14 scribed in this title, in the States of Idaho, Montana, Or-
15 egon, Washington, and Wyoming are designated as wilder-
16 ness and, therefore, as components of the National Wilder-
17 ness Preservation System.

18 **SEC. 102. GREATER GLACIER/NORTHERN CONTINENTAL DI-**
19 **VIDE ECOSYSTEM.**

20 (a) DESIGNATION.—In order to protect the unique
21 ecosystem of the greater Glacier/Northern Continental Di-
22 vide region, the areas described in this section are hereby
23 designated as wilderness.

1 (b) BOB MARSHALL WILDERNESS ADDITIONS.—The
2 following areas are incorporated into the Bob Marshall
3 Wilderness:

4 (1) CHOTEAU MOUNTAIN/TETON HIGH PEAKS/
5 DEEP CREEK ADDITION.—Certain Federal land with-
6 in the Lewis and Clark National Forest and land ad-
7 ministered by the Lewistown Field Office of the Bu-
8 reau of Land Management comprising approximately
9 73,000 acres as generally depicted on the map enti-
10 tled “_____” and dated _____, which shall be added
11 to and administered as part of the Bob Marshall
12 Wilderness.

13 (2) RENSHAW ADDITION.—Certain Federal land
14 within the Lewis and Clark National Forest and
15 land administered by the Lewistown Field Office of
16 the Bureau of Land Management comprising ap-
17 proximately 30,000 acres as generally depicted on
18 the map entitled “_____” and dated _____, which
19 shall be added to and administered as part of the
20 Bob Marshall Wilderness.

21 (3) SWAN FRONT ADDITION.—Certain Federal
22 land within the Flathead National Forest and Lolo
23 National Forest comprising approximately 169,000
24 acres as generally depicted on the map entitled
25 “_____” and dated _____, which shall be added

1 to and administered as part of the Bob Marshall
2 Wilderness.

3 (4) HUNGRY HORSE RESERVOIR WEST.—Cer-
4 tain Federal land within the Flathead National For-
5 est comprising approximately 179,000 acres as gen-
6 erally depicted on the map entitled “_____” and
7 dated _____, which shall be added to and adminis-
8 tered as part of the Bob Marshall Wilderness.

9 (5) BOB NORTH ADDITION.—Certain Federal
10 land within the Flathead National Forest comprising
11 approximately 88,000 acres as generally depicted on
12 the map entitled “_____” and dated _____, which
13 shall be added to and administered as part of the
14 Bob Marshall Wilderness.

15 (6) MONTURE CREEK ADDITION.—Certain Fed-
16 eral land within the Lolo National Forest comprising
17 approximately 99,000 acres as generally depicted on
18 the map entitled “_____” and dated _____, which
19 shall be added to and administered as part of the
20 Bob Marshall Wilderness.

21 (c) GREAT BEAR WILDERNESS ADDITIONS.—The
22 following areas are incorporated into the Great Bear Wil-
23 derness:

24 (1) HUNGRY HORSE RESERVOIR EAST ADDI-
25 TION.—Certain Federal land within the Flathead

1 National Forest comprising approximately 37,000
2 acres as generally depicted on the map entitled
3 “_____” and dated _____, which
4 shall be added to and administered as part of the
5 Great Bear Wilderness.

6 (2) MIDDLE FORK ADDITIONS.—Certain Fed-
7 eral land within the Flathead National Forest com-
8 prising approximately 53,000 acres as generally de-
9 picted on the map entitled “_____” and dated
10 _____, which shall be added to and adminis-
11 tered as part of the Great Bear Wilderness.

12 (d) SCAPEGOAT WILDERNESS ADDITIONS.—The fol-
13 lowing areas, consisting of a total of approximately
14 125,000 acres, are incorporated into the Scapegoat Wil-
15 derness:

16 (1) STONEWALL MOUNTAIN ADDITION.—Cer-
17 tain Federal land within the Helena National Forest
18 comprising approximately 55,000 acres as generally
19 depicted on the map entitled “_____” and
20 dated _____, which shall be added to and
21 administered as part of the Scapegoat Wilderness.

22 (2) SILVER KING/FALLS CREEK ADDITION.—
23 Certain Federal land within the Lewis and Clark
24 National Forest and Helena National Forest com-
25 prising approximately 25,000 acres as generally de-

1 picted on the map entitled “_____” and dated
2 _____, which shall be added to and adminis-
3 tered as part of the Scapegoat Wilderness.

4 (3) BENCHMARK/ELK CREEK ADDITION.—Cer-
5 tain Federal lands within the Lewis and Clark Na-
6 tional Forest, comprising approximately 28,000
7 acres as generally depicted on the map entitled
8 “_____” and dated _____, which
9 shall be added to and administered as part of the
10 Scapegoat Wilderness.

11 (e) MISSION MOUNTAINS WILDERNESS ADDI-
12 TIONS.—The following areas, consisting of a total of ap-
13 proximately 16,000 acres, are incorporated into the Mis-
14 sion Mountains Wilderness:

15 (1) MISSION MOUNTAIN WILDERNESS ADDI-
16 TION.—Certain Federal land within the Flathead
17 National Forest comprising approximately 20,000
18 acres as generally depicted on the map entitled
19 “_____” and dated _____, which
20 shall be added to and administered as part of the
21 Mission Mountains Wilderness.

22 (2) MARSHALL PEAK ADDITION.—Certain Fed-
23 eral land within the Lolo National Forest comprising
24 approximately 9,000 acres as generally depicted on
25 the map entitled “_____” and dated

1 _____, which shall be added to and adminis-
2 tered as part of the Mission Mountains Wilderness.

3 (f) NEW NATIONAL WILDERNESS PRESERVATION
4 SYSTEM COMPONENTS.—The following areas are des-
5 igned as new components of the National Wilderness
6 Preservation System:

7 (1) GLACIER WILDERNESS, GLACIER NATIONAL
8 PARK.—Certain Federal land within Glacier Na-
9 tional Park comprising approximately 925,000 acres
10 as generally depicted on the map entitled
11 “_____” and dated _____, which

9 (31) CAYUSE MOUNTAIN WILDERNESS.—Cer-
10 tain Federal land within the Helena National Forest
11 comprising approximately 22,000 acres, as generally
12 depicted on the map entitled “_____” and
13 dated _____, which shall be known as the
14 Cayuse Mountain Wilderness.

15 (32) ELECTRIC PEAK/LITTLE BLACKFOOT
16 MEADOWS WILDERNESS, BEAVERHEAD-DEERLODGE
17 AND HELENA NATIONAL FORESTS.—Certain Federal
18 land within the Helena and Beaverhead-Deerlodge
19 National Forest comprising approximately 53,000
20 acres, as generally depicted on the map entitled
21 “_____” and dated _____, which
22 shall be known as the Electric Peak/Little Blackfoot
23 Meadows Wilderness.

24 (33) WHITETAIL-HAYSTACK WILDERNESS.—
25 Certain Federal land within the Beaverhead-

1 Deerlodge National Forest comprising approximately
2 73,000 acres, as generally depicted on the map enti-
3 tled “ _____ ” and dated _____, which
4 shall be known as the Whitetail-Haystack Wilder-
5 ness.

6 (34) O’NEIL CREEK WILDERNESS.—Certain
7 Federal land within the Beaverhead-Deerlodge Na-
8 tional Forest comprising approximately 7,000 acres,
9 as generally depicted on the map entitled
10 “ _____ ” and dated _____, which
11 shall be known as the O’Neil Creek Wilderness.

12 (35) BANGTAIL WILDERNESS.—Certain Federal
13 land within the Custer Gallatin National Forest
14 comprising approximately 51,000 acres, as generally
15 depicted on the map entitled “ _____ ” and
16 dated _____, which shall be known as the
17 Bangtail Wilderness.

18 (n) MT. LEIDY HIGHLANDS/WIND RIVER RANGE
19 CORRIDOR.—The following area in this corridor, des-
20 ignated in title II, is hereby designated as wilderness:

21 (1) FISH LAKE MOUNTAIN WILDERNESS.—Cer-
22 tain Federal land within the Shoshone National For-
23 est comprising approximately 7,000 acres, as gen-
24 erally depicted on the map entitled “ _____ ”

1 and dated _____, which shall be known as the
2 Fish Lake Mountain Wilderness.

3 **SEC. 109. ADMINISTRATION.**

4 (a) **MANAGEMENT GENERALLY.**—Subject to valid ex-
5 isting rights, land designated as wilderness by this title
6 shall be administered in accordance with the Wilderness
7 Act (16 U.S.C. 1131 et seq.) by the Secretary concerned,
8 except that—

9 (1) any reference in the Wilderness Act to the
10 effective date of the Wilderness Act or any similar
11 reference shall be deemed to be a reference to the
12 date of the enactment of this Act;

13 (2) any reference in the Wilderness Act to the
14 Secretary of Agriculture shall be considered to be a
15 reference to Secretary concerned; and

16 (3) the Secretaries shall, to the greatest extent
17 possible, coordinate the management of those wilder-
18 ness areas containing land administered by more
19 than one Federal land management agency.

20 (b) **MAPS AND DESCRIPTION.**—As soon as prac-
21 ticable after the date of the enactment of this Act, the
22 Secretary concerned shall file a map and legal description
23 of the land designated as wilderness by this title with—

24 (1) the Committee on Energy and Natural Re-
25 sources of the Senate; and

1 (2) the Committee on Natural Resources of the
2 House of Representatives.

3 (c) FORCE AND EFFECT.—Each map and legal de-
4 scription shall have the same force and effect as if in-
5 cluded in this Act, except that the Secretary concerned
6 may correct clerical and typographical errors in the maps
7 and legal descriptions.

8 (d) PUBLIC AVAILABILITY.—Each map and legal de-
9 scription filed under subsection (a) shall be on file and
10 available for public inspection in the Office of the Chief
11 of the Forest Service, the Office of the Director of the
12 Bureau of Land Management, or the Office of the Direc-
13 tor of the National Park Service, as appropriate.

14 **SEC. 110. WATER.**

15 (a) RESERVATION.—With respect to the lands des-
16 ignated as wilderness by this title, the Congress hereby
17 reserves a quantity of water sufficient to fulfill the pur-
18 poses for which the lands are designated as wilderness.
19 The priority date of such reserved rights shall be the date
20 of enactment of this Act.

21 (b) IMPLEMENTATION.—The Secretary of Agri-
22 culture, the Secretary of the Interior, and all other officers
23 of the United States shall take all steps necessary to pro-
24 tect the rights reserved by subsection (a), including the
25 filing of claims for quantification of such rights in any

1 present or future appropriate stream adjudication, in a
2 court of the State of Idaho, Montana, Wyoming, Oregon,
3 or Washington, in which the United States has been or
4 is properly joined in accordance with section 208 of the
5 Act of July 10, 1952 (43 U.S.C. 666; commonly referred
6 to as the McCarran Amendment).

7 **TITLE II—BIOLOGICAL** 8 **CONNECTING CORRIDORS**

9 **SEC. 201. FINDINGS.**

10 The Congress makes the following findings:

11 (1) The most recent scientific information on
12 ecological reserve design and function, including re-
13 cent scientific information on species dispersal in re-
14 sponse to a changing climate, points out the critical
15 need for biological connecting corridors between the
16 larger core ecosystem areas.

17 (2) While none of the remaining major wild
18 land ecosystems of the Northern Rockies Bioregion
19 appears to be of sufficient size to perpetuate the full
20 complement of self-sustaining viable populations of
21 native wildlife, biological diversity, and full range of
22 ecological processes on its own, it appears that an
23 effective reserve system can be achieved if biological
24 connecting corridors between the ecosystems are
25 identified and protected.

1 (3) The wild land areas addressed by this title
2 are located between the major core ecosystems of the
3 region and are essential for wildlife and plant migra-
4 tion and genetic interchange.

5 (4) These areas are some of the most beautiful
6 and wild mountain ranges in the United States, in-
7 cluding the Bitterroot, Sapphire, Lost River, Lemhi,
8 and Bridger mountain ranges.

9 **SEC. 202. DESIGNATION OF BIOLOGICAL CONNECTING COR-**
10 **RIDORS.**

11 (a) DESIGNATION.—To protect the life flow of the
12 Northern Rockies Bioregion, the areas described in this
13 section are hereby designated as biological connecting cor-
14 ridors. The designated biological connecting corridors are
15 of two types, areas designated as components of the Na-
16 tional Wilderness Preservation System in title I and areas
17 subject to special corridor management requirements
18 under section 203 in this title. Each biological connecting
19 corridor shall be known by the name given it in the sub-
20 section establishing it. Each map shall be on file and avail-
21 able for public inspection in the Office of the Chief of the
22 Forest Service and the Office of the Director of the Bu-
23 reau of Land Management.

24 (b) SAPPHIRE MOUNTAINS/CONTINENTAL DIVIDE
25 CORRIDORS.—Certain Federal lands comprising approxi-

1 mately 120,000 acres, as generally depicted on the map
2 entitled “_____” and dated _____, admin-
3 istered by the Bitterroot, Beaverhead-Deerlodge, or Lolo
4 National Forest and land administered by the Missoula
5 Field Office of the Bureau of Land Management are des-
6 ignated as Sapphire Mountains/Continental Divide Cor-
7 ridor and shall be subject to the special corridor manage-
8 ment requirements under section 203.

9 (c) JOCKO MOUNTAINS/CABINET MOUNTAINS COR-
10 RIDOR.—Certain Federal lands comprising approximately
11 129,000 acres, as generally depicted on the map entitled
12 “_____” and dated _____, administered by
13 the Lolo National Forest are designated as Jocko Moun-
14 tains/Cabinet Mountains Corridor and shall be subject to
15 the special corridor management requirements under sec-
16 tion 203.

17 (d) NINE MILE/GREAT BURN CORRIDORS.—Certain
18 Federal lands comprising approximately 73,000 acres, as
19 generally depicted on the map entitled “_____” and
20 dated _____, administered by the Lolo National
21 Forest are designated as Nine Mile/Great Burn Corridor
22 and shall be subject to the special corridor management
23 requirements under section 203.

24 (e) ANACONDA-PINTLER-DIVIDE CORRIDORS.—Cer-
25 tain Federal lands comprising approximately 260,000

1 acres, as generally depicted on the map entitled
2 “_____” and dated _____, within the
3 Beaverhead-Deerlodge National Forest and land adminis-
4 tered by the Dillon or Butte Field Offices of the Bureau
5 of Land Management are designated as Anaconda-Pintler-
6 Divide Corridor and shall be subject to the special corridor
7 management requirements under section 203.

8 (f) TEN LAKES/CABINET/YAAK CORRIDORS.—Cer-
9 tain Federal lands comprising approximately 310,000
10 acres, as generally depicted on the map entitled
11 “_____” and dated _____, within the
12 Kootenai National Forest are designated as Ten Lakes/
13 Cabinet/Yaak Corridor and shall be subject to the special
14 corridor management requirements under section 203.

15 (g) CABINET/YAAK/GREAT BURN COMPLEX COR-
16 RIDOR.—Certain Federal lands comprising approximately
17 205,000 acres, as generally depicted on the map entitled
18 “_____” and dated _____, within the Idaho
19 Panhandle, Lolo or Kootenai National Forest are des-
20 ignated as Cabinet/Yaak/Great Burn Complex Corridor
21 and shall be subject to the special corridor management
22 requirements under section 203.

23 (h) CABINET/YAAK/SELKIRK CORRIDORS.—Certain
24 Federal lands comprising approximately 96,000 acres, as
25 generally depicted on the map entitled “_____” and

1 dated _____, administered by the Idaho Pan-
2 handle, Kootenai, or Colville National Forest are des-
3 ignated as the Cabinet/Yaak/Selkirk Biological Connecting
4 Corridor and shall be subject to the special corridor man-
5 agement requirements under section 203.

6 (i) CABINET/YAAK/CANADA CORRIDORS.—Certain
7 Federal lands comprising approximately 41,000, as gen-
8 erally depicted on the map entitled “_____” and
9 dated _____, within the Idaho Panhandle or
10 Kootenai National Forest are designated as the Cabinet/
11 Yaak/Canada Biological Connecting Corridor and shall be
12 subject to the special corridor management requirements
13 under section 203.

14 (j) ANACONDA-PINTLAR/BITTERROOT MOUNTAINS
15 CORRIDORS.—Certain Federal lands comprising approxi-
16 mately 147,000 acres, as generally depicted on the map
17 entitled “_____” and dated _____, within
18 the Beaverhead-Deerlodge National Forest and land ad-
19 ministered by the Dillon Field Office of the Bureau of
20 Land Management are designated as Anaconda-Pintler/
21 Bitterroot Mountains Corridor and shall be subject to the
22 special corridor management requirements under section
23 203.

24 (k) FRANK CHURCH/GREATER YELLOWSTONE COR-
25 RIDORS.—Certain Federal lands comprising approximately

1 642,000 acres, as generally depicted on the map entitled
2 “_____” and dated _____, within the Bea-
3 verhead-Deerlodge, Bitterroot, Caribou-Targhee, or Salm-
4 on-Challis National Forest and land administered by the
5 Dillon or Salmon Field Office of the Bureau of Land Man-
6 agement are designated as the Frank Church/Greater Yel-
7 lowstone Corridor and shall be subject to the special cor-
8 ridor management requirements under section 203.

9 (l) FRENCH CREEK/HELLS CANYON CORRIDORS.—
10 Certain Federal lands comprising approximately 3,000
11 acres, as generally depicted on the map entitled
12 “_____” and dated _____, within the
13 Nez Perce-Clearwater National Forests or Payette Na-
14 tional Forest and land administered by the Cottonwood
15 Field Office of the Bureau of Land Management are des-
16 igned as the French Creek/Hells Canyon Corridor and
17 shall be subject to the special corridor management re-
18 quirements under section 203.

19 (m) LEMHI MOUNTAINS CORRIDORS.—Certain Fed-
20 eral lands comprising approximately 88,000 acres, as gen-
21 erally depicted on the map entitled “_____” and
22 dated _____, within the Caribou-Targhee or
23 Salmon-Challis National Forest and land administered by
24 the Upper Snake or Challis Field Office of the Bureau
25 of Land Management are designated as the Lemhi Moun-

1 tains Corridor and shall be subject to the special corridor
2 management requirements under section 203.

3 (n) LOST RIVER RANGE CORRIDORS.—Certain Fed-
4 eral lands comprising approximately 64,000 acres, as gen-
5 erally depicted on the map entitled “_____” and
6 dated _____, within the Salmon-Challis National
7 Forest and land administered by the Upper Snake or
8 Challis Field Office of the Bureau of Land Management
9 are designated as the Lost River Range Corridor and shall
10 be subject to the special corridor management require-
11 ments under section 203.

12 (o) FRANK CHURCH COMPLEX/LEMHI RANGE COR-
13 RIDORS.—Certain Federal lands comprising approximately
14 3,000 acres, as generally depicted on the map entitled
15 “_____” and dated _____, within the
16 Salmon-Challis National Forest and land administered by
17 the Challis Field Office of the Bureau of Land Manage-
18 ment are designated as the Frank Church Complex/Lemhi
19 Range Corridor and shall be subject to the special corridor
20 management requirements under section 203.

21 (p) BOULDER/WHITE CLOUDS/LOST RIVER RANGE
22 CORRIDORS.—Certain Federal lands comprising approxi-
23 mately 88,000 acres, as generally depicted on the map en-
24 titled “_____” and dated _____, within the
25 Salmon-Challis National Forest and land administered by

1 the Upper Snake or Challis Field Office of the Bureau
2 of Land Management are designated as the Boulder/White
3 Clouds/Lost River Range Corridor and shall be subject to
4 the special corridor management requirements under sec-
5 tion 203.

6 (q) BITTERROOT/LEMHI CORRIDORS.—Certain Fed-
7 eral lands comprising approximately 20,000 acres, as gen-
8 erally depicted on the map entitled “_____” and
9 dated _____, within the Salmon-Challis National
10 Forest and land administered by the Challis Field Office
11 of the Bureau of Land Management are designated as the
12 Frank Church Complex/Lemhi Range Corridor and shall
13 be subject to the special corridor management require-
14 ments under section 203.

15 (r) GREATER GLACIER/GREATER YELLOWSTONE
16 CORRIDORS.—Certain Federal lands comprising approxi-
17 mately 542,000 acres, as generally depicted on the map
18 entitled “_____” and dated _____, within
19 the Custer Gallatin, Helena or Lewis and Clark National
20 Forest and land administered by the Lewistown Field Of-
21 fice of the Bureau of Land Management are designated
22 as the Greater Glacier/Greater Yellowstone Corridor and
23 shall be subject to the special corridor management re-
24 quirements under section 203.

1 (s) MT. LEIDY HIGHLANDS/WIND RIVER RANGE
2 CORRIDORS.—Certain Federal lands comprising approxi-
3 mately 69,000 acres, as generally depicted on the map en-
4 titled “_____” and dated _____, within the
5 Bridger-Teton or Shoshone National Forest and land ad-
6 ministered by the Lewistown Field Office of the Bureau
7 of Land Management are designated as the Mt. Leidy
8 Highlands/Wind River Range Corridor and shall be sub-
9 ject to the special corridor management requirements
10 under section 203.

11 **SEC. 203. TREATMENT OF BIOLOGICAL CONNECTING COR-**
12 **RIDORS.**

13 Those portions of the biological connecting corridors
14 designated by section 202 are hereby designated as special
15 corridor management areas and shall be managed accord-
16 ing to the Multiple-Use Sustained-Yield Act of 1960 (16
17 U.S.C. 528 et seq.) and other applicable laws, and in the
18 following manner:

19 (1) The practice of even-aged silvicultural man-
20 agement and timber harvesting is prohibited within
21 the special corridor management areas.

22 (2) Subject to valid existing rights, mining, oil,
23 and gas exploration and development and new road
24 construction or reconstruction is prohibited within
25 the special corridor management areas.

1 (3) The Federal land management agency re-
2 sponsible for the administration of a special corridor
3 management area or portion thereof shall take im-
4 mediate steps to ensure that road densities within
5 the biological connecting corridor approach, as near-
6 ly as possible, zero miles of road per square mile of
7 land area. Such road density shall not exceed 0.25
8 miles per square mile, using the method known as
9 the “moving window” method.

10 **SEC. 204. APPLICABILITY OF TITLE.**

11 (a) FEDERAL LAND MANAGEMENT AGENCIES.—This
12 title shall apply only to National Forest System lands and
13 lands under the jurisdiction of the Bureau of Land Man-
14 agement and the United States Fish and Wildlife Service.

15 (b) PRIVATE LAND AND LANDOWNERS.—Private
16 lands are not affected by this title. No private landowner
17 whose lands are adjacent to the designated connecting cor-
18 ridors shall be compelled, under any circumstances, to
19 comply with this title. However, private landowners may
20 enter into cooperative agreements with the Federal Gov-
21 ernment on a willing participant or willing seller basis to
22 include their land in a biological connecting corridor.

1 **SEC. 205. COOPERATIVE AGREEMENTS AND LAND TRADES**
2 **AND ACQUISITIONS.**

3 (a) COOPERATIVE AGREEMENTS.—The Secretary of
4 the Interior and the Secretary of Agriculture shall seek
5 to enter into cooperative agreements with private, State,
6 and corporate landowners and sovereign Indian tribes
7 whose lands are adjacent to the designated connecting cor-
8 ridors, when such agreements would benefit the ecological
9 integrity and function of the designated corridor.

10 (b) LAND TRADES AND ACQUISITIONS.—The Sec-
11 retary of Agriculture and the Secretary of the Interior
12 may undertake land trades or acquisitions in order to ac-
13 complish the purposes of this title when the Secretary con-
14 cerned considers such action to be appropriate.

15 (c) REPORT.—As part of the report required by sec-
16 tion 501, the Secretary of Agriculture and the Secretary
17 of the Interior shall describe the progress of cooperative
18 agreements, acquisitions, and proposed land exchanges
19 sought pursuant to this section.

20 **SEC. 206. EXEMPTION OF CERTAIN ROADS AND HIGHWAYS.**

21 (a) EXEMPTION.—The roads and highways referred
22 to in subsection (b) are expressly exempted from the provi-
23 sions of this title. In the event that any county, State,
24 Federal, or private road has been mistakenly omitted from
25 this list, it is deemed to be incorporated by reference.

1 (b) DESCRIPTION.—The roads and highways referred
2 to in subsection (a) are the following:

3 (1) United States Highways 2, 10, 12, 20, 89,
4 91, 93, 95, and 287.

5 (2) Interstate Highways 15 and 90.

6 (3) Idaho State Highways 3, 28, 29, and 87.

7 (4) Montana State Highways 2, 37, 38, 41, 43,
8 56, 58, 83, 87, 135, 200, 278, 287, 293, 294, 298,
9 and 324.

10 (5) Montana Secondary Roads 92, 278, 279,
11 294, 298, 324, 411, and 508.

12 (6) The Thompson Pass Road, Montana-Idaho.

13 (7) The Moyie Springs to East Port Road,
14 Idaho.

15 (8) The Red Rock Pass Road, Montana.

16 (9) Boundary County, Idaho, Routes 3, 18, 34,
17 and 47.

18 (10) Lolo National Forest Route 102.

19 (11) Gallatin National Forest Route 259.

20 (12) Kelly Canyon and Middle Fork Canyon
21 Roads, Gallatin National Forest.

22 (13) Lewis and Clark County, Montana, Roads
23 4, 164, 280, 287, and 291.

24 (14) The Beaverhead-Deerlodge to Basin Road,
25 Montana.

1 (15) The Marysville to Avon Road, Montana.

2 (16) The Pahsimeroi Road, Butte County,
3 Idaho.

4 **TITLE III—WILD AND SCENIC**
5 **RIVERS DESIGNATIONS**

6 **SEC. 301. DESIGNATION OF WILD AND SCENIC RIVERS IN**
7 **IDAHO, MONTANA, AND WYOMING.**

8 Section 3(a) of the Wild and Scenic Rivers Act (16
9 U.S.C. 1274(a)) is amended by adding at the end the fol-
10 lowing new paragraphs:

11 “(213) SOUTH FORK PAYETTE, IDAHO.—The seg-
12 ment within the Boise and Sawtooth National Forests
13 from the Sawtooth Wilderness Boundary downstream ap-
14 proximately 54 miles to confluence with the Middle Fork
15 and then downstream on the main stem to the confluence
16 with the North Fork, as generally depicted on the bound-
17 ary map entitled ‘South Fork Payette Wild River’ and
18 dated January 2003, which shall be administered by the
19 Secretary of Agriculture.

20 “(214) MIDDLE FORK PAYETTE, IDAHO.—The seg-
21 ment within the Boise National Forest from Railroad Pass
22 downstream approximately 33 miles to the national forest
23 boundary, which shall be administered by the Secretary
24 of Agriculture.

1 “(215) DEADWOOD, IDAHO.—The segment within
2 the Boise National Forest comprising from Threemile
3 Creek downstream approximately 22 miles to the South
4 Fork of the Payette, which shall be administered by the
5 Secretary of Agriculture.

6 “(216) UPPER PRIEST, IDAHO.—The segment within
7 the Panhandle National Forest from the Canadian border
8 downstream approximately 19 miles to Upper Priest Lake,
9 which shall be administered by the Secretary of Agri-
10 culture.

11 “(217) COEUR D’ALENE, IDAHO.—The segment
12 within the Panhandle National Forest from the head-
13 waters downstream approximately 58 miles to the national
14 forest boundary, which shall be administered by the Sec-
15 retary of Agriculture.

16 “(218) LITTLE NORTH FORK CLEARWATER,
17 IDAHO.—The segment within the Idaho Panhandle Na-
18 tional Forest and the Nez Perce-Clearwater National For-
19 ests from the headwaters downstream approximately 37
20 miles to the National Forest boundary, which shall be ad-
21 ministered by the Secretary of Agriculture.

22 “(219) KELLY CREEK, IDAHO.—The segment within
23 the Nez Perce-Clearwater National Forests from its head-
24 waters downstream approximately 31 miles to the North

1 Fork of the Clearwater River, which shall be administered
2 by the Secretary of Agriculture.

3 “(220) CAYUSE CREEK, IDAHO.—The segment with-
4 in the Nez Perce-Clearwater National Forests from its
5 headwaters downstream approximately 39 miles to the
6 confluence of Kelly Creek, which shall be administered by
7 the Secretary of Agriculture.

8 “(221) BARGAMIN CREEK, IDAHO.—The segment
9 within the Nez Perce-Clearwater National Forests, com-
10 prising approximately 21 miles, which shall be adminis-
11 tered by the Secretary of Agriculture.

12 “(222) LAKE CREEK, IDAHO.—The segment within
13 the Nez Perce-Clearwater National Forests from the wil-
14 derness boundary downstream approximately 10 miles to
15 Crooked Creek, which shall be administered by the Sec-
16 retary of Agriculture.

17 “(223) MEADOW CREEK, IDAHO.—The segment
18 within the Nez Perce-Clearwater National Forests from
19 its headwaters downstream approximately 34 miles to its
20 confluence with the Selway River, which shall be adminis-
21 tered by the Secretary of Agriculture.

22 “(224) RUNNING CREEK, IDAHO.—The segment
23 within the Nez Perce-Clearwater National Forests com-
24 prising approximately 20 miles, which shall be adminis-
25 tered by the Secretary of Agriculture.

1 “(225) SALMON, IDAHO.—

2 “(A) VINEGAR CREEK.—The segment within
3 the Nez Perce-Clearwater National Forests and
4 Payette National Forest from Vinegar Creek down-
5 stream approximately 25 miles to the Little Salmon
6 River, which shall be administered by the Secretary
7 of Agriculture.

8 “(B) SALMON.—The segment on public lands
9 managed by the Bureau of Land Management from
10 Hammer Creek downstream approximately 45 miles
11 to the confluence with the Snake River, which shall
12 be administered by the Secretary of the Interior.

13 “(C) SALMON.—The segment on public lands
14 within the Sawtooth National Recreation Area from
15 its headwaters downstream approximately 60 miles
16 to the recreation area boundary, which shall be ad-
17 ministered by the Secretary of Agriculture.

18 “(226) EAST FORK SALMON, IDAHO.—The segment
19 within the Sawtooth National Recreation Area from the
20 headwaters downstream approximately 42 miles to the
21 recreation area boundary, which shall be administered by
22 the Secretary of Agriculture.

23 “(227) NORTH FORK CLEARWATER, IDAHO.—The
24 segment within the Nez Perce-Clearwater National For-
25 ests from the headwaters downstream to the Dworkshak

1 Reservoir, which shall be administered by the Secretary
2 of Agriculture.

3 “(228) NORTH FORK COEUR D’ALENE, IDAHO.—
4 The segment within the Panhandle National Forest from
5 its headwaters south of Honey Mountain downstream to
6 its confluence with the Coeur d’Alene River which shall
7 be administered by the Secretary of Agriculture.

8 “(229) PACK, IDAHO.—The segment within the Pan-
9 handle National Forest from Harrison Lake downstream
10 approximately 14 miles to the national forest boundary,
11 which shall be administered by the Secretary of Agri-
12 culture.

13 “(230) HENRY’S FORK, IDAHO.—The segment with-
14 in the Caribou-Targhee National Forest from Big Springs
15 downstream to the national forest boundary, except for Is-
16 land Park Reservoir, which shall be administered by the
17 Secretary of Agriculture.

18 “(231) FALLS RIVER, IDAHO.—The segment within
19 the Caribou-Targhee National Forest from Yellowstone
20 National Park downstream approximately 13 miles to the
21 National Forest Boundary, which shall be administered by
22 the Secretary of Agriculture as a wild river.

23 “(232) LOCHSA RIVER WATERSHED, IDAHO.—The
24 segment within the Nez Perce-Clearwater National For-
25 ests of the Lochsa River from the confluence of Colt Killed

1 Creek and Crooked Fork downstream approximately 2
2 miles to the beginning of the Lochsa Recreational River,
3 which shall be administered by the Secretary of Agri-
4 culture.

5 “(233) COLT KILLED CREEK, IDAHO.—The segment
6 within the Nez Perce-Clearwater National Forests from
7 its headwaters at Big Sand Lake downstream approxi-
8 mately 23 miles to its confluence with Crooked Fork,
9 which shall be administered by the Secretary of Agri-
10 culture.

11 “(234) MOOSE CREEK COMPLEX, IDAHO.—The main
12 segment, including the North Fork segment, the East
13 Fork segment, the West Moose segment, and the Rhoda
14 Creek segment comprising approximately 86 miles within
15 the Nez Perce-Clearwater National Forests, which shall
16 be administered by the Secretary of Agriculture.

17 “(235) BEAR CREEK COMPLEX, IDAHO.—The Bear
18 Creek segment, the Club Creek segment, the Paradise
19 Creek segment, the Brushy Fork Creek segment, and the
20 Wahoo Creek segment comprising approximately 70 miles
21 within the Nez Perce-Clearwater National Forests, which
22 shall be administered by the Secretary of Agriculture.

23 “(236) THREE LINKS CREEK COMPLEX, IDAHO.—
24 The Three Links Creek segment and the West Fork Three
25 Links Creek segment comprising approximately 23 miles

1 within the Nez Perce-Clearwater National Forests, which
2 shall be administered by the Secretary of Agriculture.

3 “(237) GEDNEY CREEK, IDAHO.—The segment with-
4 in the Nez Perce-Clearwater National Forests from its
5 headwaters downstream approximately 14.5 to the con-
6 fluence the Selway River, which shall be administered by
7 the Secretary of Agriculture.

8 “(238) SOUTH FORK CLEARWATER, IDAHO.—The
9 segment within the Nez Perce-Clearwater National For-
10 ests from the confluence of the Red and American Rivers
11 downstream to the Forest boundary, comprising approxi-
12 mately 40 miles, which shall be administered by the Sec-
13 retary of Agriculture.

14 “(239) JOHNS CREEK, IDAHO.—The segment within
15 the Nez Perce-Clearwater National Forests from the head-
16 waters downstream to its confluence with the South Fork
17 Clearwater, which shall be administered by the Secretary
18 of Agriculture.

19 “(240) SLATE CREEK, IDAHO.—The segment within
20 the Nez Perce-Clearwater National Forests from the head-
21 waters downstream the source approximately 15 miles to
22 the forest boundary, which shall be administered by the
23 Secretary of Agriculture.

24 “(241) SOUTH FORK TWO MEDICINE RIVER, MON-
25 TANA.—The segment within the Lewis and Clark National

1 Forest from its headwaters downstream approximately 10
2 miles to the Sawmill Flat Trailhead, which shall be admin-
3 istered by the Secretary of Agriculture.

4 “(242) BADGER CREEK, INCLUDING THE SOUTH
5 AND NORTH FORKS, MONTANA.—The segment within the
6 Lewis and Clark National Forest from its headwaters
7 downstream approximately 24 miles to the national forest
8 boundary, which shall be administered by the Secretary
9 of Agriculture.

10 “(243) DEARBORN, MONTANA.—The segment within
11 the Lewis and Clark National Forest downstream approxi-
12 mately 19 miles to the national forest boundary, which
13 shall be administered by the Secretary of Agriculture.

14 “(244) NORTH FORK BIRCH CREEK, MONTANA.—
15 The segment within the Lewis and Clark National Forest
16 from its headwaters downstream approximately 7 miles to
17 the national forest boundary, which shall be administered
18 by the Secretary of Agriculture.

19 “(245) SOUTH FORK SUN, MONTANA.—The segment
20 within the Lewis and Clark National Forest from its head-
21 waters at Sun Lake downstream approximately 26 miles
22 to its confluence with the North Fork, which shall be ad-
23 ministered by the Secretary of Agriculture.

24 “(246) NORTH FORK SUN, MONTANA.—The segment
25 within the Lewis and Clark National Forest from the con-

1 fluence of Open Creek and Fool Creek downstream ap-
2 proximately 27 miles, which shall be administered by the
3 Secretary of Agriculture.

4 “(247) TENDERFOOT CREEK, MONTANA.—The seg-
5 ment within the Lewis and Clark National Forest from
6 the top of Tenderfoot Creek Falls downstream approxi-
7 mately 5 miles to the Smith River, which shall be adminis-
8 tered by the Secretary of Agriculture.

9 “(248) GREEN FORK STRAIGHT CREEK, MON-
10 TANA.—The segment within the Lewis and Clark National
11 Forest from its headwaters downstream approximately 5
12 miles to Straight Creek, which shall be administered by
13 the Secretary of Agriculture.

14 “(249) YAAK RIVER, MONTANA.—The segment with-
15 in the Kootenai National Forest from the Yaak Falls
16 downstream 46 miles to the mouth of the Yaak River at
17 the junction of the Kootenai River, which shall be adminis-
18 tered by the Secretary of Agriculture.

19 “(250) KOOTENAI RIVER, MONTANA.—The segment
20 within the Kootenai National Forest from the junction of
21 the Fisher River downstream approximately 46 miles to
22 the State line, which shall be administered by the Sec-
23 retary of Agriculture.

24 “(251) BULL RIVER, MONTANA.—The segment with-
25 in the Kootenai National Forest from the junction of the

1 North and South Forks downstream 21 miles to the Cabi-
2 net Gorge Reservoir, which shall be administered by the
3 Secretary of Agriculture.

4 “(252) VERMILLION RIVER, MONTANA.—The seg-
5 ment within the Kootenai National Forest from the junc-
6 tion of Willow Creek, downstream 12 miles to the Noxon
7 Reservoir, which shall be administered by the Secretary
8 of Agriculture.

9 “(253) WEST FORK MADISON, MONTANA.—The seg-
10 ment within the Beaverhead-Deerlodge National Forest
11 from approximately the midpoint of Section 28, R. 2 W.,
12 T. 12 S., downstream approximately 21 miles to the West
13 Fork Rest Area, which shall be administered by the Sec-
14 retary of Agriculture.

15 “(254) ELK RIVER, MONTANA.—The segment within
16 the Beaverhead-Deerlodge National Forest in the south-
17 east corner of Section 16, R. 2 W., T. 11 S., downstream
18 approximately 17 miles to the confluence with the West
19 Fork of the Madison River, which shall be administered
20 by the Secretary of Agriculture.

21 “(255) BROWNS CREEK, MONTANA.—The segment
22 within the Beaverhead-Deerlodge National Forest from
23 the west central part of Section 1, R. 14 W., T. 8 S.,
24 downstream approximately 4 miles to the forest boundary,

1 which shall be administered by the Secretary of Agri-
2 culture.

3 “(256) CANYON CREEK, MONTANA.—The segment
4 within the Beaverhead-Deerlodge National Forest from
5 Canyon Lake downstream approximately 4 miles to the
6 end of USFS road 7401, which shall be administered by
7 the Secretary of Agriculture.

8 “(257) DEADMAN CREEK, MONTANA.—The segment
9 within the Beaverhead-Deerlodge National Forest from its
10 headwaters source downstream approximately 10 miles to
11 the forest boundary, which shall be administered by the
12 Secretary of Agriculture.

13 “(258) SMITH RIVER, MONTANA.—The segment
14 within the Lewis and Clark National Forest from Tender-
15 foot Creek downstream approximately 12 miles to Deep
16 Creek, which shall be administered by the Secretary of Ag-
17 riculture.

18 “(259) MIDDLE FORK JUDITH RIVER, MONTANA.—
19 The segment within the Lewis and Clark National Forest
20 from Arch Coulee Junction downstream approximately 5
21 miles to the national forest boundary, which shall be ad-
22 ministered by the Secretary of Agriculture.

23 “(260) ROCK CREEK WATERSHED, MONTANA.—The
24 segments within the Lolo and Beaverhead-Deerlodge Na-
25 tional Forests including the main fork of Rock Creek, the

1 West Fork of Rock Creek, the East Fork of Rock Creek,
2 the Ross Fork of Rock Creek, the Middle Fork of Rock
3 Creek, the Carpp Creek segment, the Copper Creek seg-
4 ment, the Ranch Creek segment, the Welcome Creek seg-
5 ment, the Alder Creek segment, the Hogback Creek seg-
6 ment, the Wyman Gulch segment, the Stony Creek seg-
7 ment, the West Fork segment, and the Ross Fork seg-
8 ment, comprising approximately 134 miles, which shall be
9 administered by the Secretary of Agriculture.

10 “(261) SALT RIVER, WYOMING.—The segment with-
11 in the Bridger-Teton National Forest from the headwaters
12 downstream approximately 12 miles to forest road 10072,
13 which shall be administered by the Secretary of Agri-
14 culture.

15 “(262) SWIFT CREEK, WYOMING.—The segment
16 within the Bridger-Teton National Forest from the source
17 downstream approximately 8 miles to Periodic Spring,
18 which shall be administered by the Secretary of Agri-
19 culture.

20 “(263) HOBACK RIVER, WYOMING.—The segment
21 within the Bridger-Teton National Forest from the source
22 downstream approximately 10 miles to the end of forest
23 road 30710, which shall be administered by the Secretary
24 of Agriculture.

1 “(264) THOROFARE, WYOMING.—The segment of the
2 main stem within the Bridger-Teton National Forest from
3 the headwaters downstream approximately 25 miles to the
4 confluence with the Yellowstone River, and the headwaters
5 of Open Creek downstream 10 miles to the confluence with
6 the main stem, which shall be administered by the Sec-
7 retary of Agriculture.

8 “(265) ATLANTIC CREEK, WYOMING.—The segment
9 within the Bridger-Teton National Forest from the Part-
10 ing of the Waters downstream approximately 10 miles to
11 the confluence with the Yellowstone River, which shall be
12 administered by the Secretary of Agriculture.

13 “(266) YELLOWSTONE, WYOMING.—The segment
14 within the Bridger-Teton National Forest from the head-
15 water downstream approximately 28 miles to the boundary
16 of Yellowstone National Park, which shall be administered
17 by the Secretary of Agriculture.

18 “(267) YELLOWSTONE RIVER, WYOMING AND MON-
19 TANA.—The segment within the Custer Gallatin National
20 Forest and Yellowstone National Park from the southern
21 boundary of Yellowstone National Park downstream ap-
22 proximately 102 miles to the mouth of Yankee Jim can-
23 yon, which shall be administered by the Secretaries of the
24 Interior and Agriculture.”.

1 **TITLE IV—WILDLAND**
2 **RESTORATION AND RECOVERY**

3 **SEC. 401. DEFINITIONS.**

4 In this title:

5 (1) **RECOVERY.**—The term “recovery” means
6 the restoration of lands damaged by land manage-
7 ment activities to a natural untrammelled condition
8 and the restoration of the undeveloped roadless
9 character of such land.

10 (2) **RECOVERY SYSTEM.**—The term “Recovery
11 System” means the National Wildland Restoration
12 and Recovery System.

13 **SEC. 402. RESTORATION AND RECOVERY.**

14 (a) **RECOVERY AREAS.**—The following areas, con-
15 sisting of a total of approximately 1,023,000 acres, as de-
16 picted on the maps dated _____ and entitled “_____”, are
17 designated as wildland recovery areas:

18 (1) Skyland area, consisting of approximately
19 10,000 acres administered by the Flathead National
20 Forest.

21 (2) Hungry Horse area (except Hungry Horse
22 Dam and Reservoir), consisting of approximately
23 205,000 acres administered by the Flathead Na-
24 tional Forest.

1 (3) Lolo Creek area, consisting of approxi-
2 mately 59,000 acres administered by the Lolo or
3 Clearwater National Forest.

4 (4) Yellowstone West area, consisting of ap-
5 proximately 164,000 acres administered by the Car-
6 ibou-Targhee National Forest.

7 (5) Mt. Leidy area, consisting of approximately
8 70,000 acres administered by the Bridger-Teton Na-
9 tional Forest.

10 (6) Cabinet/Yaak area, consisting of approxi-
11 mately 100,000 acres administered by the Kootenai
12 National Forest.

13 (7) Lightning Creek area, consisting of approxi-
14 mately 31,000 acres administered by the Panhandle
15 National Forest.

16 (8) Coeur d'Alene River area, consisting of ap-
17 proximately 372,000 acres administered by the Pan-
18 handle National Forest.

19 (9) Magruder Corridor area, consisting of ap-
20 proximately 12,000 acres administered by the Nez
21 Perce or Bitterroot National Forest.

22 (b) EXEMPTION.—The roads and highways and fa-
23 cilities referred to below are expressly exempted from the
24 provisions of this title: All private, county, State, or Fed-
25 eral roads, including National Forest System roads, ac-

1 censing existing authorized uses and any facilities such as
2 a developed campground, ranger station, or other facilities
3 deemed essential by the Forest Service.

4 (c) MAGRUDER CORRIDOR AREA.—Notwithstanding
5 subsection (b) of this section, the Secretary of Agriculture
6 will recommend recovery and restoration on the part of
7 the Magruder Corridor between Magruder Crossing and
8 Dry Saddle under plans developed under section 403 of
9 this title.

10 (d) Notwithstanding subsection (b) of this section,
11 the Secretary of Agriculture may recommend recovery and
12 restoration of any National Forest System road or Forest
13 Service development or facility in any recovery area and
14 the entire Magruder Corridor under plans developed under
15 section 403 of this title.

16 **SEC. 403. MANAGEMENT.**

17 (a) RESTORATION.—All lands within the Recovery
18 Areas described in section 402(a) shall be managed so as
19 to restore their native vegetative cover and reduce or elimi-
20 nate invasive non-native species, facilitate native species
21 diversity to the extent possible with climate change, sta-
22 bilize slopes and soils to prevent or reduce further erosion,
23 recontour slopes to their original contours, remove barriers
24 to natural fish spawning runs, and generally restore such

1 lands in their entirety to a natural roadless and wild con-
2 dition.

3 (b) WATER QUALITY RESTORATION.—In the man-
4 agement of the Recovery Areas, special consideration shall
5 be given to restoration of water quality in the Recovery
6 Area.

7 (c) RECOVERY PLANS.—Not later than three years
8 after the date of the enactment of this Act, the Secretary
9 shall develop a wildland recovery plan for each Recovery
10 Area. Each recovery plan shall detail necessary work and
11 funding requirements needed to implement the manage-
12 ment direction established under this section.

13 (d) EVALUATION.—The Secretary shall use measur-
14 able criteria to judge the success of recovery efforts taken
15 pursuant to this section.

16 **TITLE V—IMPLEMENTATION** 17 **AND MONITORING**

18 **SEC. 501. IMPLEMENTATION REPORT.**

19 (a) REPORT REQUIRED.—Within three years after
20 the date of the enactment of this Act, the Secretary of
21 Agriculture and the Secretary of the Interior shall jointly
22 submit to the Committee on Energy and Natural Re-
23 sources of the Senate and the Committee on Natural Re-
24 sources of the House of Representatives a report that de-
25 tails the implementation of this Act. The report shall also

1 detail any additional work and funding requirements nec-
2 essary to achieve the purposes of this Act.

3 (b) PREPARATION.—The report shall be produced by
4 a panel of independent scientists appointed by the Na-
5 tional Academy of Sciences, in consultation with the Soci-
6 ety for Conservation Biology.

7 **SEC. 502. INTERAGENCY TEAM.**

8 (a) ESTABLISHMENT.—The Secretary of Agriculture
9 and the Secretary of the Interior shall jointly establish an
10 interagency team, containing equal numbers of partici-
11 pants from the public and private sectors, to monitor,
12 evaluate, and make recommendations to ensure long-term
13 results required by this Act.

14 (b) GEOGRAPHIC INFORMATION SYSTEM.—

15 (1) DEVELOPMENT.—The interagency team
16 shall develop a geographic information system for
17 monitoring the Northern Rockies Bioregion. The ge-
18 ographic information system shall be based on sat-
19 ellite-gathered data and shall include comprehensive
20 maps and databases to assist in the detection of
21 changes in the Northern Rockies Bioregion.

22 (2) TYPES OF INFORMATION.—The maps and
23 databases included in the geographic information
24 system shall be updated periodically to record the
25 following:

1 (A) Vegetation cover (with species occur-
2 rence and densities).

3 (B) Human impacts.

4 (C) Water and air quality.

5 (D) Activities that bear on forest hus-
6 bandry and restoration.

7 (3) STATUS REPORTS.—The geographic infor-
8 mation system shall include status reports on the
9 progress of ecosystem protection, corridor consolida-
10 tion, and forest recovery efforts and reports on the
11 status of threatened and endangered species which
12 are primary indicators of ecosystem health.

13 (c) WILDLIFE MOVEMENTS.—The interagency team
14 shall assess the potential for facilitating wildlife move-
15 ments across or under major highways and rail lines with-
16 in the biological corridors established in title II. This as-
17 sessment shall identify major crossing points and identify
18 possible management actions to enhance the suitability of
19 such crossing points as movement corridors, including
20 underpasses, overpasses, and other methods for reducing
21 the danger to native wildlife while facilitating movements
22 within the Northern Rockies Bioregion.

23 **SEC. 503. ROADLESS LANDS EVALUATION.**

24 (a) EVALUATION REQUIRED.—Roadless lands great-
25 er than 1,000 acres in size, that are located within the

1 National Forest System in the Wild Rockies Bioregion in
2 Idaho, Montana, Oregon, Washington, or Wyoming, and
3 that are not designated as components of the National
4 Wilderness Preservation System (under this Act or any
5 other law) shall be identified and evaluated by the panel
6 of independent scientists appointed under section 501. In
7 identifying and evaluating these lands, the panel shall
8 make use of existing satellite information and Geographic
9 Information System data developed by the Forest Service,
10 the Bureau of Land Management, and the United States
11 Fish and Wildlife Service, in addition to other information
12 sources. The panel shall study the role of such lands in
13 maintaining biological diversity in the Northern Rockies
14 and as part of the overall forest reserve system. The panel
15 shall make recommendations regarding the management
16 of the lands, and shall include the recommendations in the
17 report required by section 501.

18 (b) PROHIBITION.—After completion of the evalua-
19 tion required by subsection (a), until Congress enacts a
20 law stating otherwise, no new road construction or recon-
21 struction, or timber harvest (except firewood gathering)
22 shall be allowed in the lands described in subsection (a).
23 In addition, subject to valid existing rights, no oil or gas
24 leasing, mining, or other development which impairs the

1 natural and roadless qualities of these lands shall be al-
2 lowed on the lands.

3 **TITLE VI—ADDITIONAL PROVI-**
4 **SIONS REGARDING INDIAN**
5 **TRIBES**

6 **SEC. 601. INDIAN TRIBES.**

7 Nothing in this Act may be construed to affect or
8 modify any treaty or other right of an Indian tribe.

9 **SEC. 602. FEDERAL TRUST RESPONSIBILITY.**

10 Nothing in this Act is intended to amend, alter, or
11 give priority over the Federal trust responsibility to Indian
12 tribes.

13 **SEC. 603. EXEMPTION FROM FREEDOM OF INFORMATION**
14 **ACT.**

15 If a Federal department or agency receives any infor-
16 mation related to sacred sites or cultural activities identi-
17 fied by an Indian tribe as confidential, such information
18 shall be exempt from disclosure under section 552 of title
19 5, United States Code, popularly known as the Freedom
20 of Information Act (5 U.S.C. 552).

21 **SEC. 604. APPLICATION OF INDIAN SELF-DETERMINATION**
22 **AND EDUCATION ASSISTANCE ACT.**

23 The Secretary of the Interior may apply the provi-
24 sions of the Indian Self-Determination and Education As-

1 sistance Act (25 U.S.C. 450 et seq.; Public Law 93–638)
2 when appropriate in the implementation of this Act.

3 **SEC. 605. NATIVE AMERICAN USES.**

4 (a) DEFINITION.—For purposes of this section and
5 section 505, the term “protected areas” means land des-
6 ignated by this Act as wilderness, wildland recovery areas,
7 wild and scenic rivers, and biological corridors.

8 (b) NONEXCLUSIVE ACCESS.—In recognition of the
9 past use of portions of the protected areas by Native
10 Americans for traditional cultural and religious purposes,
11 the Secretary of Agriculture and the Secretary of the Inte-
12 rior shall ensure nonexclusive access to these protected
13 areas by native people for such traditional cultural and
14 religious purposes. Such access shall be consistent with the
15 purpose and intent of Public Law 95–341 (42 U.S.C.
16 1996; commonly known as the American Indian Religious
17 Freedom Act), and, in the case of land designated as wil-
18 derness by this Act, the Wilderness Act (16 U.S.C. 1121
19 et seq.). The Secretaries, in accordance with such laws,
20 upon request of an Indian tribe, may from time-to-time
21 temporarily close to the general public use of one or more
22 specific portions of these protected areas in order to pro-
23 tect the privacy of religious activities and cultural uses in
24 such portions by an Indian people. As part of the prepara-
25 tion of general management plans for the protected areas,

1 the Secretaries shall request that the chief executive offi-
2 cers of appropriate Indian tribes make recommendations
3 with respect to assuring access to important sites, enhanc-
4 ing the privacy of traditional cultural and religious activi-
5 ties, and protecting cultural and religious sites.

6 **TITLE VII—RULES OF**
7 **CONSTRUCTION**

8 **SEC. 701. WATER RIGHTS.**

9 Nothing in this Act may be construed as a relinquish-
10 ment or reduction of any water rights reserved, appro-
11 priated, or otherwise secured by the United States in the
12 State of Idaho, Montana, Wyoming, Oregon, or Wash-
13 ington on or before the date of enactment of this Act.
