Ms. FOXX, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 1735) to authorize appropriations for fiscal year 2016 for military activities of the Department of Defense and for military construction, to prescribe military personnel strengths for such fiscal year, and for other purposes; providing for consideration of the bill (H.R. 36) to amend title 18,

United States Code, to protect pain-capable unborn children, and for other purposes; providing for consideration of the bill (H.R. 2048) to reform the authorities of the Federal Government to require the production of certain business records, conduct electronic surveillance, use pen registers and trap and trace devices, and use other forms of information gathering for foreign intelligence, counterterrorism, and criminal purposes, and for other purposes; and providing for consideration of motions to suspend the rules.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 1735) to authorize appropriations
6 for fiscal year 2016 for military activities of the Depart-
7 ment of Defense and for military construction, to prescribe
8 military personnel strengths for such fiscal year, and for
9 other purposes. The first reading of the bill shall be dis-
10 pensed with. All points of order against consideration of
11 the bill are waived. General debate shall be confined to
12 the bill and shall not exceed one hour equally divided and
13 controlled by the chair and ranking minority member of
14 the Committee on Armed Services. After general debate,
15 the Committee of the Whole shall rise without motion. No
16 further consideration of the bill shall be in order except
17 pursuant to a subsequent order of the House.

1 SEC. 2. Upon adoption of this resolution it shall be
2 in order to consider in the House the bill (H.R. 36) to
3 amend title 18, United States Code, to protect pain-capable
4 unborn children, and for other purposes. All points of
5 order against consideration of the bill are waived. The
6 amendment in the nature of a substitute printed in part
7 A of the report of the Committee on Rules accompanying
8 this resolution shall be considered as adopted. The bill,
9 as amended, shall be considered as read. All points of
10 order against provisions in the bill, as amended, are
11 waived. The previous question shall be considered as ordered
12 on the bill, as amended, and on any further amendment
13 thereto, to final passage without intervening motion
14 except: (1) one hour of debate equally divided and controlled
15 by the chair and ranking minority member of the
16 Committee on the Judiciary or their respective designees;
17 and (2) one motion to recommit with or without instructions.

19 SEC. 3. Upon adoption of this resolution it shall be
20 in order to consider in the House the bill (H.R. 2048)
21 to reform the authorities of the Federal Government to
22 require the production of certain business records, conduct
23 electronic surveillance, use pen registers and trap and
24 trace devices, and use other forms of information gathering
25 for foreign intelligence, counterterrorism, and crimi-

1 nal purposes, and for other purposes. All points of order
2 against consideration of the bill are waived. The amend-
3 ment printed in part B of the report of the Committee
4 on Rules accompanying this resolution shall be considered
5 as adopted. The bill, as amended, shall be considered as
6 read. All points of order against provisions in the bill, as
7 amended, are waived. The previous question shall be con-
8 sidered as ordered on the bill, as amended, and on any
9 further amendment thereto, to final passage without inter-
10 vening motion except: (1) one hour of debate equally di-
11 vided and controlled by the chair and ranking minority
12 member of the Committee on the Judiciary; and (2) one
13 motion to recommit with or without instructions.

14 SEC. 4. It shall be in order at any time on the legisla-
15 tive day of May 14, 2015, or May 15, 2015, for the Speak-
16 er to entertain motions that the House suspend the rules
17 as though under clause 1 of rule XV. The Speaker or his
18 designee shall consult with the Minority Leader or her des-
19 ignee on the designation of any matter for consideration
20 pursuant to this section.
