Mr. SESSIONS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 37) to make technical corrections to the Dodd-Frank Wall Street Reform and Consumer Protection Act, to enhance the ability of small and emerging growth companies to access capital through public and private markets, to reduce regulatory burdens, and for other purposes; providing for consideration of the bill (H.R. 185) to reform the

process by which Federal agencies analyze and formulate new regulations and guidance documents; and providing for consideration of the bill (H.R. 240) making appropriations for the Department of Homeland Security for the fiscal year ending September 30, 2015, and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 37) to make technical corrections to the Dodd-Frank Wall  
4 Street Reform and Consumer Protection Act, to enhance  
5 the ability of small and emerging growth companies to ac-  
6 cess capital through public and private markets, to reduce  
7 regulatory burdens, and for other purposes. All points of  
8 order against consideration of the bill are waived. The bill  
9 shall be considered as read. All points of order against  
10 provisions in the bill are waived. The previous question  
11 shall be considered as ordered on the bill and on any  
12 amendment thereto to final passage without intervening  
13 motion except: (1) one hour of debate equally divided and  
14 controlled by the chair and ranking minority member of  
15 the Committee on Financial Services; and (2) one motion  
16 to recommit.

17       SEC. 2. At any time after adoption of this resolution  
18 the Speaker may, pursuant to clause 2(b) of rule XVIII,  
19 declare the House resolved into the Committee of the  
20 Whole House on the state of the Union for consideration

1 of the bill (H.R. 185) to reform the process by which Fed-  
2 eral agencies analyze and formulate new regulations and  
3 guidance documents. The first reading of the bill shall be  
4 dispensed with. All points of order against consideration  
5 of the bill are waived. General debate shall be confined  
6 to the bill and shall not exceed one hour equally divided  
7 and controlled by the chair and ranking minority member  
8 of the Committee on the Judiciary. After general debate  
9 the bill shall be considered for amendment under the five-  
10 minute rule. The bill shall be considered as read. All points  
11 of order against provisions in the bill are waived. No  
12 amendment to the bill shall be in order except those print-  
13 ed in part A of the report of the Committee on Rules ac-  
14 companying this resolution. Each such amendment may  
15 be offered only in the order printed in the report, may  
16 be offered only by a Member designated in the report,  
17 shall be considered as read, shall be debatable for the time  
18 specified in the report equally divided and controlled by  
19 the proponent and an opponent, shall not be subject to  
20 amendment, and shall not be subject to a demand for divi-  
21 sion of the question in the House or in the Committee  
22 of the Whole. All points of order against such amendments  
23 are waived. At the conclusion of consideration of the bill  
24 for amendment the Committee shall rise and report the  
25 bill to the House with such amendments as may have been

1 adopted. The previous question shall be considered as or-  
2 dered on the bill and amendments thereto to final passage  
3 without intervening motion except one motion to recommit  
4 with or without instructions.

5       SEC. 3. At any time after adoption of this resolution  
6 the Speaker may, pursuant to clause 2(b) of rule XVIII,  
7 declare the House resolved into the Committee of the  
8 Whole House on the state of the Union for consideration  
9 of the bill (H.R. 240) making appropriations for the De-  
10 partment of Homeland Security for the fiscal year ending  
11 September 30, 2015, and for other purposes. The first  
12 reading of the bill shall be dispensed with. All points of  
13 order against consideration of the bill are waived. General  
14 debate shall be confined to the bill and shall not exceed  
15 two hours equally divided and controlled by the chair and  
16 ranking minority member of the Committee on Appropria-  
17 tions. After general debate the bill shall be considered for  
18 amendment under the five-minute rule. The bill shall be  
19 considered as read. All points of order against provisions  
20 in the bill are waived. No amendment to the bill shall be  
21 in order except those printed in part B of the report of  
22 the Committee on Rules accompanying this resolution.  
23 Each such amendment may be offered only in the order  
24 printed in the report, may be offered only by a Member  
25 designated in the report, shall be considered as read, shall

1 be debatable for the time specified in the report equally  
2 divided and controlled by the proponent and an opponent,  
3 shall not be subject to amendment, and shall not be sub-  
4 ject to a demand for division of the question in the House  
5 or in the Committee of the Whole. All points of order  
6 against such amendments are waived. At the conclusion  
7 of consideration of the bill for amendment the Committee  
8 shall rise and report the bill to the House with such  
9 amendments as may have been adopted. The previous  
10 question shall be considered as ordered on the bill and  
11 amendments thereto to final passage without intervening  
12 motion except one motion to recommit with or without in-  
13 structions.

14       SEC. 4. The chair of the Committee on Appropria-  
15 tions may insert in the Congressional Record not later  
16 than January 14, 2015, such material as he may deem  
17 explanatory of H.R. 240.
