# RESOLUTION

Providing for consideration of the Senate amendment to the bill (H.R. 2028) making appropriations for energy and water development and related agencies for the fiscal year ending September 30, 2016, and for other purposes, and providing for consideration of the bill (S. 612) to designate the Federal building and United States courthouse located at 1300 Victoria Street in Laredo, Texas, as the “George P. Kazen Federal Building and United States Courthouse”.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to take from the Speaker’s table the bill  
3 (H.R. 2028) making appropriations for energy and water  
4 development and related agencies for the fiscal year end-  
5 ing September 30, 2016, and for other purposes, with the  
6 Senate amendment thereto, and to consider in the House,  
7 without intervention of any point of order, a motion of-  
8 fered by the chair of the Committee on Appropriations or  
9 his designee that the House concur in the Senate amend-  
10 ment with an amendment consisting of the text of Rules  
11 Committee Print 114-70 modified by the amendment  
12 printed in the report of the Committee on Rules accom-  
13 panying this resolution. The Senate amendment and the  
14 motion shall be considered as read. The motion shall be  
15 debatable for one hour equally divided and controlled by  
16 the chair and ranking minority member of the Committee  
17 on Appropriations. The previous question shall be consid-  
18 ered as ordered on the motion to its adoption without in-  
19 tervening motion.

20       SEC. 2. Upon adoption of this resolution it shall be  
21 in order to consider in the House the bill (S. 612) to des-  
22 ignate the Federal building and United States courthouse  
23 located at 1300 Victoria Street in Laredo, Texas, as the  
24 “George P. Kazen Federal Building and United States  
25 Courthouse”. All points of order against consideration of

1 the bill are waived. An amendment in the nature of a sub-  
2 stitute consisting of the text of Rules Committee Print  
3 114-69 shall be considered as adopted. The bill, as amend-  
4 ed, shall be considered as read. All points of order against  
5 provisions in the bill, as amended, are waived. The pre-  
6 vious question shall be considered as ordered on the bill,  
7 as amended, and on any further amendment thereto, to  
8 final passage without intervening motion except: (1) one  
9 hour of debate equally divided among and controlled by  
10 the respective chairs and ranking minority members of the  
11 Committees on Energy and Commerce, Natural Re-  
12 sources, and Transportation and Infrastructure; and (2)  
13 one motion to recommit with or without instructions.
