A BILL

To require the Secretary of the Interior to take land into trust for certain Indian tribes, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Nevada Native Nations
5 Land Act”.

1 **SEC. 2. DEFINITION OF SECRETARY.**

2 In this Act, the term “Secretary” means the Sec-
3 retary of the Interior.

4 **SEC. 3. CONVEYANCE OF LAND TO BE HELD IN TRUST FOR**
5 **CERTAIN INDIAN TRIBES.**

6 (a) CONVEYANCE OF LAND TO BE HELD IN TRUST
7 FOR THE FORT McDERMITT PAIUTE AND SHOSHONE
8 TRIBE.—

9 (1) DEFINITION OF MAP.—In this subsection,
10 the term “map” means the map entitled “Fort
11 McDermitt Indian Reservation Expansion Act”,
12 dated February 21, 2013, and on file and available
13 for public inspection in the appropriate offices of the
14 Bureau of Land Management.

15 (2) CONVEYANCE OF LAND.—Subject to valid
16 existing rights, all right, title, and interest of the
17 United States in and to the land described in para-
18 graph (3)—

19 (A) is held in trust by the United States
20 for the benefit of the Fort McDermitt Paiute
21 and Shoshone Tribe; and

22 (B) shall be part of the reservation of the
23 Fort McDermitt Paiute and Shoshone Tribe.

24 (3) DESCRIPTION OF LAND.—The land referred
25 to in paragraph (2) is the approximately 19,094
26 acres of land administered by the Bureau of Land

1 Management as generally depicted on the map as
2 “Reservation Expansion Lands”.

3 (b) CONVEYANCE OF LAND TO BE HELD IN TRUST
4 FOR THE SHOSHONE PAIUTE TRIBES.—

5 (1) DEFINITION OF MAP.—In this subsection,
6 the term “map” means the map entitled “Mountain
7 City Administrative Site Proposed Acquisition”,
8 dated July 29, 2013, and on file and available for
9 public inspection in the appropriate offices of the
10 Forest Service.

11 (2) CONVEYANCE OF LAND.—Subject to valid
12 existing rights, all right, title, and interest of the
13 United States in and to the land described in para-
14 graph (3)—

15 (A) is held in trust by the United States
16 for the benefit of the Shoshone Paiute Tribes of
17 the Duck Valley Indian Reservation; and

18 (B) shall be part of the reservation of the
19 Shoshone Paiute Tribes of the Duck Valley In-
20 dian Reservation.

21 (3) DESCRIPTION OF LAND.—The land referred
22 to in paragraph (2) is the approximately 82 acres of
23 land administered by the Forest Service as generally
24 depicted on the map as “Proposed Acquisition Site”.

1 (c) CONVEYANCE OF LAND TO BE HELD IN TRUST
2 FOR THE SUMMIT LAKE PAIUTE TRIBE.—

3 (1) DEFINITION OF MAP.—In this section, the
4 term “map” means the map entitled “Summit Lake
5 Indian Reservation Conveyance”, dated February
6 28, 2013, and on file and available for public inspec-
7 tion in the appropriate offices of the Bureau of
8 Land Management.

9 (2) CONVEYANCE OF LAND.—Subject to valid
10 existing rights, all right, title, and interest of the
11 United States in and to the land described in para-
12 graph (3)—

13 (A) is held in trust by the United States
14 for the benefit of the Summit Lake Paiute
15 Tribe; and

16 (B) shall be part of the reservation of the
17 Summit Lake Paiute Tribe.

18 (3) DESCRIPTION OF LAND.—The land referred
19 to in paragraph (2) is the approximately 941 acres
20 of land administered by the Bureau of Land Man-
21 agement as generally depicted on the map as “Res-
22 ervation Conveyance Lands”.

23 (d) CONVEYANCE OF LAND TO BE HELD IN TRUST
24 FOR THE RENO-SPARKS INDIAN COLONY.—

1 (1) DEFINITION OF MAP.—In this subsection,
 2 the term “map” means the map entitled “Reno-
 3 Sparks Indian Colony Expansion”, dated June 11,
 4 2014, and on file and available for public inspection
 5 in the appropriate offices of the Bureau of Land
 6 Management.

7 (2) CONVEYANCE OF LAND.—Subject to valid
 8 existing rights, all right, title, and interest of the
 9 United States in and to the land described in para-
 10 graph (3)—

11 (A) is held in trust by the United States
 12 for the benefit of the Reno-Sparks Indian Col-
 13 ony; and

14 (B) shall be part of the reservation of the
 15 Reno-Sparks Indian Colony.

16 (3) DESCRIPTION OF LAND.—The land referred
 17 to in paragraph (2) is the approximately 13,434
 18 acres of land administered by the Bureau of Land
 19 Management as generally depicted on the map as
 20 “RSIC Amended Boundary”.

21 (c) CONVEYANCE OF LAND TO BE HELD IN TRUST
 22 FOR THE PYRAMID LAKE PAIUTE TRIBE.—

23 (1) MAP.—In this subsection, the term “map”
 24 means the map entitled “Pyramid Lake Indian Res-
 25 ervation Expansion”, dated April 13, 2015, and on

1 file and available for public inspection in the appro-
 2 priate offices of the Bureau of Land Management.

3 ~~(2) CONVEYANCE OF LAND.~~—Subject to valid
 4 existing rights, all right, title, and interest of the
 5 United States in and to the land described in para-
 6 graph ~~(3)~~—

7 (A) is held in trust by the United States
 8 for the benefit of the Pyramid Lake Paiute
 9 Tribe; and

10 (B) shall be part of the reservation of the
 11 Pyramid Lake Paiute Tribe.

12 ~~(3) DESCRIPTION OF LAND.~~—The land referred
 13 to in paragraph ~~(2)~~ is the approximately 6,357 acres
 14 of land administered by the Bureau of Land Man-
 15 agement as generally depicted on the map as “Res-

19 (1) MAP.—In this subsection, the term “map”

 22 available for public inspection in the appropriate of-
 23 fices of the Bureau of Land Management.

24 ~~(2) CONVEYANCE OF LAND.~~—Subject to valid
 25 existing rights, all right, title, and interest of the

1 United States in and to the land described in para-
 2 graph (3)—

3 (A) is held in trust by the United States
 4 for the benefit of the Duckwater Shoshone
 5 Tribe; and

6 (B) shall be part of the reservation of the
 7 Duckwater Shoshone Tribe.

8 (3) DESCRIPTION OF LAND.—The land referred
 9 to in paragraph (2) is the approximately 31,269
 10 acres of land administered by the Bureau of Land
 11 Management as generally depicted on the map as
 12 “Reservation Expansion Lands”.

13 **SEC. 4. ADMINISTRATION.**

14 (a) SURVEY.—Not later than 180 days after the date
 15 of enactment of this Act, the Secretary shall complete a
 16 survey of the boundary lines to establish the boundaries
 17 of the land taken into trust for each Indian tribe under
 18 section 3.

19 (b) USE OF TRUST LAND.—

20 (1) GAMING.—Land taken into trust under sec-
 21 tion 3 shall not be eligible, or considered to have
 22 been taken into trust, for class II gaming or class
 23 III gaming (as those terms are defined in section 4
 24 of the Indian Gaming Regulatory Act (25 U.S.C.
 25 2703)).

1 (2) *CONVEYANCE OF LAND.*—Subject to valid ex-
2 isting rights, all right, title, and interest of the
3 United States in and to the land described in para-
4 graph (3)—

5 (A) is held in trust by the United States for
6 the benefit of the Fort McDermitt Paiute and
7 Shoshone Tribe; and

8 (B) shall be part of the reservation of the
9 Fort McDermitt Paiute and Shoshone Tribe.

10 (3) *DESCRIPTION OF LAND.*—The land referred
11 to in paragraph (2) is the approximately 19,094
12 acres of land administered by the Bureau of Land
13 Management as generally depicted on the map as
14 “Reservation Expansion Lands”.

15 (b) *CONVEYANCE OF LAND TO BE HELD IN TRUST FOR*
16 *THE SHOSHONE PAIUTE TRIBES.*—

17 (1) *DEFINITION OF MAP.*—In this subsection, the
18 term “map” means the map entitled “Mountain City
19 Administrative Site Proposed Acquisition”, dated
20 July 29, 2013, and on file and available for public
21 inspection in the appropriate offices of the Forest
22 Service.

23 (2) *CONVEYANCE OF LAND.*—Subject to valid ex-
24 isting rights and paragraph (4), all right, title, and

1 *interest of the United States in and to the land de-*
2 *scribed in paragraph (3)—*

3 *(A) is held in trust by the United States for*
4 *the benefit of the Shoshone Paiute Tribes of the*
5 *Duck Valley Indian Reservation; and*

6 *(B) shall be part of the reservation of the*
7 *Shoshone Paiute Tribes of the Duck Valley In-*
8 *dian Reservation.*

9 *(3) DESCRIPTION OF LAND.—The land referred*
10 *to in paragraph (2) is the approximately 82 acres of*
11 *land administered by the Forest Service as generally*
12 *depicted on the map as “Proposed Acquisition Site”.*

13 *(4) CONDITION ON CONVEYANCE.—The convey-*
14 *ance under paragraph (2) shall be subject to the res-*
15 *ervation of an easement on the conveyed land for a*
16 *road to provide access to adjacent National Forest*
17 *System land for use by the Forest Service for admin-*
18 *istrative purposes.*

19 *(5) FACILITIES AND IMPROVEMENTS.—The Sec-*
20 *retary of Agriculture (acting through the Chief of the*
21 *Forest Service) shall convey to the Shoshone Paiute*
22 *Tribes of the Duck Valley Indian Reservation any ex-*
23 *isting facilities or improvements to the land described*
24 *in paragraph (3).*

10 *isting rights, all right, title, and interest of the*
11 *United States in and to the land described in para-*
12 *graph (3)—*

13 (A) *is held in trust by the United States for*
14 *the benefit of the Summit Lake Paiute Tribe;*
15 *and*

16 (B) *shall be part of the reservation of the*
17 *Summit Lake Paiute Tribe.*

18 (3) *DESCRIPTION OF LAND.*—*The land referred*
19 *to in paragraph (2) is the approximately 941 acres*
20 *of land administered by the Bureau of Land Manage-*
21 *ment as generally depicted on the map as “Reserva-*
22 *tion Conveyance Lands”.*

23 (d) *CONVEYANCE OF LAND TO BE HELD IN TRUST*
24 *FOR THE RENO-SPARKS INDIAN COLONY.*—

1 (1) *DEFINITION OF MAP.*—*In this subsection, the*
2 *term “map” means the map entitled “Reno-Sparks*
3 *Indian Colony Expansion”, dated June 11, 2014, and*
4 *on file and available for public inspection in the ap-*
5 *propriate offices of the Bureau of Land Management.*

6 (2) *CONVEYANCE OF LAND.*—*Subject to valid ex-*
7 *isting rights, all right, title, and interest of the*
8 *United States in and to the land described in para-*
9 *graph (3)—*

10 (A) *is held in trust by the United States for*
11 *the benefit of the Reno-Sparks Indian Colony;*
12 *and*

13 (B) *shall be part of the reservation of the*
14 *Reno-Sparks Indian Colony.*

15 (3) *DESCRIPTION OF LAND.*—*The land referred*
16 *to in paragraph (2) is the approximately 13,434*
17 *acres of land administered by the Bureau of Land*
18 *Management as generally depicted on the map as*
19 *“RSIC Amended Boundary”.*

20 (e) *CONVEYANCE OF LAND TO BE HELD IN TRUST FOR*
21 *THE PYRAMID LAKE PAIUTE TRIBE.*—

22 (1) *MAP.*—*In this subsection, the term “map”*
23 *means the map entitled “Pyramid Lake Indian Res-*
24 *ervation Expansion”, dated April 13, 2015, and on*

1 *file and available for public inspection in the appro-*
2 *prate offices of the Bureau of Land Management.*

3 (2) *CONVEYANCE OF LAND.—Subject to valid ex-*
4 *isting rights, all right, title, and interest of the*
5 *United States in and to the land described in para-*

20 *means the map entitled “Duckwater Reservation Ex-*
21 *pansion”, dated October 15, 2015, and on file and*
22 *available for public inspection in the appropriate of-*
23 *fices of the Bureau of Land Management.*

24 (2) *CONVEYANCE OF LAND.—Subject to valid ex-*
25 *isting rights, all right, title, and interest of the*

1 *United States in and to the land described in para-*
2 *graph (3)—*

3 *(A) is held in trust by the United States for*
4 *the benefit of the Duckwater Shoshone Tribe; and*

5 *(B) shall be part of the reservation of the*
6 *Duckwater Shoshone Tribe.*

7 *(3) DESCRIPTION OF LAND.—The land referred*
8 *to in paragraph (2) is the approximately 31,229*
9 *acres of land administered by the Bureau of Land*
10 *Management as generally depicted on the map as*
11 *“Reservation Expansion Lands”.*

12 *(g) REVOCATION OF PUBLIC LAND ORDERS.—Any*
13 *public land order that withdraws any portion of land con-*
14 *veyed to an Indian tribe under this section shall be revoked*
15 *to the extent necessary to permit the conveyance of the land.*

16 **SEC. 4. ADMINISTRATION.**

17 *(a) SURVEY.—Not later than 180 days after the date*
18 *of enactment of this Act, the Secretary shall complete a sur-*
19 *vey of the boundary lines to establish the boundaries of the*
20 *land taken into trust for each Indian tribe under section*
21 *3.*

22 *(b) USE OF TRUST LAND.—*

23 *(1) GAMING.—Land taken into trust under sec-*
24 *tion 3 shall not be eligible, or considered to have been*
25 *taken into trust, for class II gaming or class III gam-*

1 *ing (as those terms are defined in section 4 of the In-*
2 *dian Gaming Regulatory Act (25 U.S.C. 2703)).*

3 (2) *THINNING; LANDSCAPE RESTORATION.—With*
4 *respect to the land taken into trust under section 3,*
5 *the Secretary, in consultation and coordination with*
6 *the applicable Indian tribe, may carry out any fuel*
7 *reduction and other landscape restoration activities,*
8 *including restoration of sage grouse habitat, on the*
9 *land that is beneficial to the Indian tribe and the Bu-*
10 *reau of Land Management.*
