A BILL

To designate the Federal building and United States courthouse located at 300 Fannin Street in Shreveport, Louisiana, as the “Tom Stagg Federal Building and United States Courthouse”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. TOM STAGG FEDERAL BUILDING AND UNITED**
2 **STATES COURTHOUSE UNITED STATES**
3 **COURT HOUSE.**

4 (a) FINDINGS.—Congress finds that—

5 (1) the Honorable Thomas Eaton Stagg, Jr.,
6 served as judge of the United States District Court
7 for the Western District of Louisiana from 1974
8 until his death in 2015;

9 (2) Judge Stagg served as Chief Judge of the
10 United States District Court for the Western Dis-
11 trict of Louisiana from 1984 through 1992;

12 (3) Judge Stagg served as Senior Judge of the
13 United States District Court for the Western Dis-
14 trict of Louisiana from 1992 through 2015;

15 (4) Judge Stagg exemplified all that is respect-
16 able and dignified in the judiciary and was a mentor
17 and role model for all attorneys within and beyond
18 the Western District of Louisiana; and

19 (5) the naming of the Federal building and
20 United States courthouse located at 300 Fannin
21 Street in Shreveport, Louisiana, after Judge Stagg
22 would honor his name and the legacy he left to all
23 citizens of the Western District of Louisiana.

24 (b) DESIGNATION.—The Federal building and United
25 States courthouse located at 300 Fannin Street in Shreve-
26 port, Louisiana, shall be known and designated as the

1 “Tom Stagg ~~Federal Building and United States Court-~~
2 ~~house~~ *United States Court House*”.

3 (c) REFERENCES.—Any reference in a law, map, reg-
4 ulation, document, paper, or other record of the United
5 States to the Federal building and United States court-
6 house referred to in subsection (b) shall be deemed to be
7 a reference to the “Tom Stagg ~~Federal Building and~~
8 ~~United States Courthouse~~ *United States Court House*”.
