A BILL

To amend the Omnibus Crime Control and Safe Streets Act of 1968 to authorize COPS grantees to use grant funds for active shooter training, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Protecting Our Lives
3 by Initiating COPS Expansion Act of 2016” or the “PO-
4 LICE Act of 2016”.

5 **SEC. 2. ADDITIONAL AUTHORIZED USE OF COPS FUNDS.**

6 Section 1701(b) of title I of the Omnibus Crime Con-
7 trol and Safe Streets Act of 1968 (42 U.S.C. 3796dd(b))
8 is amended—

9 (1) in paragraph (16), by striking “and” at the
10 end;

11 (2) by redesignating paragraph (17) as para-
12 graph (18);

13 (3) by inserting after paragraph (16) the fol-
14 lowing:

15 “(17) to participate in nationally recognized ac-
16 tive shooter training programs that offer scenario-
17 based, integrated response courses designed to
18 counter active shooter threats or acts of terrorism
19 against individuals or facilities; and”; and

20 (4) in paragraph (18), as redesignated, by
21 striking “(16)” and inserting “(17)”.
