

In the Senate of the United States,

February 9 (legislative day, February 8), 2018.

Resolved, That the resolution from the House of Representatives (H. Con. Res. 104) entitled “Concurrent resolution providing for a correction in the enrollment of H.R. 1892”, do pass with the following

AMENDMENT:

Strike all after the resolving clause and insert the following:

1 *That in the enrollment of the bill H.R. 1892, the Clerk of*
2 *the House of Representatives shall make the following cor-*
3 *rections:*

4 (1) *Strike the first section 1 and section 2 imme-*
5 *diately following the enacting clause and insert the*
6 *following:*

7 **“SECTION 1. SHORT TITLE.**

8 *“This Act may be cited as the “Bipartisan Budget Act*
9 *of 2018”.*

1 **“DIVISION A—HONORING**
2 **HOMETOWN HEROES ACT**

3 **“SECTION 10101. SHORT TITLE.**

4 *“This division may be cited as the ‘Honoring Home-*
5 *town Heroes Act’.*

6 **“SEC. 10102. PERMITTING THE FLAG TO BE FLOWN AT HALF-**
7 **STAFF IN THE EVENT OF THE DEATH OF A**
8 **FIRST RESPONDER SERVING IN THE LINE OF**
9 **DUTY.**

10 *“(a) AMENDMENT.—The sixth sentence of section 7(m)*
11 *of title 4, United States Code, is amended—*

12 *“(1) by striking ‘or’ after ‘possession of the*
13 *United States’ and inserting a comma;*

14 *“(2) by inserting ‘or the death of a first re-*
15 *sponder working in any State, territory, or possession*
16 *who dies while serving in the line of duty,’ after*
17 *‘while serving on active duty,’;*

18 *“(3) by striking ‘and’ after ‘former officials of*
19 *the District of Columbia’ and inserting a comma; and*

20 *“(4) by inserting before the period the following:*
21 *‘, and first responders working in the District of Co-*
22 *lumbia’.*

23 *“(b) FIRST RESPONDER DEFINED.—Such subsection is*
24 *further amended—*

1 “(1) in paragraph (2), by striking ‘, United
2 *States Code; and*’ and inserting a semicolon;

3 “(2) in paragraph (3), by striking the period at
4 *the end and inserting ‘; and*’; and

5 “(3) by adding at the end the following new
6 *paragraph:*

7 ““(4) the term “first responder” means a “public
8 *safety officer*” as defined in section 1204 of title I of
9 *the Omnibus Crime Control and Safe Streets Act of*
10 *1968 (34 U.S.C. 10284).*”.

11 “(c) *EFFECTIVE DATE.*—*The amendments made by*
12 *this section shall apply with respect to deaths of first re-*
13 *sponders occurring on or after the date of the enactment*
14 *of this Act.*”.

15 (2) *Strike section 1 immediately preceding divi-*
16 *sion B.*

17 (3) *In section 30422(b)(4), strike subparagraphs*
18 *(A) and (B) and insert the following:*

19 “(A) *GENERAL AUTHORITY.*—*For purposes*
20 *of enabling the joint committee to exercise its*
21 *powers, functions, and duties under this subtitle,*
22 *and consistent with the Standing Rules of the*
23 *Senate, there is authorized from the date of en-*
24 *actment of this Act through February 28, 2019,*
25 *\$500,000 to be allocated—*

1 “(i) in total during the period October
2 1, 2017 through September 30, 2018; and

3 “(ii) any remaining amounts shall be
4 carried forward for the period October 1,
5 2018 through February 28, 2019.

6 “(B) *EXPENSES*.—*Expenses of the joint*
7 *committee shall be paid from the contingent fund*
8 *of the Senate upon vouchers approved by the co-*
9 *chairs, subject to the rules and regulations of the*
10 *Senate.”.*

11 (4) *In section 30422(b)(4)(I)(i), insert “, con-*
12 *sistent with the rules and regulations of the Senate”*
13 *before the period at the end.*

14 (5) *Strike section 30423 and insert the following:*

15 **“SEC. 30423. FUNDING.**

16 “(a) *SPECIAL RESERVE*.—*To enable the joint com-*
17 *mittee to exercise its powers, functions, and duties under*
18 *this subtitle, within the funds in the account for ‘Expenses*
19 *of Inquiries and Investigations’ of the Senate, not more*
20 *than \$500,000 shall be allocated from the special reserve*
21 *established in S. Res. 62, agreed to February 28, 2017*
22 *(115th Congress), for use by the joint committee.*

23 “(b) *EXPIRATION*.—*None of the funds made available*
24 *by this section may be available for obligation by the joint*
25 *committee after January 2, 2019.*

1 “(c) *AVAILABILITY REQUIREMENTS.*—For purposes of
2 the joint committee, section 20(b) of S. Res. 62, agreed to
3 February 28, 2017 (115th Congress), shall not apply.”.

4 (6) In section 30442(b)(4), strike subparagraphs
5 (A) and (B) and insert the following:

6 “(A) *GENERAL AUTHORITY.*—For purposes
7 of enabling the joint committee to exercise its
8 powers, functions, and duties under this subtitle,
9 and consistent with the Standing Rules of the
10 Senate, there is authorized from the date of en-
11 actment of this Act through February 28, 2019,
12 \$500,000 to be allocated—

13 “(i) in total during the period October
14 1, 2017 through September 30, 2018; and

15 “(ii) any remaining amounts shall be
16 carried forward for the period October 1,
17 2018 through February 28, 2019.

18 “(B) *EXPENSES.*—Expenses of the joint
19 committee shall be paid from the contingent fund
20 of the Senate upon vouchers approved by the co-
21 chairs, subject to the rules and regulations of the
22 Senate.”.

23 (7) In section 30442(b)(4)(I)(i), insert “, con-
24 sistent with the rules and regulations of the Senate”
25 before the period at the end.

1 (8) *Strike section 30443 and insert the following:*

2 **“SEC. 30443. FUNDING.**

3 “(a) *SPECIAL RESERVE.—To enable the joint com-*
 4 *mittee to exercise its powers, functions, and duties under*
 5 *this subtitle, within the funds in the account for ‘Expenses*
 6 *of Inquiries and Investigations’ of the Senate, not more*
 7 *than \$500,000 shall be allocated from the special reserve*
 8 *established in S. Res. 62, agreed to February 28, 2017*
 9 *(115th Congress), for use by the joint committee.*

10 “(b) *EXPIRATION.—None of the funds made available*
 11 *by this section may be available for obligation by the joint*
 12 *committee after January 2, 2019.*

13 “(c) *AVAILABILITY REQUIREMENTS.—For purposes of*
 14 *the joint committee, section 20(b) of S. Res. 62, agreed to*
 15 *February 28, 2017 (115th Congress), shall not apply.”.*

16 (9) *Strike lines 4–8 on page 232 of the amend-*
 17 *ment and replace with the following:*

18 “(II) *a State false claims act, in-*
 19 *cluding a State false claims act with*
 20 *qui tam provisions, or”.*

21 (10) *At the end of division G, strike the fol-*
 22 *lowing: “.”.*

23 “(c) *EFFECTIVE DATE.—The amendments made by*
 24 *this Act shall apply with respect to deaths of first respond-*

1 *ers occurring on or after the date of the enactment of this*
2 *Act.*”.
