A BILL

To amend title 18, United States Code, to provide additional aggravating factors for the imposition of the death penalty based on the status of the victim.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Thin Blue Line Act”.*

5 **SEC. 2. AGGRAVATING FACTORS FOR DEATH PENALTY.**

6 *Section 3592(c) of title 18, United States Code, is*
7 *amended by inserting after paragraph (16) the following:*

8 “(17) *KILLING OR TARGETING OF LAW ENFORCE-*
9 *MENT OFFICER.—*

10 “(A) *The defendant killed or attempted to*
11 *kill, in the circumstance described in subpara-*
12 *graph (B), a person who is authorized by law—*

13 “(i) *to engage in or supervise the pre-*
14 *vention, detention, investigation, or prosecu-*
15 *tion, or the incarceration of any person for*
16 *any criminal violation of law;*

17 “(ii) *to apprehend, arrest, or prosecute*
18 *an individual for any criminal violation of*
19 *law; or*

20 “(iii) *to be a firefighter or other first*
21 *responder.*

22 “(B) *The circumstance referred to in sub-*
23 *paragraph (A) is that the person was killed or*
24 *targeted—*

1 “(i) while he or she was engaged in the
2 performance of his or her official duties;

3 “(ii) because of the performance of his
4 or her official duties; or

5 “(iii) because of his or her status as a
6 public official or employee.”.
