A BILL

To amend title 38, United States Code, to include the cost of applying to an institution of higher learning as part of the benefits provided under the Post-9/11 Educational Assistance Program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Reducing Barriers for
3 Veterans Education Act of 2017”.

4 **SEC. 2. COSTS OF APPLYING TO INSTITUTION OF HIGHER**
5 **LEARNING.**

6 (a) IN GENERAL.—Chapter 33 of title 38, United
7 States Code, is amended by inserting after section 3315A
8 the following new section:

9 **“§ 3315B. Costs of applying to institution of higher**
10 **learning**

11 “(a) IN GENERAL.—An individual entitled to edu-
12 cational assistance under this chapter shall also be entitled
13 to educational assistance for the application fee required
14 to apply to an approved program of education at an insti-
15 tution of higher learning.

16 “(b) AMOUNT.—The total amount of educational as-
17 sistance payable under this chapter to an individual for
18 applications described in subsection (a) is the lesser of—

19 “(1) the total application fees charged to the in-
20 dividual by the institutions of higher learning; or

21 “(2) \$750.

22 “(c) CHARGE AGAINST ENTITLEMENT.—The number
23 of months (and any fraction thereof) of entitlement
24 charged an individual under this chapter for an applica-
25 tion described in subsection (a) shall be determined at the

1 rate of one month for each amount that equals the amount
2 determined under section 3315A(c)(2) of this title.”.

3 (b) CLERICAL AMENDMENT.—The table of sections
4 at the beginning of such chapter is amended by inserting
5 after the item relating to section 3315A the following new
6 item:

“3315B. Costs of applying to institution of higher learning.”.
