A BILL

To retitle Indiana Dunes National Lakeshore as Indiana
Dunes National Park, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Indiana Dunes National*
5 *Park Act”.*

6 **SEC. 2. INDIANA DUNES NATIONAL LAKESHORE RETITLED**

7 **AS INDIANA DUNES NATIONAL PARK.**

8 (a) *IN GENERAL.*—*Public Law 89–761 (16 U.S.C.*
9 *460u et seq.) is amended—*

10 (1) *by striking “National Lakeshore” and “na-*
11 *tional lakeshore” each place it appears and inserting*
12 *“National Park”; and*

13 (2) *by striking “lakeshore” each place it appears*
14 *and inserting “Park”.*

15 (b) *NONAPPLICATION.*—*The amendment made by sub-*
16 *section (a)(1) shall not apply to the title of the map referred*
17 *to in the first section of Public Law 89–761 (16 U.S.C.*
18 *460u), or to the title of the maps referred to in section 4*
19 *of Public Law 89–761 (16 U.S.C. 460u–3).*
