# **A BILL**

To amend title 17, United States Code, to provide additional responsibilities for the Register of Copyrights, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SEC. 1. SHORT TITLE.**

4        *This Act may be cited as the “Register of Copyrights*  
5 *Selection and Accountability Act of 2017”.*

6 **SECTION 2. REGISTER OF COPYRIGHTS.**

7        *(a) AMENDMENTS.—Section 701 of title 17, United*  
8 *States Code, is amended—*

9            *(1) in subsection (a)—*

10                    *(A) by striking “(a) All administrative”*  
11 *and inserting the following:*

12            *“(a) REGISTER AND DIRECTOR.—*

13                    *“(1) IN GENERAL.—All administrative”;*

14                    *(B) by striking “director” and inserting*  
15 *“Director”;*

16                    *(C) by inserting after the first sentence the*  
17 *following: “The Register of Copyrights shall be a*  
18 *citizen of the United States with a professional*  
19 *background and experience in copyright law and*  
20 *shall be appointed by the President from the in-*  
21 *dividuals recommended under paragraph (6), by*  
22 *and with the advice and consent of the Senate.”;*  
23 *and*

1           (D) in the last sentence, by striking “shall  
2           be appointed” and all that follows through “and  
3           shall act” and inserting “shall act”;

4           (2) in subsection (b), by redesignating para-  
5           graphs (1) through (5) as subparagraphs (A) through  
6           (E), respectively, and adjusting the margins accord-  
7           ingly;

8           (3) by redesignating subsection (b) as paragraph  
9           (2), and adjusting the margins accordingly;

10          (4) in paragraph (2), as so redesignated, by in-  
11          serting “DUTIES.—” before “In addition”;

12          (5) by inserting after paragraph (2) the fol-  
13          lowing:

14               “(3) OATH.—The Register of Copyrights shall,  
15               before taking office, take an oath to discharge faith-  
16               fully the duties of the Copyright Office described in  
17               paragraph (2).

18               “(4) REMOVAL.—

19                       “(A) IN GENERAL.—The Register of Copy-  
20                       rights may be removed from office by the Presi-  
21                       dent.

22                       “(B) NOTIFICATION.—The President shall  
23                       provide notification to both Houses of Congress  
24                       of a removal under subparagraph (A).

25               “(5) TERM OF OFFICE.—

1           “(A) *IN GENERAL.*—Subject to subpara-  
2 graph (B), the Register of Copyrights—

3           “(i) shall be appointed for a term of 10  
4 years; and

5           “(ii) may serve until a successor is ap-  
6 pointed, confirmed, and taken the oath of  
7 office.

8           “(B) *LIMITATION.*—The Register of Copy-  
9 rights may not continue to serve after the date  
10 on which Congress adjourns sine die after the  
11 date on which the 10-year period described in  
12 subparagraph (A)(i) ends.

13           “(C) *REAPPOINTMENT.*—An individual ap-  
14 pointed to the position of Register of Copyrights,  
15 by and with the advice and consent of the Sen-  
16 ate, may be reappointed to that position in ac-  
17 cordance with the requirements of this section.

18           “(6) *PANEL FOR REGISTER OF COPYRIGHTS REC-*  
19 *OMMENDATIONS.*—There is established a panel to rec-  
20 ommend a list of at least 3 individuals to the Presi-  
21 dent for appointment as the Register of Copyrights.  
22 The panel shall be composed of the following:

23           “(A) The Speaker of the House of Rep-  
24 resentatives.

1           “(B) *The President pro tempore of the Sen-*  
2           *ate.*”

3           “(C) *The majority and minority leaders of*  
4           *the House of Representatives and the Senate.*”

5           “(D) *The Librarian of Congress.*”;

6           (6) *by redesignating subsections (c) through (f)*  
7           *as subsections (b) through (e), respectively;*

8           (7) *in subsection (b), as so redesignated, by in-*  
9           *serting “SEAL.—” before “The Register”;*

10          (8) *in subsection (c), as so redesignated, by in-*  
11          *serting “ANNUAL REPORT.—” before “The Register”;*

12          (9) *in subsection (d), as so redesignated, by in-*  
13          *serting “APPLICABILITY OF TITLE 5.—” before “Ex-*  
14          *cept as provided”; and*

15          (10) *in subsection (e), as so redesignated, by in-*  
16          *serting “COMPENSATION.—” before “The Register”.*

17          (b) *APPLICABILITY.—The amendments made by sub-*  
18          *section (a) shall apply with respect to any vacancy for the*  
19          *Register of Copyrights after January 1, 2017. If a Register*  
20          *of Copyrights is appointed during the period beginning on*  
21          *January 1, 2017 and ending on the day before the date*  
22          *of the enactment of this Act, that Register shall meet the*  
23          *requirements of the amendments made by this Act or shall*  
24          *be replaced in accordance with such amendments.*
