# **A BILL**

To adjust the eastern boundary of the Deschutes Canyon-Steelhead Falls Wilderness Study Area in the State of Oregon to facilitate fire prevention and response activities in order to protect adjacent private property, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Crooked River Ranch*  
5 *Fire Protection Act”.*

6 **SEC. 2. FINDINGS.**

7 *Congress finds the following:*

8 *(1) The Crooked River Ranch is an unincor-*  
9 *porated community with a population of 5,000 resi-*  
10 *dents.*

11 *(2) The current lands located adjacent to Crook-*  
12 *ed River Ranch are managed by the Bureau of Land*  
13 *Management and are classified as a Wilderness Study*  
14 *Area.*

15 *(3) There is currently only one entrance/exit to*  
16 *the Crooked River Ranch.*

17 *(4) Jefferson County and Crooked River Ranch*  
18 *have determined that the Wilderness Study Area*  
19 *lands are in the highest risk category for exposure to*  
20 *devastating wildfire due to overstocked juniper stands*  
21 *under the federally mandated and locally promul-*  
22 *gated Jefferson County Community Wildfire Protec-*  
23 *tion Plan (CWPP).*

1           (5) *The current Wilderness Study Area classi-*  
2           *fication prevents mechanical fire prevention activities*  
3           *within the overstocked juniper stands.*

4           (6) *Advancing this proposed legislation will*  
5           *greatly enhance the life and safety of people and*  
6           *property by reducing the extreme fire threat to these*  
7           *lands.*

8 **SEC. 3. BOUNDARY ADJUSTMENT, DESCHUTES CANYON-**  
9                           **STEELHEAD FALLS AND DESCHUTES CANYON**  
10                           **WILDERNESS STUDY AREAS, OREGON.**

11           (a) *BOUNDARY ADJUSTMENT REQUIRED.—The Sec-*  
12           *retary of the Interior shall adjust the eastern boundary of*  
13           *the Deschutes Canyon-Steelhead Falls Wilderness Study*  
14           *Area and the Deschutes Canyon Wilderness Study Area in*  
15           *the State of Oregon to exclude approximately 832 acres, as*  
16           *depicted on the map entitled “Deschutes Canyon-Steelhead*  
17           *Falls Wilderness Study Area” and dated April 6, 2017, in*  
18           *order to facilitate fire prevention and response activities on*  
19           *the excluded public lands and adjacent private property.*

20           (b) *EFFECT OF EXCLUSION.—Effective on the date of*  
21           *the enactment of this Act, the public lands to be excluded*  
22           *from the Deschutes Canyon-Steelhead Falls Wilderness*  
23           *Study Area and the Deschutes Canyon Wilderness Study*  
24           *Area pursuant to subsection (a) are no longer subject to*

- 1 *section 603(c) of the Federal Land Policy and Management*
- 2 *Act of 1976 (43 U.S.C. 1782(c)).*

Amend the title so as to read: “A bill to adjust the eastern boundary of the Deschutes Canyon-Steelhead Falls and Deschutes Canyon Wilderness Study Areas in the State of Oregon to facilitate fire prevention and response activities to protect private property, and for other purposes.”.
