## AN ACT

To amend title 38, United States Code, to improve the oversight of contracts awarded by the Secretary of Veterans Affairs to small business concerns owned and controlled by veterans, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Protecting Business  
3 Opportunities for Veterans Act of 2017”.

4 **SEC. 2. LIMITATIONS ON SUBCONTRACTS UNDER CON-**  
5 **TRACTS WITH SMALL BUSINESS CONCERNS**  
6 **OWNED AND CONTROLLED BY VETERANS.**

7 (a) IN GENERAL.—Section 8127 of title 38, United  
8 States Code, is amended—

9 (1) by redesignating subsection (l) as subsection  
10 (m); and

11 (2) by inserting after subsection (k) the fol-  
12 lowing new subsection (l):

13 “(l) LIMITATIONS ON SUBCONTRACTING.—(1)(A)  
14 The requirements applicable to a covered small business  
15 concern under section 46 of the Small Business Act (15  
16 U.S.C. 657s) shall apply with respect to a small business  
17 concern owned and controlled by veterans that is awarded  
18 a contract under this section.

19 “(B) For purposes of applying the requirements of  
20 section 46 of the Small Business Act (15 U.S.C. 657s)  
21 pursuant to subparagraph (A), the term ‘similarly situated  
22 entity’ used in such section 46 includes a subcontractor  
23 for a small business concern owned and controlled by vet-  
24 erans described in such subparagraph (A).

25 “(2) The Secretary may award a contract under this  
26 section only after the Secretary obtains from the offeror

1 a certification that the offeror will comply with the re-  
2 quirements described in paragraph (1)(A) if awarded the  
3 contract. Such certification shall—

4 “(A) specify the exact performance require-  
5 ments applicable under such paragraph; and

6 “(B) explicitly acknowledge that the certifi-  
7 cation is subject to section 1001 of title 18.

8 “(3)(A) The Director of Small and Disadvantaged  
9 Business Utilization for the Department, established pur-  
10 suant to section 15(k) of the Small Business Act (15  
11 U.S.C. 644(k)), and the Chief Acquisition Officer of the  
12 Department, established pursuant to section 1702 of title  
13 41, shall jointly implement a process using the systems  
14 described in section 16(g)(2) of the Small Business Act  
15 (15 U.S.C. 645(g)(2)), and any other relevant systems  
16 available, to monitor compliance with this subsection.

17 “(B) The Director of Small and Disadvantaged Busi-  
18 ness Utilization and the Chief Acquisition Officer shall  
19 jointly refer any violations or suspected violations of this  
20 subsection to the Inspector General of the Department.

21 “(C) If the Secretary determines, in consultation with  
22 the Inspector General of the Department, that a small  
23 business concern that is awarded a contract under this  
24 section did not act in good faith with respect to the re-  
25 quirements described in paragraph (1)(A), the small busi-

1 ness concern shall be subject to any or all of the following  
2 consequences—

3 “(i) referral to the Debarment and Suspension  
4 Committee of the Department;

5 “(ii) a fine under section 16(g)(1) of the Small  
6 Business Act (15 U.S.C. 645(g)(1)); and

7 “(iii) prosecution for violating section 1001 of  
8 title 18.

9 “(D) Not later than November 30 for each of years  
10 2018 through 2022, the Inspector General shall submit  
11 to the Committees on Veterans’ Affairs of the Senate and  
12 House of Representatives a report for the fiscal year pre-  
13 ceding the fiscal year during which the report is submitted  
14 that includes, for the fiscal year covered by the report—

15 “(i) the number of referred violations and sus-  
16 pected violations received under subparagraph (B);  
17 and

18 “(ii) the disposition of such referred violations,  
19 including the number of small business concerns sus-  
20 pended or debarred from Federal contracting or re-  
21 ferred to the Attorney General for prosecution.”.

22 (b) EFFECTIVE DATE.—Subsection (l) of section  
23 8127 of title 38, United States Code, as added by sub-

- 1 section (a) shall apply with respect to a contract entered
- 2 into after the date of the enactment of this Act.
