Ms. CLARK of Massachusetts (for herself and Mr. YOUNG of Alaska) introduced the following bill; which was referred to the Committee on Education and the Workforce

A BILL

To amend the Higher Education Act of 1965 to provide greater support to students with dependents, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Child Care Access
5 Means Parents in School Reauthorization Act” or the
6 “CCAMPIS Reauthorization Act”.

7 **SEC. 2. AMENDMENTS TO CCAMPIS.**

8 Section 419N of the Higher Education Act of 1965
9 (20 U.S.C. 1070e) is amended—

1 (1) in subsection (b)—

2 (A) in paragraph (1)—

3 (i) by striking “The Secretary” and
4 inserting the following:

5 “(A) IN GENERAL.—The Secretary”; and

6 (ii) by adding the following:

7 “(B) RESERVATION.—The Secretary shall
8 reserve not less than 3 percent of the funds ap-
9 propriated under subsection (g) for a fiscal year
10 to award grants under this section to Tribal
11 Colleges and Universities (defined in section
12 316) that meet the requirements of this section,
13 except that the requirements of paragraph (4)
14 of this subsection shall not be applicable to
15 such institutions.”; and

16 (B) in paragraph (4), by striking “An in-
17 stitution” and inserting “Except as provided in
18 paragraph (1)(B), an institution”;

19 (2) in subsection (e)—

20 (A) in paragraph (1), by adding at the end
21 the following:

22 “(C) STAKEHOLDER CONSULTATION.—The
23 Secretary shall work with relevant stakeholders
24 to determine the manner in which the data de-
25 scribed in subparagraph (B) shall be collected

1 in order to ensure compliance with such sub-
 2 paragraph.”; and

3 (B) by adding at the end the following:

4 “(3) PUBLICATION OF REPORTS.—Not later
 5 than 1 year after the first report is submitted under
 6 paragraph (1), as amended by the CCAMPIS Reau-
 7 thorization Act, and annually thereafter, the Sec-
 8 retary shall publish the reports submitted under
 9 paragraph (1) for the preceding year on the public
 10 website of the Department.”; and

11 (3) by amending subsection (g) to read as fol-
 12 lows:

13 “(g) AUTHORIZATION OF APPROPRIATIONS.—There
 14 are authorized to be appropriated to carry out this section
 15 \$67,000,000 for fiscal year 2018 and each succeeding fis-
 16 cal year.”.

17 **SEC. 3. REPORT BY OFFICE OF POSTSECONDARY EDU-**
 18 **CATION.**

19 Not later than 1 year after the date of enactment
 20 of this Act, the Secretary of Education (acting through
 21 the Office of Postsecondary Education) shall report to
 22 Congress on the plans of the Department of Education
 23 to better serve postsecondary students with dependents.
