## AN ACT

To provide overtime pay for employees of the United States  
Secret Service, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Secret Service Recruit-  
3 ment and Retention Act of 2017”.

4 **SEC. 2. EXTENSION OF OVERTIME PAY EXCEPTION**  
5 **THROUGH 2018 FOR PROTECTIVE SERVICES.**

6 (a) **IN GENERAL.**—The Overtime Pay for Protective  
7 Services Act of 2016 (5 U.S.C. 5547 note) is amended—

8 (1) in the section heading for section 2, by  
9 striking “**2016**” and inserting “**2016 THROUGH**  
10 **2018**”; and

11 (2) by striking “during 2016” each place it ap-  
12 pears and inserting “during 2016 through 2018”.

13 (b) **EFFECTIVE DATE.**—The amendments made by  
14 subsection (a) shall take effect as if enacted on December  
15 31, 2016.

16 (c) **REPORT ON EXTENSIONS.**—Not later than Janu-  
17 ary 30, 2018, and January 30, 2019, the Director of the  
18 Secret Service shall submit to the Committee on Home-  
19 land Security and the Committee on Oversight and Gov-  
20 ernment Reform of the House of Representatives and the  
21 Committee on Homeland Security and Governmental Af-  
22 fairs of the Senate a report on the effects of the amend-  
23 ment made by subsection (a)(2). The report shall include,  
24 with respect to the previous calendar year—

25 (1) the total number of United States Secret  
26 Service personnel receiving premium pay above the

1 premium pay limitation in subsection (a) of section  
2 5547 of title 5, United States Code;

3 (2) the total amount of premium pay for that  
4 calendar year paid to United States Secret Service  
5 personnel above the premium pay limitation in such  
6 subsection;

7 (3) the mean and median amount of premium  
8 pay paid to United States Secret Service personnel  
9 above the premium pay limitation in such sub-  
10 section;

11 (4) the greatest amount paid to United States  
12 Secret Service personnel above the premium pay lim-  
13 itation in such subsection and the number of em-  
14 ployees who received that amount;

15 (5) notwithstanding the amendments made by  
16 subsection (a), the total number of United States  
17 Secret Service personnel who were not fully com-  
18 pensated for service because of the premium pay  
19 earnings limitation in section 118 of the Treasury  
20 and General Government Appropriations Act, 2001  
21 (5 U.S.C. 5547 note);

22 (6) the total amount of premium pay United  
23 States Secret Service personnel would have been  
24 paid but for the premium pay earnings limitation in  
25 such section; and

1           (7) a list of United States Secret Service per-  
2           sonnel who, within the calendar year, received pre-  
3           mium pay above the premium pay limitation in sub-  
4           section (a) of section 5547 of title 5, United States  
5           Code, and separated from the agency, including the  
6           type of separation in each case.

7   **SEC. 3. REPORT OF THE COMPTROLLER GENERAL OF THE**  
8                                   **UNITED STATES.**

9           Not later than 1 year after the effective date of this  
10          section, the Comptroller General of the United States shall  
11          complete a study and submit to the Committee on the Ju-  
12          diciary of the House of Representatives, the Committee  
13          on the Judiciary of the Senate, the Committee on Over-  
14          sight and Government Reform of the House of Represent-  
15          atives, and the Committee on Homeland Security and Gov-  
16          ernmental Affairs of the Senate a report on the extent  
17          of the progress made by the United States Secret Service  
18          in implementing the recommendations of the United  
19          States Secret Service Protective Mission Panel, including  
20          in particular those items pertaining to training and per-  
21          sonnel enumerated in the Executive Summary to Report  
22          from the United States Secret Service Protective Mission  
23          Panel to the Secretary of Homeland Security dated De-  
24          cember 15, 2014.

1 **SEC. 4. RESCISSIONS.**

2 (a) RESCISSION OF UNOBLIGATED BALANCES IN THE  
3 DEPARTMENT OF JUSTICE ASSETS FORFEITURE  
4 FUND.—Of the unobligated balances available under the  
5 Department of Justice Assets Forfeiture Fund,  
6 \$10,000,000 is hereby permanently rescinded.

7 (b) AUTHORIZATION TO RESCIND FUTURE UNOBLI-  
8 GATED BALANCES IN THE DEPARTMENT OF JUSTICE AS-  
9 SETS FORFEITURE FUND.—There is authorized to be re-  
10 scinded from the unobligated balances available under the  
11 Department of Justice Assets Forfeiture Fund  
12 \$7,000,000 in fiscal year 2018 and \$3,000,000 in fiscal  
13 year 2019.
