A BILL

To require the Secretary of Homeland Security to examine what actions the Department of Homeland Security is undertaking to combat the threat of vehicular terrorism, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Vehicular Terrorism*
5 *Prevention Act of 2018”.*

6 **SEC. 2. STRATEGY ON VEHICULAR TERRORISM.**

7 *(a) IN GENERAL.—Not later than six months after the*
8 *date of the enactment of this Act, the Secretary of Homeland*
9 *Security shall—*

10 *(1) assess the activities the Department of Home-*
11 *land Security is undertaking to support emergency*
12 *response providers and the private sector to prevent,*
13 *mitigate, and respond to the threat of vehicular ter-*
14 *rorism; and*

15 *(2) based on such assessment, develop and submit*
16 *to the Committee on Homeland Security of the House*
17 *of Representatives and the Committee on Homeland*
18 *Security and Governmental Affairs of the Senate a*
19 *strategy to improve the Department’s efforts to sup-*
20 *port the efforts of emergency response providers and*
21 *the private sector to prevent, mitigate, and respond to*
22 *such threat.*

23 *(b) CONTENTS.—The strategy required under sub-*
24 *section (a) shall include the following:*

1 (1) *An examination of the current threat of ve-*
2 *hicular terrorism.*

3 (2) *Methods to improve Department of Home-*
4 *land Security information sharing activities with*
5 *emergency response providers and the private sector*
6 *regarding best practices to prevent, mitigate, and re-*
7 *spond to the increasing threat of vehicular terrorism.*

8 (3) *Training activities the Department can pro-*
9 *vide, including possible exercises, for emergency re-*
10 *sponse providers to prevent and respond to the threat*
11 *of vehicular terrorism.*

12 (4) *Any additional activities the Secretary of*
13 *Homeland Security recommends to prevent, mitigate,*
14 *and respond to the threat of vehicular terrorism.*

15 (c) *DEFINITIONS.—In this section:*

16 (1) *EMERGENCY RESPONSE PROVIDERS.—The*
17 *term “emergency response providers” has the meaning*
18 *given such term in section 2(6) of the Homeland Se-*
19 *curity Act of 2002 (6 U.S.C. 101(6)).*

20 (2) *VEHICULAR TERRORISM.—The term “vehic-*
21 *ular terrorism” means any action that utilizes auto-*
22 *motive transportation to inflict violence and intimi-*
23 *dation on individuals for a political purpose.*
