AN ACT

To amend the Coastal Barrier Resources Act to give effect to more accurate maps of units of the John H. Chafee Coastal Barrier Resources System that were produced by digital mapping of such units, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Strengthening Coastal
3 Communities Act of 2018”.

4 **SEC. 2. REPLACEMENT OF JOHN H. CHAFEE COASTAL BAR-**
5 **RIER RESOURCES SYSTEM MAPS.**

6 (a) IN GENERAL.—Subject to subsection (c), each
7 map included in the set of maps referred to in section 4(a)
8 of the Coastal Barrier Resources Act (16 U.S.C. 3503(a))
9 that relates to a Unit of such System referred to in sub-
10 section (b) of this section is replaced in such set with the
11 map described in subsection (b) with respect to that Unit.

12 (b) REPLACEMENT MAPS DESCRIBED.—The replace-
13 ment maps referred to in subsection (a) are the following:

14 (c) LIMITATIONS.—For purposes of subsection (a)—

15 (1) nothing in this section affects the bound-
16 aries of any of Units NC–06 and NC–06P;

17 (2) the occurrence in subsection (b) of the name
18 of a Unit solely in the title of a map shall not be
19 construed to be a reference to such Unit; and

20 (3) the depiction of boundaries of any of Units
21 P18P, FL–71P, and P24P in a map referred to in
22 paragraph (22), (24), or (27) of subsection (b) shall
23 not be construed to affect the boundaries of such
24 Unit.

1 (d) CONFORMING AMENDMENT.—Section 4(a) of the
2 Coastal Barrier Resources Act (16 U.S.C. 3503(a)) is
3 amended—

4 (1) in the matter preceding paragraph (1), by
5 inserting “replaced,” after “may be”; and

6 (2) in paragraph (3), by inserting “replaces
7 such a map or” after “that specifically”.

8 **SEC. 3. DIGITAL MAPS OF JOHN H. CHAFEE COASTAL BAR-**
9 **RIER RESOURCES SYSTEM UNITS.**

10 Section 4(b) of the Coastal Barrier Resources Act (16
11 U.S.C. 3503(b)) is amended—

12 (1) by inserting before the first sentence the
13 following:

14 “(1) IN GENERAL.—”; and

15 (2) by adding at the end the following:

16 “(2) DIGITAL MAPS.—

17 “(A) AVAILABILITY.—The Secretary shall
18 make available to the public on the Internet
19 web site of the United States Fish and Wildlife
20 Service digital versions of the maps included in
21 the set of maps referred to in subsection (a).

22 “(B) EFFECT.—Any determination as to
23 whether a location is inside or outside the Sys-
24 tem shall be made without regard to the digital
25 maps available under this paragraph, except

1 that this subparagraph does not apply with re-
2 spect to any printed version of such a digital
3 map if the printed version is included in the
4 maps referred to in subsection (a).

5 “(C) REPORT.—No later than 180 days
6 after the date of the enactment of the Strength-
7 ening Coastal Communities Act of 2018, the
8 Secretary shall submit to the Committee on
9 Natural Resources of the House of Representa-
10 tives and the Committee on Environment and
11 Public Works of the Senate a report regarding
12 the progress and challenges in the transition
13 from paper to digital maps and a timetable for
14 completion of the digitization of all maps re-
15 lated to the System.”.

16 **SEC. 4. REPEAL OF REPORT.**

17 Section 3 of Public Law 109–226 is repealed.
