# **A BILL**

To amend title XIX of the Social Security Act to provide for Medicaid coverage protections for pregnant and postpartum women while receiving inpatient treatment for a substance use disorder, and for other purposes.



1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. GUIDANCE TO IMPROVE CARE FOR INFANTS**  
 4 **WITH NEONATAL ABSTINENCE SYNDROME**  
 5 **AND THEIR MOTHERS; GAO STUDY ON GAPS**  
 6 **IN MEDICAID COVERAGE FOR PREGNANT AND**  
 7 **POSTPARTUM WOMEN WITH SUBSTANCE USE**  
 8 **DISORDER.**

9 *(a) GUIDANCE.—Not later than one year after the date*  
 10 *of the enactment of this Act, the Secretary of Health and*  
 11 *Human Services shall issue guidance to improve care for*  
 12 *infants with neonatal abstinence syndrome and their moth-*  
 13 *ers. Such guidance shall include—*

14 *(1) the types of services, including post-discharge*  
 15 *services and parenting supports, for mothers and fa-*  
 16 *thers of babies with neonatal abstinence syndrome*  
 17 *that States may cover under the Medicaid program*  
 18 *under title XIX of the Social Security Act;*

19 *(2) best practices from States with respect to in-*  
 20 *novative or evidenced-based payment models that*  
 21 *focus on prevention, screening, treatment, plans of*  
 22 *safe care, and post-discharge services for mothers and*  
 23 *fathers with substance use disorders and babies with*  
 24 *neonatal abstinence syndrome that improve care and*  
 25 *clinical outcomes;*



1           (3) recommendations for States on available fi-  
 2           nancing options under the Medicaid program under  
 3           title XIX of such Act and under the Children’s Health  
 4           Insurance Program under title XXI of such Act for  
 5           Children’s Health Insurance Program Health Services  
 6           Initiative funds for parents with substance use dis-  
 7           orders, infants with neonatal abstinence syndrome,  
 8           and home visiting services; and

9           (4) guidance and technical assistance to State  
 10          Medicaid agencies regarding additional flexibilities  
 11          and incentives related to screening, prevention, and  
 12          post-discharge services, including parenting supports,  
 13          under contracts with medicaid managed care organi-  
 14          zations.

15          (b) GAO STUDY.—Not later than one year after the  
 16          date of the enactment of this Act, the Comptroller General  
 17          of the United States shall conduct a study, and submit to  
 18          Congress a report, addressing gaps in coverage for pregnant  
 19          women with substance use disorder under the Medicaid pro-  
 20          gram under title XIX of the Social Security Act, and gaps  
 21          in coverage for postpartum women with substance use dis-  
 22          order who had coverage during their pregnancy under the  
 23          Medicaid program under such title.

Amend the title so as to read: “A bill to require the  
 Secretary of Health and Human Services to issue guid-  
 ance to improve care for infants with neonatal abstinence



syndrome and their mothers, and require the Comptroller General of the United States to conduct a study on gaps in Medicaid coverage for pregnant and postpartum women with substance use disorder.”.
