A BILL

To direct the Secretary of Veterans Affairs to establish qualifications for the human resources positions within the Veterans Health Administration of the Department of Veterans Affairs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “VA Hospitals Estab-
5 lishing Leadership Performance Act”.

6 **SEC. 2. QUALIFICATIONS FOR HUMAN RESOURCES POSI-**
7 **TIONS WITHIN THE VETERANS HEALTH AD-**
8 **MINISTRATION OF THE DEPARTMENT OF**
9 **VETERANS AFFAIRS.**

10 (a) ESTABLISHMENT OF QUALIFICATIONS.—Not
11 later than 180 days after the date of the enactment of
12 this Act, the Secretary of Veterans Affairs shall—

13 (1) establish qualifications for each human re-
14 sources position within the Veterans Health Admin-
15 istration of the Department of Veterans Affairs;

16 (2) establish standardized performance metrics
17 for each such position; and

18 (3) submit to Congress a report containing the
19 qualifications and standardized performance metrics
20 established under paragraphs (1) and (2).

21 (b) REPORT.—Not later than 180 days after the es-
22 tablishment of the qualifications and performance metrics
23 under subsection (a), the Comptroller General of the
24 United States shall submit to the Committee on Veterans’
25 Affairs of the House of Representatives and the Com-

1 mittee on Veterans' Affairs of the Senate a report con-
2 taining—

3 (1) a description of the implementation of such
4 qualifications and performance metrics; and

5 (2) an assessment of the quality of such quali-
6 fications and performance metrics.
