# **A BILL**

To repeal the provisions of the Patient Protection and Affordable Care Act providing for the Independent Payment Advisory Board.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Protecting Seniors Ac-*  
5 *cess to Medicare Act”.*

6 **SEC. 2. REPEAL OF THE INDEPENDENT PAYMENT ADVISORY**  
7 **BOARD.**

8        *Effective as of the enactment of the Patient Protection*  
9 *and Affordable Care Act (Public Law 111–148), sections*  
10 *3403 and 10320 of such Act (including the amendments*  
11 *made by such sections) are repealed, and any provision of*  
12 *law amended by such sections is hereby restored as if such*  
13 *sections had not been enacted into law.*
