Ms. CHENEY, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 1635) to amend the loan counseling requirements under the Higher Education Act of 1965, and for other purposes, and providing for consideration of the bill (H.R. 4606) to provide that applications under the Natural Gas Act for the importation or exportation of small volumes of natural gas shall be granted without modification or delay.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule

1 XVIII, declare the House resolved into the Committee of
2 the Whole House on the state of the Union for consider-
3 ation of the bill (H.R. 1635) to amend the loan counseling
4 requirements under the Higher Education Act of 1965,
5 and for other purposes. The first reading of the bill shall
6 be dispensed with. All points of order against consider-
7 ation of the bill are waived. General debate shall be con-
8 fined to the bill and shall not exceed one hour equally di-
9 vided and controlled by the chair and ranking minority
10 member of the Committee on Education and the Work-
11 force. After general debate the bill shall be considered for
12 amendment under the five-minute rule. The bill shall be
13 considered as read. All points of order against provisions
14 in the bill are waived. No amendment to the bill shall be
15 in order except those printed in part A of the report of
16 the Committee on Rules accompanying this resolution.
17 Each such amendment may be offered only in the order
18 printed in the report, may be offered only by a Member
19 designated in the report, shall be considered as read, shall
20 be debatable for the time specified in the report equally
21 divided and controlled by the proponent and an opponent,
22 shall not be subject to amendment, and shall not be sub-
23 ject to a demand for division of the question in the House
24 or in the Committee of the Whole. All points of order
25 against such amendments are waived. At the conclusion

1 of consideration of the bill for amendment the Committee
2 shall rise and report the bill to the House with such
3 amendments as may have been adopted. The previous
4 question shall be considered as ordered on the bill and
5 amendments thereto to final passage without intervening
6 motion except one motion to recommit with or without in-
7 structions.

8 SEC. 2. At any time after adoption of this resolution
9 the Speaker may, pursuant to clause 2(b) of rule XVIII,
10 declare the House resolved into the Committee of the
11 Whole House on the state of the Union for consideration
12 of the bill (H.R. 4606) to provide that applications under
13 the Natural Gas Act for the importation or exportation
14 of small volumes of natural gas shall be granted without
15 modification or delay. The first reading of the bill shall
16 be dispensed with. All points of order against consider-
17 ation of the bill are waived. General debate shall be con-
18 fined to the bill and shall not exceed one hour equally di-
19 vided and controlled by the chair and ranking minority
20 member of the Committee on Energy and Commerce.
21 After general debate the bill shall be considered for
22 amendment under the five-minute rule. It shall be in order
23 to consider as an original bill for the purpose of amend-
24 ment under the five-minute rule the amendment in the na-
25 ture of a substitute recommended by the Committee on

1 Energy and Commerce now printed in the bill. The com-
2 mittee amendment in the nature of a substitute shall be
3 considered as read. All points of order against the com-
4 mittee amendment in the nature of a substitute are
5 waived. No amendment to the committee amendment in
6 the nature of a substitute shall be in order except those
7 printed in part B of the report of the Committee on Rules
8 accompanying this resolution. Each such amendment may
9 be offered only in the order printed in the report, may
10 be offered only by a Member designated in the report,
11 shall be considered as read, shall be debatable for the time
12 specified in the report equally divided and controlled by
13 the proponent and an opponent, shall not be subject to
14 amendment, and shall not be subject to a demand for divi-
15 sion of the question in the House or in the Committee
16 of the Whole. All points of order against such amendments
17 are waived. At the conclusion of consideration of the bill
18 for amendment the Committee shall rise and report the
19 bill to the House with such amendments as may have been
20 adopted. Any Member may demand a separate vote in the
21 House on any amendment adopted in the Committee of
22 the Whole to the bill or to the committee amendment in
23 the nature of a substitute. The previous question shall be
24 considered as ordered on the bill and amendments thereto

- 1 to final passage without intervening motion except one
- 2 motion to recommit with or without instructions.
