RESOLUTION

Providing for consideration of the bill (H.R. 6784) to provide for removal of the gray wolf in the contiguous 48 States from the List of Endangered and Threatened Wildlife published under the Endangered Species Act of 1973, and providing for proceedings during the period from November 19, 2018, through November 26, 2018.

- 1 *Resolved*, That upon adoption of this resolution it
- 2 shall be in order to consider in the House the bill (H.R.
- 3 6784) to provide for removal of the gray wolf in the con-

1 tiguous 48 States from the List of Endangered and
2 Threatened Wildlife published under the Endangered Spe-
3 cies Act of 1973. All points of order against consideration
4 of the bill are waived. The bill shall be considered as read.
5 All points of order against provisions in the bill are
6 waived. The previous question shall be considered as or-
7 dered on the bill and on any amendment thereto to final
8 passage without intervening motion except: (1) one hour
9 of debate equally divided and controlled by the chair and
10 ranking minority member of the Committee on Natural
11 Resources; and (2) one motion to recommit.

12 SEC. 2. On any legislative day during the period from
13 November 19, 2018, through November 26, 2018—

14 (a) the Journal of the proceedings of the pre-
15 vious day shall be considered as approved; and

16 (b) the Chair may at any time declare the
17 House adjourned to meet at a date and time, within
18 the limits of clause 4, section 5, article I of the Con-
19 stitution, to be announced by the Chair in declaring
20 the adjournment.

21 SEC. 3. The Speaker may appoint Members to per-
22 form the duties of the Chair for the duration of the period
23 addressed by section 2 of this resolution as though under
24 clause 8(a) of rule I.

- 1 SEC. 4. The provisions of section 7 of the War Powers
- 2 Resolution (50 U.S.C. 1546) shall not apply to House
- 3 Concurrent Resolution 138.
