## RESOLUTION

Providing for consideration of the joint resolution (H.J. Res. 66) disapproving the rule submitted by the Department of Labor relating to savings arrangements established by States for non-governmental employees, and providing for consideration of the joint resolution (H.J. Res. 67) disapproving the rule submitted by the Department of Labor relating to savings arrangements established by qualified State political subdivisions for non-governmental employees.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House any joint resolu-  
3 tion specified in section 2 of this resolution. All points of  
4 order against consideration of each such joint resolution  
5 are waived. Each such joint resolution shall be considered  
6 as read. All points of order against provisions in each such  
7 joint resolution are waived. The previous question shall be  
8 considered as ordered on each such joint resolution and  
9 on any amendment thereto to final passage without inter-  
10 vening motion except: (1) one hour of debate equally di-  
11 vided and controlled by the chair and ranking minority  
12 member of the Committee on Education and the Work-  
13 force; and (2) one motion to recommit.

14       SEC. 2. The joint resolutions referred to in the first  
15 section of this resolution are as follows:

16       (a) The joint resolution (H.J. Res. 66) disapproving  
17 the rule submitted by the Department of Labor relating  
18 to savings arrangements established by States for non-  
19 governmental employees.

20       (b) The joint resolution (H.J. Res. 67) disapproving  
21 the rule submitted by the Department of Labor relating  
22 to savings arrangements established by qualified State po-  
23 litical subdivisions for non-governmental employees.
