## RESOLUTION

Providing for consideration of the bill (H.R. 1101) to amend title I of the Employee Retirement Income Security Act of 1974 to improve access and choice for entrepreneurs with small businesses with respect to medical care for their employees.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 1101) to amend title I of the Employee Retirement In-  
4 come Security Act of 1974 to improve access and choice  
5 for entrepreneurs with small businesses with respect to

1 medical care for their employees. All points of order  
2 against consideration of the bill are waived. In lieu of the  
3 amendment recommended by the Committee on Education  
4 and the Workforce now printed in the bill, an amendment  
5 in the nature of a substitute consisting of the text of Rules  
6 Committee Print 115-9 shall be considered as adopted.  
7 The bill, as amended, shall be considered as read. All  
8 points of order against provisions in the bill, as amended,  
9 are waived. The previous question shall be considered as  
10 ordered on the bill, as amended, and on any further  
11 amendment thereto, to final passage without intervening  
12 motion except: (1) one hour of debate equally divided and  
13 controlled by the chair and ranking minority member of  
14 the Committee on Education and the Workforce; (2) the  
15 further amendment printed in the report of the Committee  
16 on Rules accompanying this resolution, if offered by the  
17 Member designated in the report, which shall be in order  
18 without intervention of any point of order, shall be consid-  
19 ered as read, shall be separately debatable for the time  
20 specified in the report equally divided and controlled by  
21 the proponent and an opponent, and shall not be subject  
22 to a demand for a division of the question; and (3) one  
23 motion to recommit with or without instructions.
