Providing for consideration of the Senate amendments to the bill (H.R. 244) to encourage effective, voluntary investments to recruit, employ, and retain men and women who have served in the United States military with annual Federal awards to employers recognizing such efforts, and for other purposes.

4 other purposes, with the Senate amendments thereto, and
5 to consider in the House, without intervention of any point
6 of order, a single motion offered by the chair of the Com-
7 mittee on Appropriations or his designee that the House
8 concur in the Senate amendments numbered 2 and 3, and
9 that the House concur in the Senate amendment num-
10 bered 1 with an amendment consisting of the text of Rules
11 Committee Print 115-16 modified by the amendment
12 printed in the report of the Committee on Rules accom-
13 panying this resolution. The Senate amendments and the
14 motion shall be considered as read. The motion shall be
15 debatable for one hour equally divided and controlled by
16 the chair and ranking minority member of the Committee
17 on Appropriations. The previous question shall be consid-
18 ered as ordered on the motion to final adoption without
19 intervening motion or demand for division of the question.

20 SEC. 2. The chair of the Committee on Appropria-
21 tions may insert in the Congressional Record not later
22 than May 3, 2017, such material as he may deem explana-
23 tory of the Senate amendments and the motion specified
24 in the first section of this resolution.

1 SEC. 3. The chair of the Permanent Select Committee
2 on Intelligence may insert in the Congressional Record not
3 later than May 3, 2017, such material as he may deem
4 explanatory of intelligence authorization measures for the
5 fiscal year 2017.
