Providing for consideration of the bill (H.R. 1973) to prevent the sexual abuse of minors and amateur athletes by requiring the prompt reporting of sexual abuse to law enforcement authorities, and for other purposes; providing for consideration of the bill (H.R. 1761) to amend title 18, United States Code, to criminalize the knowing consent of the visual depiction, or live transmission, of a minor engaged in sexually explicit conduct, and for other purposes; and providing for proceedings during the period from May 26, 2017, through June 5, 2017.

Mr. BUCK, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 1973) to prevent the sexual abuse of minors and amateur athletes by requiring the prompt reporting of sexual abuse to law enforcement authorities, and for other purposes; providing for consideration of the bill (H.R. 1761) to amend title 18, United States Code, to criminalize the knowing consent of the visual depiction, or live transmission, of a minor engaged in sexually explicit conduct, and for

other purposes; and providing for proceedings during the period from May 26, 2017, through June 5, 2017.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 1973) to prevent the sexual abuse
6 of minors and amateur athletes by requiring the prompt
7 reporting of sexual abuse to law enforcement authorities,
8 and for other purposes. The first reading of the bill shall
9 be dispensed with. All points of order against consider-
10 ation of the bill are waived. General debate shall be con-
11 fined to the bill and amendments specified in this section
12 and shall not exceed one hour equally divided and con-
13 trolled by the chair and ranking minority member of the
14 Committee on the Judiciary. After general debate the bill
15 shall be considered for amendment under the five-minute
16 rule. In lieu of the amendment in the nature of a sub-
17 stitute recommended by the Committee on the Judiciary
18 now printed in the bill, it shall be in order to consider
19 as an original bill for the purpose of amendment under
20 the five-minute rule an amendment in the nature of a sub-
21 stitute consisting of the text of Rules Committee Print
22 115-20. That amendment in the nature of a substitute
23 shall be considered as read. All points of order against
24 that amendment in the nature of a substitute are waived.

1 No amendment to that amendment in the nature of a sub-
2 stitute shall be in order except those printed in part A
3 of the report of the Committee on Rules accompanying
4 this resolution. Each such amendment may be offered only
5 in the order printed in the report, may be offered only
6 by a Member designated in the report, shall be considered
7 as read, shall be debatable for the time specified in the
8 report equally divided and controlled by the proponent and
9 an opponent, shall not be subject to amendment, and shall
10 not be subject to a demand for division of the question
11 in the House or in the Committee of the Whole. All points
12 of order against such amendments are waived. At the con-
13 clusion of consideration of the bill for amendment the
14 Committee shall rise and report the bill to the House with
15 such amendments as may have been adopted. Any Member
16 may demand a separate vote in the House on any amend-
17 ment adopted in the Committee of the Whole to the bill
18 or to the amendment in the nature of a substitute made
19 in order as original text. The previous question shall be
20 considered as ordered on the bill and amendments thereto
21 to final passage without intervening motion except one
22 motion to recommit with or without instructions.

23 SEC. 2. Upon adoption of this resolution it shall be
24 in order to consider in the House the bill (H.R. 1761)
25 to amend title 18, United States Code, to criminalize the

1 knowing consent of the visual depiction, or live trans-
2 mission, of a minor engaged in sexually explicit conduct,
3 and for other purposes. All points of order against consid-
4 eration of the bill are waived. In lieu of the amendment
5 in the nature of a substitute recommended by the Com-
6 mittee on the Judiciary now printed in the bill, an amend-
7 ment in the nature of a substitute consisting of the text
8 of Rules Committee Print 115-19 shall be considered as
9 adopted. The bill, as amended, shall be considered as read.
10 All points of order against provisions in the bill, as amend-
11 ed, are waived. The previous question shall be considered
12 as ordered on the bill, as amended, and on any further
13 amendment thereto, to final passage without intervening
14 motion except: (1) one hour of debate equally divided and
15 controlled by the chair and ranking minority member of
16 the Committee on the Judiciary; (2) the further amend-
17 ment printed in part B of the report of the Committee
18 on Rules accompanying this resolution, if offered by the
19 Member designated in the report, which shall be in order
20 without intervention of any point of order, shall be consid-
21 ered as read, shall be separately debatable for the time
22 specified in the report equally divided and controlled by
23 the proponent and an opponent, and shall not be subject
24 to a demand for a division of the question; and (3) one
25 motion to recommit with or without instructions.

1 SEC. 3. On any legislative day during the period from
2 May 26, 2017, through June 5, 2017—

3 (a) the Journal of the proceedings of the previous day
4 shall be considered as approved; and

5 (b) the Chair may at any time declare the House ad-
6 journed to meet at a date and time, within the limits of
7 clause 4, section 5, article I of the Constitution, to be an-
8 nounced by the Chair in declaring the adjournment.

9 SEC. 4. The Speaker may appoint Members to per-
10 form the duties of the Chair for the duration of the period
11 addressed by section 3 of this resolution as though under
12 clause 8(a) of rule I.
