RESOLUTION

Providing for consideration of the bill (H.R. 2372) to amend the Internal Revenue Code of 1986 to clarify the rules relating to veteran health insurance and eligibility for the premium tax credit, and providing for consideration of the bill (H.R. 2579) to amend the Internal Revenue Code of 1986 to allow the premium tax credit with respect to unsubsidized COBRA continuation coverage.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.

1 2372) to amend the Internal Revenue Code of 1986 to
2 clarify the rules relating to veteran health insurance and
3 eligibility for the premium tax credit. All points of order
4 against consideration of the bill are waived. The amend-
5 ment in the nature of a substitute recommended by the
6 Committee on Ways and Means now printed in the bill
7 shall be considered as adopted. The bill, as amended, shall
8 be considered as read. All points of order against provi-
9 sions in the bill, as amended, are waived. The previous
10 question shall be considered as ordered on the bill, as
11 amended, and on any further amendment thereto, to final
12 passage without intervening motion except: (1) one hour
13 of debate equally divided and controlled by the chair and
14 ranking minority member of the Committee on Ways and
15 Means; and (2) one motion to recommit with or without
16 instructions.

17 SEC. 2. Upon adoption of this resolution it shall be
18 in order to consider in the House the bill (H.R. 2579)
19 to amend the Internal Revenue Code of 1986 to allow the
20 premium tax credit with respect to unsubsidized COBRA
21 continuation coverage. All points of order against consid-
22 eration of the bill are waived. The amendment in the na-
23 ture of a substitute recommended by the Committee on
24 Ways and Means now printed in the bill shall be consid-
25 ered as adopted. The bill, as amended, shall be considered

1 as read. All points of order against provisions in the bill,
2 as amended, are waived. The previous question shall be
3 considered as ordered on the bill, as amended, and on any
4 further amendment thereto, to final passage without inter-
5 vening motion except: (1) one hour of debate equally di-
6 vided and controlled by the chair and ranking minority
7 member of the Committee on Ways and Means; and (2)
8 one motion to recommit with or without instructions.
