Mr. SESSIONS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 3004) to amend section 276 of the Immigration and Nationality Act relating to reentry of removed aliens, and providing for proceedings during the period from July 3, 2017, through July 10, 2017.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 3004) to amend section 276 of the Immigration and Na-
4 tionality Act relating to reentry of removed aliens. All
5 points of order against consideration of the bill are waived.

1 The bill shall be considered as read. All points of order
2 against provisions in the bill are waived. The previous
3 question shall be considered as ordered on the bill and on
4 any amendment thereto to final passage without inter-
5 vening motion except: (1) one hour of debate equally di-
6 vided and controlled by the chair and ranking minority
7 member of the Committee on the Judiciary; and (2) one
8 motion to recommit.

9 SEC. 2. On any legislative day during the period from
10 July 3, 2017, through July 10, 2017—

11 (a) the Journal of the proceedings of the previous day
12 shall be considered as approved; and

13 (b) the Chair may at any time declare the House ad-
14 journed to meet at a date and time, within the limits of
15 clause 4, section 5, article I of the Constitution, to be an-
16 nounced by the Chair in declaring the adjournment.

17 SEC. 3. The Speaker may appoint Members to per-
18 form the duties of the Chair for the duration of the period
19 addressed by section 2 of this resolution as though under
20 clause 8(a) of rule I.

21 SEC. 4. It shall be in order without intervention of
22 any point of order to consider concurrent resolutions pro-
23 viding for adjournment during the month of July, 2017.

24 SEC. 5. The Committee on Appropriations may, at
25 any time before 5 p.m. on Thursday, July 6, 2017, file

1 privileged reports to accompany measures making appro-
2 priations for the fiscal year ending September 30, 2018.

3 SEC. 6. The Committee on Armed Services may, at
4 any time before 5 p.m. on Thursday, July 6, 2017, file
5 a report to accompany H.R. 2810.
