## RESOLUTION

Providing for further consideration of the bill (H.R. 3354) making appropriations for the Department of the Interior, environment, and related agencies for the fiscal year ending September 30, 2018, and for other purposes.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for further  
5 consideration of the bill (H.R. 3354) making appropria-

1 tions for the Department of the Interior, environment, and  
2 related agencies for the fiscal year ending September 30,  
3 2018, and for other purposes.

4 SEC. 2. (a) No further amendment to the bill, as  
5 amended, shall be in order except those printed in the re-  
6 port of the Committee on Rules accompanying this resolu-  
7 tion, amendments en bloc described in section 3 of this  
8 resolution, and available pro forma amendments described  
9 in section 4 of House Resolution 500.

10 (b) Each further amendment printed in the report of  
11 the Committee on Rules shall be considered only in the  
12 order printed in the report, may be offered only by a Mem-  
13 ber designated in the report, shall be considered as read,  
14 shall be debatable for the time specified in the report  
15 equally divided and controlled by the proponent and an  
16 opponent, may be withdrawn by the proponent at any time  
17 before action thereon, shall not be subject to amendment  
18 except amendments described in section 4 of House Reso-  
19 lution 500, and shall not be subject to a demand for divi-  
20 sion of the question in the House or in the Committee  
21 of the Whole.

22 (c) All points of order against further amendments  
23 printed in the report of the Committee on Rules or against  
24 amendments en bloc described in section 3 of this resolu-  
25 tion are waived.

1       SEC. 3. It shall be in order at any time for the chair  
2 of the Committee on Appropriations or his designee to  
3 offer amendments en bloc consisting of further amend-  
4 ments printed in the report of the Committee on Rules  
5 accompanying this resolution not earlier disposed of.  
6 Amendments en bloc offered pursuant to this section shall  
7 be considered as read, shall be debatable for 20 minutes  
8 equally divided and controlled by the chair and ranking  
9 minority member of the Committee on Appropriations or  
10 their respective designees, shall not be subject to amend-  
11 ment except amendments described in section 4 of House  
12 Resolution 500, and shall not be subject to a demand for  
13 division of the question in the House or in the Committee  
14 of the Whole.

15       SEC. 4. At the conclusion of consideration of the bill  
16 for amendment the Committee shall rise and report the  
17 bill, as amended, to the House with such further amend-  
18 ments as may have been adopted. The previous question  
19 shall be considered as ordered on the bill and amendments  
20 thereto to final passage without intervening motion except  
21 one motion to recommit with or without instructions.
