RESOLUTION

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 2874) to achieve reforms to improve the financial stability
4 of the National Flood Insurance Program, to enhance the
5 development of more accurate estimates of flood risk
6 through new technology and better maps, to increase the
7 role of private markets in the management of flood insur-
8 ance risks, and to provide for alternative methods to in-
9 sure against flood peril, and for other purposes. All points
10 of order against consideration of the bill are waived. In
11 lieu of the amendment in the nature of a substitute rec-
12 ommended by the Committee on Financial Services now
13 printed in the bill, the amendment printed in part A of
14 the report of the Committee on Rules accompanying this
15 resolution, modified by the amendment printed in part B
16 of that report, shall be considered as adopted. The bill,
17 as amended, shall be considered as read. All points of
18 order against provisions in the bill, as amended, are
19 waived. The previous question shall be considered as or-
20 dered on the bill, as amended, and on any further amend-

1 ment thereto, to final passage without intervening motion
2 except: (1) one hour of debate equally divided and con-
3 trolled by the chair and ranking minority member of the
4 Committee on Financial Services; and (2) one motion to
5 recommit with or without instructions.

6 SEC. 2. Upon adoption of this resolution it shall be
7 in order to consider the conference report to accompany
8 the bill (H.R. 2810) to authorize appropriations for fiscal
9 year 2018 for military activities of the Department of De-
10 fense, for military construction, and for defense activities
11 of the Department of Energy, to prescribe military per-
12 sonnel strengths for such fiscal year, and for other pur-
13 poses. All points of order against the conference report
14 and against its consideration are waived. The conference
15 report shall be considered as read. The previous question
16 shall be considered as ordered on the conference report
17 to its adoption without intervening motion except: (1) one
18 hour of debate; and (2) one motion to recommit if applica-
19 ble.

20 SEC. 3. The Clerk shall not transmit to the Senate
21 a message that the House has adopted the conference re-
22 port to accompany H.R. 2810 until notified by the Speak-
23 er or by message from the Senate that the Senate has
24 passed H.R. 4374 without amendment.
